JOHN LIPSCOME, son of Moses Lipscomb was born possibly ca.

1756 in either King William Co. or in Hanover Co., most probably, since his father was of record there as early as 1750. Very little is known of his life, and he seems to have died at an early age, leaving only two children and no wife mentioned in his will.

It is assumed that he was the John Lipscomb who married, 27 Sept.1773, Charlette Co., Va., Margaret Almond, daughter of John Almond, with John Almond and John May as Bondsmen. ("Charlotte Co. Marriage records"p.52). This assumption is because he named his only son, Moses Almond Lipscomb (apparently for his two grandparents). (Charlotte Co. was some distance away!)

John Lipscomb, of Hanover, is credited with Public Service, during the Revolutionary War - Hanover Court Booklet I 3; Certificates 2; List II 2,6; Commissioner's Book III 187. (19 Sept.1783, for beef 56-17-6) (VSA)

One record - in the Brock Collection-- the Notice of Sale of his land after his death, by Ambrose Lipscombe, his Executor, indicated that his land in Hanover Co. had been 354 acres on the Main Road from Hanover Court House to Richmond, - 12 miles from the latter 9 from the former.

At the time of his death, he and his family were living in Richmond. His wife had evidently died. His will, dated 31 Mar.1784. "being sick and weak in body but of sound mind & memory" asked that his land be sold and the balance, after payment of debts, etc. be divided between his two children, Moses Almond Lipscomb and Elizabeth Lipscomb. He also specified that his negro fellow, Jupiter, be hired or sold for the benefit of his two heirs.

He named his brother, Ambrose Lipscomb, as sole Executor, and Ambrose also became guardian to the two children who were underage. The will was probated in Hanover Court, 8 May 1784. (Brock Collection)

The children, then, of John and Margaret (Almond) Lipscomb were, --

- 97 MOSES ALMOND LIPSCOMB, born ca. 1774/5 to even 1780 (?) (See next)
- 98 ELIZABETH LIPSCOMB, born ca.1775/6; died before 1809 See p. 132)

It is interesting to note that actually the only portion of the family that used the "E" at the end of LIPSCOMB was the Capt. Ambrose Lipscombe branch, - Was, perhaps, Elizabeth Claiborne, his wife, carrying on the tradition because of the "e" at the end of her name?

ELIZABETH LIPSCOMB, daughter of John and Margaret (Almond) Lipscomb was born by 1776, since she was identified as being over 21 in the Henrico County Marriage record, p. 21, -- 3 Oct. 1798, when she was married to Aubin de la Forrest. Her brother, Moses, made oath that she was over 21.

Elizabeth apparently died before 1809, when, on 8 March, that year, Aubin de la Forrest married (2) her cousin, Jane Cole Lipscomb (see p. 130)

It is said that he, after the death of his second wife, returned to France, taking his two sons. It is not known which wife was the mother of the boys.

91 SARAH LIPSCOMB, Daughter of Moses Lipscomb (p. 123)

91 SARAH LIPSCOMB, daughter of Moses Lipscomb would have been born ca. 1755-60,- in Hanover County.

Nothing further is known of her, except that she married 4 Jan. 1781, Henry Fear of Hanover Co. ("Some Marriages in Burned Record Counties" Va. Gen. Soc. Special Publ. #4 p37)

Her husband could well have been the Henry Fair who witnessed John Lipscomb's (her brother's) will in Richmond, 31 Mar. 1784.

MANOAH LIPSCOMB (Surely not son of Moses Lipscomb, as has been thought, - See p.

MANOAH (or, sometimes MENOAH) LIPSCOMB has been considered by most to have been a son of Moses Lipscomb. However, we cannot keep from considering the fact that he just could have been the son of Henry Lipscomb, Manuel. a legatee in his will, inheriting 143 acres in Hanover Co. (7W(2)278-9)(1927) This needs further study (see p. 133)

He would have been born around 1745. He shows first in Hanover records in 1771 in St. Paul's Vestry Book, (p 480) and again in 1779 (p549).

But, as stated above, it appears more logical to include him as the son of Henry Lipscomb (of the incomplete will of ca. 1772, King William Co.), so, we will not number him here. (Please turn to p. 135.)

HENRY LIPSCOMB, (whom we shall call "Henry-Incomplete Will") is the subject of a genealogy query in William & Mary Quarterly, Series 2, Vol. 7, p. 278-9 (1927). We are indeed grateful to the querist, Mrs. John P. Nesbitt, Chapel Hill, N.C. who quoted the existing first portion of his will, asking if anyone had the completing portion, showing date of will, or any other data pertaining to his family. Response from her family to a letter written to her at a much later date, said that she had died, and that they did not have any knowledge of the matter.

So, Henry's identity is, as with the others, merely conjecture. Let us consider that he may have been a son of Ambrose Lipscomb III, based on the mere fact that he surely had some close connection with George Major Lipscomb. They both had a number of Millicent (used interchangeably with "Mildred") daughters in both of their branches, and not found in any others. Notice the frequency in their lines.

Henry could have been born ca. 1715-20, in King William Co., Va.. And, of course, he could have been, instead, a son of any of the other brothers of Ambrose III- (except Benjamin) -- Richard, John or William. Or, he could have been, even, in the line of William Lipscomb, brother of Ambrose II. Do bear in mind that these placements have been based on very slim clues sometimes.

So far, no other record of Henry has come to light, except his will, written in St. John's Parish, county of King William, "sick and weak, but sound and perfect mind and memory". He lists legacies as follows --

- To son, ROGER LIPSCOMB, feather bed & furniture, pigs, horse & saddle, cattle and two ewes.
- To son, MANUEL LIPSCOMB, 143 acres containing the plantation where he
 now lives (part of larger tract of 293 acres bought from John Norvel,
 situated in Hanover County), two slaves; feather bed & furniture; pigs;
 horse & saddle; and cattle.

3. To my daughter, MILLICENT CHEATHAM, two slaves; bed & furniture and

kitchen ware.

4. To daughter, LEAH LIPSCOMB, two slaves; feather bed and furniture

To daughter, LEVENA LIPSCOMB, two slaves; one bed & furniture; cattle.
 To son, JAMES LIPSCOMB, 150 acres, the remainder of the Hanover tract; two slaves, one feather bed and furniture.

7. To daughter, ANNA LIPSCOMB, two slaves; one feather bed and furniture.

8. To son, MORNING, three slaves; one feather bed and -----

and, there ended the existing portion of the will, leaving us to wonder if there were any other children, or to try to estimate a date.

In the first place, his wife is not mentioned in the will- always the first item in a will, -- so she must have died. And, it cannot help but be wondered if her name might have been Millicent!

One clue might help to set the date of the writing of the will-as before 1772. Henry did name his oldest (?) daughter Millicent by her married name, Cheatham. Her marriage date cannot be found, but she did marry (2) Branch Tucker in 1784. However, Henry named his daughter Leah by her maiden name. Leah married "Ca.1772" Thomas Fox (217277), so it is surely safe to assume that the will was written before that date. Death date, of course, still unknown.

Any land in King William Co. remains a mystery.

ROGER LIPSCOMB, son of Henry Lipscomb, (1st named son in his will). would have been born probably ca. 1735-45.

Nothing is known with certainty, about Roger. There were apparently no other contemporary Roger Lipscombs, so, it can well be assumed that he was the Roger Lipscomb who witnessed a deed, 16 Mar. 1761, Spotsylvania Co. (B.E) Jos. Brock and Mary Beverly, his wife, to Thos. White. (Crozier, p. 220)

Roger died before 1780, perhaps even before 1779, since an Eliz'a Lipscomb turned in her money during May 1779, #2925, \$390.00. Her given name is established by the listing on the King William County Specific Tax, 1780,--

In 1782 and 1783, she paid tax on 600 acres land 7/4, and the 1783 Personal Property tax listed her slaves - "Amica, Jane, Jude, Thompson, & again Amica!"

In 1785 and 1787, John Lambeth paid the tax on the 600 acres, listed on the Alterations as "rent". Then the "Alterations made in the Land Tax for King William County for the year 1791" shows--

"Anderson Lipscomb 600 acres 7/4 Roger Lipscomb's Est."

There are seemingly no other clues. Had Roger received this 600 acres from his father during his lifetime, hence the mere feather bed and cattle legacy? Could it possibly have been the bulk of land owned by Ambrose Lipscomb II-his 470 acres plus the 200 acres from Ambrose I (see p.13)? His brothers, "Manuel" and James had received lands in Hanover County, and brother, Mourning bought 398; acres, (1788 Alterations), from Thos. Littlepage Est.

There is no clue as to possible children for Roger and Elizabeth(____)Lips-comb. That is possibly the reason that the land was sold to Anderson Lips-comb, who is very evidently (from further records) the son of Daniel and Keziah Lipscomb (p. 419, a second cousin, once removed.

MANOAH LIPSCOMB of Hanover County records has been accepted by 100 some as the son of Moses Lipscomb, perhaps logically because they were in the same County, at the same time, and Manoah being younger than Moses. Handver County records were destroyed by fire, and few accounts remain. Wm. R. Cocke III published "St. Paul's Parish Records 1782-1815" (1956). Eugenia Goss Glazebrook published "Virginia Migrations" inlouding Hanover Wills, Deeds. etc., Vols. I & II, 1723-1871. Personal Property Tax records are available on microfilm, beginning 1782, at VSA.

Since there is no proof of any connection with the Moses Lipscomb family. and since there was a record that MANUEL Lipscomb received in his father's (Henry Linscomb) will of ca. 1772, 143 acres "containing the plantation where he now lives (part of a larger tract of 293 acres bought from John Norvel, situated in Hanover County", and since no other Manuel Lipscomb records have come to light, ---- isn't it logical to deduce that MANOAH Lipscomb of Hanover County could well be the "Manuel" Lipscomb - perhaps even misspelled or miscopied in that incomplete will of Henry Lipscomb of King William County. (See p. 133, and see p. 131)

He could have been born ca. 1745, in King William County, son of Henry Linscomb (wife's name unknown). He could have been living on this 143 acres in Hanover Co. where he was tithe listed 1771 through 1779. Then, he was listed on Hanover Co. Personal Property Tax lists 1782 through 1803 when it stops. (Cocke) This would surely indicate the year of his probable death.

By 1805, through 1815, an Elizabeth Lipscomb, widow is taxed for Personal Property, -- no other conclusion than that she was widow of Manoah. 1816 and 1817 show an Elizabeth Sr. and an Elizabeth Jr., then after that through 1824, an Elizabeth with no designation. So, there must have been a daughter, Elizabeth. The 1810 Hanover Census shows, --

Elizabeth Lipscomb: males 1 16-26; 1 over 45 (a parent?) 7 slaves females 1 16-26; 1 26-45; 1 over 45.

The 1820 Census shows, - Hanover Co., --

8 slaves Elizabeth Lipscomb: males 1 16-26 females 1 26-45; 1 over 45

So, if Elizabeth was the widow of Manoah, they had apparently had a son and two daughters. An unaccounted-for Henry Lipscomb appears on the brief Hanover Co. records, on 1810 Census, on Personal Property tax lists 1799 through 1828, and on 1820 Census. So, since he was on 1810 Census, that would mean that he would have been an older son, making two sons.

Then, there is an unaccounted-for Mildred Linscomb on Personal Property tax (yes, another Mildred! Milly)-1815 through 1824. She apparently married 1825. So, could we postulate that Manoah and Elizabeth had had at least three children .--

HENRY LIPSCOME, surmised son of Manoah and Elizabeth Lipscomb of Hanover Co. would have been born, according to Census records, between 1775 and 1784, no doubt in Hanover Co. His Personal Property Tax began in 1799 and continued until 1828- the actual date-- May 2, when it was marked "Est." So, he had died probably 1827 or early 1828.

No name for a wife has been found, but since it does seem logical that one son's name was Nicholas Talley Lipscomb, b. 1801, it is fair to try to find his wife among the Hanover Talley family. A Nicholas Talley left a will 30 Mar. 1787, Hanover Co., in which he named sons and two daughters, Judith and Alice. (23W(1)27).

No apparent widow's name shows in Hanover Co. Census index for 1830, so perhaps his wife had died -- or even remarried by 1830.

And, Nicholas T. lipscomb, who was apparently his son, is the only Lipscomb showing in Hanover Co. in the 1830 and 40 Census Index. The other children-?

So, the only child we can list for Henry, (tho' he apparently had more). is-

MILLICENT LIPSCOME, first daughter mentioned in Henry Lipscomb's will of around 1772, would have been born probably ca. 1750. Here she was, -- another Millicent contemporary with the Millicent (Mildred), daughter of George Major Lipscomb, possibly a brother of her father, Henry. (See p.113)

She is listed in her father's will as Cheatham, so she had married before ca. 1772. The given name of her husband is not known as yet. He died before fore 1784 when Millicent married (2) Branch Tucker of Chesterfield Co., Va.

Other statistics have not been searched.

102 LEAH LIPSCOMB. Daughter of Henry Lipscomb (p.133)

LEAH LIPSCOMB, next named daughter in Henry Lipscomb's will may have been born ca. 1752.

She married, ca. 1772, Thomas Fox (b. ca. 1750), son of Joseph Fox, (of Rosegarden", a famous landmark in King William County, just east of the early Lipscomb lands) and his first wife, Mildred Fenton (Woods Herndon-Hunt and allied Families"). (This a little late to have been source of name "Mildred")

Thomas Fox and his wife, Leah, lived at "The College" which he bought in 1793, - 496 acres, from John Stubbs, -- part of the College Lands".

Joseph's will was probated, King William County 23 Dec. 1805. "Some Fox Trails" - E.M. Cocke (1939) lists their children -- as in the will, --

She married (1) Joseph Fox, Jr. (b. ca. 1748, died 1781), son of Joseph and Mildred (Fenton) Fox, and brother of her sister, Leah's, husband, Thomas Fox. ("Some Fox Trails" p.39).

After Joseph Fox died, she married, ca. 1785 (2) John Garrett. This is confirmed by the fact that 11 Apr.1796 (K. Wm.B.III p 193), John Garrett and Levena, his wife deeded, for L20, to Joseph S. Fox (her son), of King and Queen County, land on Herring Creek adjoining Wm. Burrass and Jane Garrett, which Levena had from the Estate of her late husband, Joseph Fox, Jr. (also 217273)

Further records of Levena Lipscomb have not been found. But one son was ,-- by her first husband, --

119 JOSEPH STEVEN FOX, born ca. 1775, St. David's Parish, King William County.

104 JAMES (T-?) LIPSCOMB, Son of Henry Lipscomb (p. 133)

JAMES (T-?) LIPSCOMB, son of Henry Lipscomb, may have been born ca. 1748-50, King William County. In his father's will, he inherited 150 agres of land in Hanover Co., land his father had bought from John Norvel. No further transaction involving this particular 150 agres has been found.

Perhaps, somehow, earlier records of the purchase from John Norvel may be found to help identify that location of the 293 acre purchase by Henry Lipscomb - probably sometime prior to around 1770. Could the 150 acres inherited by James from Henry Lipscomb have had any connection with the 150 acres sold by John King and Marima, his wife, to James Lipscomb of King William Co., for 490, in 1769, in Hanover and Goochland Counties, adjoining Major Powers and Henry Atkins (Goochland Co. D.B.9 p.191)? And, which, 17 Aug.1772, (Ibid. D.B.10 p.252) James Lipscomb and wife, Jane, of St.John's Parish, King William Co. sold to Richard Johnson, of Goochland Co., for 4100.

In addition to this above question, there are other problems involving the at-least-two James Lipscombs who were somewhat contemporary in King William County. These problems were discussed on p. 33, in the segment of James (C) Lipscomb, so please refer to these.

Aside from these problems, it is evident that surely James (Taylor) Lipscomb was the one taxed for the King William Specific Tax, 4 Apr. 1780, 496 lbs. To-bacco.

And, he was on King William Co. land and personal property tax lists beginning 1782 as James (T) Lipscomb, to differentiate him from the James (C, for College) Lipscomb.

So, now, the problem is -- was James (T) Lipscomb, of King William Co., the

James (T) Lipscomb shows on Land Tax records, King William County, 1782-3, and 5 with 196 acres, 6/5. 1787 Land Tax Alterations shows that James Lipscomb (does not indicate "T", but it is evident by the subsequent lists) acquired "of George Peay by survey 273 acres". This makes the total 469 acres on his 1787 Land Tax listing, 8/0, which was not marked "Est.".

The 1784,-6,-8,-9, 1790,-1 and-2 King William Land Tax records are missing. The 1793 Land Tax record shows James Lipscomb "Est." 367 acres 7/9, so, James (Taylor) Lipscomb had died between 1787 and 1793. This "Est." record remained on Land Tax listings at 7/11, through 1800. Then, --

no further references, except that Henry continued to pay Personal Property tax, only, for many years, at least through 1811.

Analyzing these records, it would seem that probably James' son, Roger had come of age by 1801, but he disappears from records, -- did he die? Then, by 1802, Henry had come of age, and by 1803, acting as guardian for his sister, Frances, paid tax on her portion of 154 acres. Then, she disappears -- perhaps, she married.

One document (K.Wm.B.3 p.190) 23 Oct. 1795, has some connection with the Peay land, perhaps the Alterations of 1787, though not the same acreage. It is a deed from George Peay and Ann, his wife, of King William Co., St. David's Parish (where they had moved) to Henry and Roger Lipscomb and Frances Lipscomb orphans of James Lipscomb of St. John's Parish for 1342 paid by them, for 171 acres on Ruffins Ferry, .. to Holt Richeson's corner near Cohoak Mill Pond.... to Drury Ragsdale's land.... Recorded 30 ______ 1796. Was this part of the 273 acres "by survey", or an additional acreage adjoining? The location of at least part of their lands, then, were down near the mouth of Cohoke Swamp, and not near the early land grants of the Lipscombs.

By 1802, Henry disposed of his portion of the inheritance, --

(K. Wm. B.4 p 184) 10 Dec. 1802-- "Henry Lipscomb one of the distributees to Thos. King ... Henry hath a right to one moiety or half of lands of s. James Lipscomb, dec'd bounded on both sides of Cohoke, part of which was purchased by James Lipscomb from one John Ellis and conveyed to him by deed dated 20 (?) Feby.1783..... \$1200 paid by King .. all lands adjacent Cohoke Mill. either side of said Mill Pond." (no acreage named) Recorded 27 June 1803. (The Ellis deed has not been found)

Thomas King began paying tax on 179 acres, 1803 &-4; 1805 190 acres 7/6. (An earlier 1782,3 &5 Land tax record had shown a Thomas King with 200, then 250 acres which the 1787 Alterations gave over to James Hill.)

A few puzzles remain unsolved, now. What is the significance of the "T" for "Taylor" used by the Clerk in his name? Who was his wife, -- or, who were

his wives, if he had married more than once? Could he have been the James, with wife, Jane, who had bought and sold the 150 acres in Hanover & Gooch-land counties 1769 and 1772? Could he have been the Wames Lipscomb dec'd father of the Sarah Lipscomb, whose marriage bond, to marry William Elliott, was signed 31 Jan.1786 by William Elliott and Ann Lipscomb (does not say "mother") (See p. 33).

There seems to be no extant will for James (T.) Lipscomb, nor any record of a widow, so all we have, in the way of names of his children is from the above records, ---

- 120 ROGER LIPSCOMB, born ca.1780 (?); did he die 1801/2? (See next)
- 121 HENRY LIPSCOMB, born ca. 1781 (?) (Following)
- 122 FRANCES LIPSCOMB, (Following)

120 ROGER LIPSCOMB, Son of James (T.) Lipscomb (p.138)

ROGER LIPSCOMB, son of James (T) Lipscomb, could have been born ca. 1780, to have been of age, to assume his father's land along with his brother, Henry, in 1801 taxes. No other record of this Roger has been found, so we must just conclude that he may have died 1801/2.

121 HENRY LIPSCOMB, Son of James (T.) Lipscomb (p.138)

HENRY LIPSCOME, son of James (T) Lipscomb, could have been born ca. 1778/9, since he does show in King William County Personal Property tax in 1800, for the first time, (before Roger, his brother) showing 1 titheable, 1 horse & 1 cow.

Excepting for the above Land tax records, he shows only on Personal Property Tax list up through 1811, and later P.P. Tax lists have not been checked.

A few questions remain about him. Could he have been the Henry Lipscomb (no wife listed), one of the grantees in the deed of 27 Mar. 1813, from Ambrose P. Lipscomb and Christiana, his wife, Thomas A. Lipscomb and Levina, his wife, and James W. Lipscomb and Elizabeth, his wife, and Henry Lipscomb to George Slaughter, - the 25 acres called Fox's Mill. (See p. 40)

Could he have been the Henry Lipscomb, 1820 King William Census ac. 26-45 - (b. 1775-1794) with no others (no family). The Henry Lipscomb in 1830 Census -- 1 male 30-40 (no females) does not match timewise, but could have been an error. At least, it would seem that he did not marry, and since no Henry shows on 1840 or 1850 census records, can we assume that he must have died?

122 FRANCES LIPSCOMB, Daughter of James (T.) Lipscomb

FRANCES LIPSCOMB, daughter of James (T) Lipscomb, would have been born probably in the 1780s, and as explained above, may have married ca. 1802.

ANNA LIPSCOMB, a daughter of Henry Lipscomb, would have been born possibly around 1753, in King William County. Aside from the legacy left her by her father in his will, we have no further records.

106 MOURNING LIPSCOMB. Son of Henry Lipscomb (p.133)

MOURNING LIPSCOME (spelled Morning" in the 7W(2)278,279 query of 1927) was the last named child of Henry Lipscomb in the extant portion of Henry Lipscomb's will of probably ca. 1772. Since he was named in the 1812 List of Volunteers in King William County (see-21T125) as being aged 58, we can assume that he was born ca. 1754, in King William County.

The incomplete portion of Henry's will stops even in the middle of the items of legacy, so we are left with the question as to whether or not he received land or any other items,— also whether or not there were even more heirs. Perhaps some of the unidentifiables may belong in this family. Henry does not show in the early portion of his will any son, Ambrose, but he could have had a son so named.

Mourning Lipscomb enlisted 2 Jan.1777 for a three-year period of service in the Revolutionary War. He was a private in the 15th Va. Regt. of foot Soldiers in Capt. James Grey's Company, commanded by Lt. Col. James Innes. The National Archives have several interesting record slips in his Military file. His balance of pay" was collected by Capt. D. (Drury?) Ragsdale, -- L55-11-1, date (?).

He had served 1777-1779, was at Valley Forge, March though April, 1778, and for his three years service, received his Bounty Land Warrant #1465, 1 Aug. 1783 for 100 acres, the amount awarded a private.

He married, probably ca. 1785, Sarah Norrel (Norvel?) apparently daughter of the John Norvel from whom his father had bought his 293 acres in Hanover County. Sarah (Norvel) Lipscomb died sometime after 1806, and Mourning Lipscomb married (2), by 1814, Jane Lipscomb, widow of Daniel Lipscomb, son of George Major Lipscomb (see p. 105)

The 1787 Alterations of Land Tax., King William County, show that Mourning Lipscomb acquired 398 acres, 9/6, from the Thos. Littlepage Estate. In Alterations of 1790, he added 150 acres, 6/11, from Holt Richeson, totalling on 1793 tax, - 548 acres (7/4) with 10 shillings tax! From time to time, on his Personal Property tax, he was assessed on a "Chair" or two, a luxury!

This acreage remained through 1806, when it was reduced to 402 acres by the deed 27 Nov.1806 (K. Wm. B.5 p 68) to William Newman for 146 acres on Long Branch, for \$130.00. Dr. Malcolm H. Harris indicates, p. 652-3 that Mourning's land was part of the earlier West Lands, situated between the two main branches of Bull Swamp, across the Main Road and farther East from the early Lipscomb lands.

A record (K.Wm.B.3 p61) involves a mortgage between Mourning Lipscomb and John Lipscomb in which John was indebted to Mourning, apparently 14 in connection with the administration of Mrs. Frances Quarles Estate, 28 July, 1794.

A deed (K. Wm.B3 p.232) 25 Oct. 1796, from John & Sally K. Lipscomb (their identity has not been established) to Mourning Lipscomb for apparently 3 1/8 acres did not alter the acreage in the tax for Mourning. It was on Long Branch, also.

In 1814, by his marriage to Jane Lipscomb, widow of Daniel, he added 24½ acres to his 402½ acres, - from Daniel's inheritance from his father, George Major Lipscomb. On 25 July 1814, Mourning and Jane, his wife, deeded to his son, Roger N. Lipscomb 125 acres 7/4, 8 miles East, adjoining his own land, leaving 302 acres for Mourning. In 1816 the 24½ acres went to John Mill, leaving 287½ acres, 1817, for Mourning (probably 281½ acres) including 3 3/4 acres from Charles Lipscomb.

A complicated document appears 23 June 1812 (K.Wm.B.6 pl94)- a deed of trust from Mourning Lipscomb to Hardin Littlepage and Bernard Lipscomb, for the tract on which Mourning Lipscomb lived. It was apparently a form of mortgage to secure his payment of \$624.12 on or before 1 Oct.1813, with interest, to George Slaughter, attorney for Hardin Littlepage, son & administrator of Thomas Littlepage from whom he had bought the original 398 acres.

It is apparent that this payment was not met since in 1815 an advertisement appeared, quoted in Ryland's book on King William County records, p. 81 quotes -- "King William County, Va. from Old Newspapers and Files" (1955).

"By virtue of a deed of Trust on 23 June 1812 by Mourning Lipscomb to secure George Slaughter a certain sum of money therein mentioned, will be sold on 6 of Dec. next (1815) 404 acres of land whereon s. Mourning Lipscomb resides in Parish of St. John's, County of King William.

— Hardin Littlepage, Trustee."

Oddly enough, though, this did not seem to affect Mourning Lipscomb's tax status, so the problem may have been resolved in some other way.

1816 was his last tax, so he died ca. 1817. By 1818 and 1819 his children were deeding away their inheritances. Abner Allen, his son-in-law was Administrator and settled the estate in 1819. Jane, the second wife of Mourning, must have died about the same time, perhaps in 1816.

Another Mourning Lipscomb (with Clerk's designation "W") appeared in taxes briefly with 217 acres, 9/2, from 1793 through 1797. Could he have been a son of Charles Lipscomb of nearby lands— who had been taxed — for similar acre ages 1782-1787? And, could Charles have been closely related to Mourning, son of Henry?

We have no copy of a will for Mourning Lipscomb, but from later records, it is apparent that his children were as follows, children of his first wife,-

123 ROGER NORRELL (NORVELL?) LIPSCOMB, born ca. 1786 (See p.143)

ROGER NORVELL (NORRELL(?)) LIPSCOMB, son of Mourning and Sarah (Norvell) Lipscomb, was born ca. 1786. He married Frances, probably the daughter of James C.) Lipscomb (see p. 41)

Roger N. Lipscomb received, by deed from his father, 25 July 1814 (see p. 142) 125 acres. In 1817, he added 72 acres from the estate of his father; then, in 1819 sold 13 acres to his neighbor, Christopher Johnson.

His land holdings remained the same, - 184 acres, 8 miles East of the Court house, adjacent to George Slaughter and Christopher Johnson through 1829.

The 1820 King William County Census shows --

Roger N. Lipscomb males- 1 under 10; 1 10-16; 1 26-45 females- 2 " 10; 1 26-45

Tax records after 1829 have not been checked, but since Roger N. Lipscomb's 1829 tax does not indicate "Est.", and since the 1830 Census does not include his name (nor apparently his wife's name), it may be concluded that he must have died late 1829 or early 1830.

The 1840 King William County Census does include a -- (p.80 line #30)

Frances Lipscomb males- 2 15-20 females- 1 5-10; 2 20-30; 1 40-50

Was this possibly the widow of Roger N. Lipscomb? In the 1818 (27 July) document (see p. 39) Roger and Frances had three children, James, Catherine and Mildred. More were evidently born after that, but we do not know the names. A record in 1820 shows that John Lipscomb, trustee for Frances Lipscomb, wife of Roger N. Lipscomb, dealt with the division of Mourning Lipscomb's estate of the negroes.

The known children, then, of Roger N. and Frances (Lipscomb) Lipscomb were-

- 123-A JAMES LIPSCOMB, born ca.1820 (Could he be the James A. Lipscomb, merchant, ae.29 (b.1821) p.239- K. Wm.1850 Census?)
- 123-B CATHERINE IIPSCOMB, born ca. 1810-20

No further research.

- 123-C MILDRED LIPSCOMB, born ca. 1810-20
 - 124 AGNES LIPSCOME, Daughter of Mourning Lipscomb (p.141)
- AGNES LIPSCOMB, daughter of Mourning and Sarah (Norvell) Lipscomb, was born possibly ca. 1787, and died sometime after 1820.
- She married, ca. 1803 John Willeroy (born ca. 1770; d. after 1820). They had at least one daughter whose line is given in Ida Lee's DAR application-
 - 124-A ISABELLA WILLEROY, born ca. 1804; m. ante 6 Jan. 1820 Thos. Stark (Ca. 1796-1862); died 1851.
 - A-I SALLY STARK, born 1820; m.1843 Henry Crutchfield Johnson died 1849

125 MILDRED LIPSCOMB, Daughter of Mourning Lipscomb (p.141)

MILDRED LIPSCOMB, yes, another one! There was surely a favorite aunt or grandmother somewhere in this branch- to have had so many Mildreds, and usually they interchanged the name with Millicent! and "Milly"!

As daughter of Mourning and Sarah (Norvell) Lipscomb, she was born probably ca. 1790. The date of her marriage to Abner Allen is unknown, and the death dates for both are also unknown, as well as names of any children.

Abner Allen was Administrator of Mourning Lipscomb's estate, which was settled ca. 1819. The 1850 Census lists him in the home of Egbert A. Lipscomb, (son of Levina (Whitworth) Lipscomb-Allen-Lipscomb) and shows his age as 57 (the script is blurred, and could possibly be 67). It shows his occupation as a teacher.

Abner Allen's Census record 1820 King William Co. shows 4 children, -- p 297

Abner Allen males 2 under 10; 1 26-45 females 2 " 10; 1 26-45

In 1830 Census he is shown in Dinwiddie County, at Petersburg, p 379

Abner Allen males 1 10-15; 1 25-20; 1 40-50 :: females 1 10-15; 1 15-20

So, Mildred had died before 1840. And, they had had 2 daughters and 2 sons.

On the 1833 King William Co. Tax records, Abner Allen of Petersburg, is listed for 162 acres adj. Egbert Lipscomb and James W. Lipscomb 5 mi. S.E., and both Abner Allen and Egbert's listings show that their lands were "from Thos.A. Lipscomb Estate by division". Had Abner Allen married Levina. widow of Thos. A. Lipscomb, (parents of Egbert E. Lipscomb)? (See p. 46)

126 CATHERINE LIPSCOMB, Daughter of Mourning Lipscomb (p.141)

CATHERINE LIPSCOMB, daughter of Mourning and Sarah (Norvell) Lipscomb was born probably in the 1790s, King William County. She married before 1819, George B. Fleet, known by the fact that 25 Aug. 1819 (K. Wm. B. 8 p. 89) George Fleet and Catherine, his wife, sold 72 acres, her inheritance from her father, to Thos. W. L. Gregory for \$389.97, to be paid by 1 Mar. 1820, with the stipulation that they were to be permitted to remain on the property.

CONTINUING with the other CHILDREN OF AMBROSE LIPSCOMB II (p. 31)

- 10 WILLIAM LIPSCOMB, and
- 11 JOHN LIPSCOMB
- brose Lipscomb II, was very probably the next born son of Ambrose II and Mary (Gissedge) Lipscomb, born possibly ca. 1707,-at least before the 1714 Land Patent. He was no doubt named for his father's brother, William.
- JOHN LIPSCOME, the fourth named son of Ambrose II and Mary Gissedge) Lipscomb, would have likewise been born before 1714- perhaps ca. 1708, and probably named for his father's brother, John.

The only record found so far which could apply to them (both) is the deed recorded at the November Court. 1722, King William Co. (K.Wm.B.I p.59-61), very much damaged, but showing enough to abstract —

155 acres altogether),... (and later on) mentions Pasture Spring Branch
.. and .. west side of Jack's Creek. Also Robert Prytes Line is mentioned. times for payments were disignated, which would indicate
a sort of Mortgage. Witnesses were Nich Meriwether, Davis Meriwether,
and Jo: Bickley.

The fact that Joseph Bickley was one of the witnesses might seem to confirm the probability that this William and John could have been the sons of Ambrose Lipscomb II and his wife, Mary Gissedge (see p.19. And, it could be that the two young sons #3 and #4 might have looked to the future in expanding westward.

This deed, however, could have involved the William and John, brothers of Ambrose Lipscomb II. There seems no way to determine, as yet.

No further records regarding this acreage have been found. Did it go by default? It was in an area a little west of the earlier Lipscomb lands, and could possibly have been the beginning of the westward spread of the Lipscomb family, some of whom we find in later years west of the Court House, and near the Acquinton Church, somewhat north of the area indicated in this deed.

We have no way, at present, of knowing whether or not these sons, William and John, married and had families. In succeeding generations there were a number of William Lipscombs and John Lipscombs who cannot be precisely identified. These will be taken up in later pages. It is to be hoped that sometime they can be connected, with either these William and John, or the ones who were brothers of their father, Ambrose Lipscomb II.

An unexplainable entry is found on the 1750 list of titheables, "Borough of Norfolk and down the south side of Daniel Tanner's Creek"- on Christopher Perkin's List. --

"Robert Waller, Thos. Willoughby, Abraham Allen and John Lipscomb - 4 tithes." from-p. 193
"Norfolk Co., Va. Titheables, 1730-1750" - 1979, Mrs. W. B. Wingo.
and, on p. 198, another entry for simply

Lipscomb, 1 tithe."

Timewise, these entries, might just possibly refer to our John and William Lipscomb, and account for their later whereabouts, in a way. However, very unfortunately, records from that area are very scarce. Perhaps something may come to light in the future to help untangle this possibility.

MARY LIPSCOMB, Daughter of Ambrose & Mary Gissedge) Lipscomb (p.31)

MARY LIPSCOMB, the only daughter listed in the patent of Ambrose Lipscomb II, would have been born sometime between probably 1700 and 1712, of course, in King William Co. area.

No record of any kind has been found for her.

So, now, let's go on to the last-named child of Ambrose and Mary Lipscomb-Benjamin. See next page.

BENJAMIN LIPSCOMB, the last named child of Ambrose Lipscomb II and his wife Mary Gissedge) Lipscomb, in his Land Patent of 1714, would have been born ca. 1710 possibly. We do not have a name for his wife, - she was apparently deceased before his will which was written 17 July 1778. The will was probated in Amelia Co. (Amelia Co. W.B. 3 p. 211), Va. seemingly ca. 1783. For some reason that date does not show in the books, but the previously probated will and subsequent one, - would indicate sometime in 1783, after Oct. 23.

Aside from this will, the only other records (except for his name in Ambrose Lipscomb's (II) Land Patent), are the tithe lists of Amelia Co., Va. (VSA)

- 1779 Nottoway Parish, Amelia Co. Sherwin's List -Uriah, Benjamin Lipscomb 7 tithes, including the slaves- Hanah,
 Daphne. Cynder, Jane & Leartha (Sp.?)
- 1781 Nottoway Parish, Amelia Co. again Sherwin's List Uriah Lipscomb, Benjamin Lipscomb and 6 other names(of slaves)

The 1782 Personal Property tax list in the Amelia Co. "Executive Papers" at VSA, p. 67 shows -- (not shown on actual 1782 tax lists)

Benjamin, Benjamin Jr., Uriah and Barnabas.

It cannot be calculated when Benjamin came to Amelia County from King William County with any accuracy. No land transactions have been found in the Deed Books. However, as early as 1769 his son, Uriah Lipscomb shows on the tithe list of Chas. Hamlin (Lunbg.Co. tithe lists, VSA), Cumberland Parish, Lunenburg Co. with 8 titheables and 800 acres, (perhaps the acreage he bought from Philomen Crain (Lun. B..11 p. 34). He shows further on 1771 and 1772 tithe lists.

So, perhaps, in the spreading out of Benjamin's children, Uriah had gone to the southern part of Virginia, and his father, Benjamin followed him, if he did not even go with him, by 1769.

We cannot keep from trying to connect, in some way, too, the migration of the Ambrose Lipscomb from King William County to Amelia County when he bought land there in 1760 (see p. 53)

Benjamin's will, dated 17 July 1778 (probated as indicated above ca. 1783) was a little unusual in that it gave to the first six of his legatees one shilling each. Then, the next named daughter received 2 negro girls and some furniture, and Uriah, the youngest, received the entire balance of his estate, showing that probably Uriah had cared for him in his later years. Also, many times parents made gifts to children from time to time, and therefore gave them just token legacies in the will.

It will be seen in the sections covering his sons, that they had scattered in different directions, - Joseph to Louisa Co. by 1765; Barnabas in various places; Thomas to Halifax County, and ,by 1779, son, Richard, had taken a Fairfax Land Lease in Frederick Co., Virginia. Could it be that Benjamin, being the youngest of the children of Ambrose II and Mary (Gissedge) Lipscomb, did not stand to inherit much in the way of land, so they began to leave for other parts?

Benjamin Lipscomb's will was witnessed by Sam Sherwin, Elizabeth Sherwin, Charles Winfree and Sterling T. Wallington. These names could just cossibly give a clue as to some relationship.

127 JOSEPH LIPSCOMB, Son of Benjamin Lipscomb (p.147)

JOSEPH LIPSCOMB, first named son in Benjamin Lipscomb's will, would have been born possibly ca. 1735 (judging from the proposed birth of the youngest son, Uriah, in probably 1746). He was probably born in King William County, before the migration of the various members of the family. His mother's name is not known.

He married Frances Tandy, daughter of William Tandy, sometime before 24 Dec. 1774 - the date given in the Douglas Register which gives that date for the baptism of one of their daughters, Mary.

Joseph had gone to Louisa County by 1765. His first record, there, is a deed (Louisa Co. D.B.C. p. 93) 8 Apr.1765, from William Tandy and Jane (Cuarles?), his wife, of Louisa County, to Joseph Lipscomb of King William County for land on Goldmine Creek... to Col. Syms' corner, formerly Charles Stephain's corner, 250 acres, for L112-10-0.

On Oct. 2, 1766, the next year, he purchased an additional parcel of land from John Syme (possibly the acreage adjacent?) (Louisa County D.B. D p.75)

He was on the 1777 Louisa County tithe list, with 6 titheable.

In 1782, and on through 1796, he paid tax on 440 acres, and from 1797 until his death on 432 acres in Louisa County. By 1810, the land had been divided 146 acres to Frances, 66 acres to daughter, Patsey, and 130 acres to daughter, Ann, 8 miles N.E. of the County Court House, on Goldmine Creek. The additional 70 acres have not been accounted for—perhaps to a son-in-law (?) but Joseph's will had provided for his widow, Frances to have her third, and the balance of his land to be divided equally between Mary, Martha (Patsey) and Ann.

Joseph Lipscomb did not serve in the Revolutionary forces, but did furnish supplies, as listed in Louisa County Court Booklet, p.19; Certificates 2; List I 3,23,33; Commission book III p.357. (DAR acceptance)

The will of William Tandy, dated 1792, recorded 1794, Fayette Co., Ky. listed a daughter. Frances Lipscomb, and also a daughter-in-law, wife of his son, Moses. This "daughter-in-law" was surely the Ann, sister of Joseph (daughter of Benjamin).

Joseph's will, dated 23 Apr.1804 was probated 11 Jan.1808 (Louisa Co. Will B.5 p.280). It was witnessed by W. Harwood, John Fleeman, David Lipscomb, and William Bibb. He named his friend William Thomson and Roger Burres to be Executors.

In his will, Joseph gave to his wife, Frances, one third of his tract of land, including the mansion house, the tract bounded by Simses line, Meriwether's line, Bigger's line, cattail branch, with one third of the slaves, all stock, household furniture, etc., but she was to furnish each child, not already furnished with a bed and furniture when they shall attain the age of 21 or marry. The balance of his tract was to be divided equally between his daughters, Mary, Martha and Ann. His son, Barnabas was to receive nothing until he should give account of Joseph's crops from the year 1797 to the present,—a satisfactory account! Henry Willoby and his wife, Jane (his daughter??) were to receive nothing unless Henry produced the instrument of writing which he had given him"to prevent the sale of the negro woman (Nan) which I let my daughter Lucy Roseberry have". But, if they do comply, they are to be equally entitled to the division of the balance of his estate, together with the other children. Etc. At his wife's death, the estate lent to her, not already disposed of, was to be divided among his children.

Joseph's widow, Frances, left her will, 13 Apr. 1829 (Louisa Co.W.B.8 p. 7) listing her daughter, (Ann) Nancy; son, William T. (Tandy); and her grand-children, Jane and Wm. Tisdale (children of her dau., Frances); Robert Jones, (son of her daughter, Martha); and Parkes Roseberry (son of daughter, Lucy). Children, Wm. T. and Frances, had not been named specifically in their father's will, but may have been very young children, and included in the group of "all my other children".

The Register kept by Rev. Wm. Douglas listed birth and baptismal records, and, in lieu of a marriage record, he listed as a marriage date, the date of birth of the first child for whom he had a record. So, he listed as follows -- for Joseph Lipscomb and Frances Tandie --

BENJAMIN LIPSCOMB, JR., son of Benjamin Lipscomb, would have been born possibly ca. 1737 (?). He left little in the way of records.

He was probably the Benjamin Lipscomb on Revolutionary War records, --

Eckenrode's "Supplement - Revolutionary Soldiers of Virginia" (1913)
p. 187- Benjamin Lipscomb, MLW Bk 1, 615, which probably refers to
his Military Land Warrant, as shown in --

"Catalogue of Rev. Soldiers and Sailors of the Commonwealth of Virginia to whom Bounty Warrants were granted by Virginia for Military Services in the War of Independence compiled by Samuel M. Wilson, Ky. 1953 --

Warrant 2965- Lipscomb, Benjamin 100 acres- private, Va. Cont.Line 3 years, awarded Apr. 19, 1784.

No attempt has been made to ascertain if he claimed this Bounty Land, but, no trace of him has been found in Kentucky, where most of the lands were located, -- and, his warrant is also listed in "Old Kentucky Entries and Deeds" - Willard Rouse Jillson (1926) p. 346, with no location indicated, so, he probably did not take up his claim.

As mentioned above, in Benjamin's section, Benjamin, Jr. was listed on Personal Property tax, in 1782 along with his father and his brothers, Barnabas and Uriah.

No further records of any kind have been found. (Did he die young?) Except for the 24 Sept.1784 record of Marriage bond for Asa Davis to marry Frances Lipscomb (dau. of Uriah), where Benjamin Lipscomb witnessed the consent.

129 THOMAS LIPSCOMB, Son of Benjamin Lipscomb (p. 147)

THOMAS LIPSCOMB, third named son of Benjamin Lipscomb, would have been born probably ca. 1739 (?). The many Thomas Lipscombs have posed quite a problem, but, it has been possible to untangle them, and to conclude that Banjamin's son, Thomas, was the one who went to Halifax County. He must have been born in King William County before his father went to Amelia County.

He seems to have gone to Amelia County, even possibly before his brother, U-rish, and his father, since in Amelia County Deeds (B.9 p.82) we find a deed dated 25 Oct.1766, from Daniel Coleman Sr. and his wife, Elizabeth, of Amelia County to Thomas Lipscomb of same County, for 200 acres, at the mouth of Porringer's Branch, for £150.

- 20 March 1773, Charlotte County Marriage records show that Thomas Lipscomb married (1) Mary Barksdale (dau. of Collier Barksdale).
- 16 Dec. 1778, Halifax County (D.B. 11p. 202) Thomas Lipscomb witnessed a deed of John Scott.
- 18 March 1779, Thomas Lipscomb married (2) Gilley Whitlock, Halifax County. so, apparently his first wife, Mary Barksdale, had died.
- 1782 Personal Property Tax 4 white, 7 black; Land Tax. 550 acres, Hal.Co. 1782 Rev.War-Pub. Serv. Hal. Co.; Ct. Bklet p. 17-18; Comm. Bk. II p 280-1

1784 Halifax Tax Alterations show "To Thomas Lipscomb from Whitlock's Executor 550 acres" (on which he had already been paying the tax. (his father-in -law, had died?), also, 200 acres, from Whitlock's Executor.

16 June 1786. Thomas Lipscomb and wife sold to Daniel Malone 300 acres, leaving the 450 acres on his 1787 Halifax Tax. (the 300 acres, on Lawson Cr.)

1794, 1796 and 1797, Thomas Lipscomb was a Vestryman, Antrim Parish Church, Halifax County (Antrim Parish Vestry Book, 1752-1817, photostat, VSA)

3 Oct. 1799. Thomas Lipscomb married Elizabeth Turner, Caswell County, N. Carolina. So, Thomas' second wife, Gilley Whitlock, had died. (See p. 490)

1801, his Halifax County Tax was listed as 550 acres, in the Southern District of the County. So, it is possible to locate his land approximately since Lawson's Creek runs Northeast, joining Dan River just s.w. of South Boston, the County seat.

2 July 1804, Thomas Lipscomb signed his will, which was recorded 25 Feb.1805 (Halfax Co. W.B.7 p.58). Witnessed by Stephen Townes, Anthony Powell and Robert Talman, making James A and/or his son, Clement, Executor. He gaveto his wife, Elizabeth, 3 negroes, 1/3 of stock, mill and his home tract. to Thomas, William and John, children of his deceased son, John, 4 ne-

groes and land- of the land where John had lived.

to Dicey Lipscomb, widow of son, John, the use of the land for her children to son, Clement, the other half of land where John had lived, and negroes.

to daughter. Polly Carnall, two negroes and a mare.

to son, William, a tract of land adjoining Frances Brandon, and at Thomas' wife's death, the home plantation, 4 negroes, a mare & furniture. further to son, Clement, at wife's death, his mill and utensils. Balance to be sold and divided according to instructions.

This material is being compiled from a recently published book - "The Lipscombs of East Feliciana (La.) - A Virginia Heritage", 1977, by Richard Rowley Lipscomb, 10636 Lynell Dr., Baton Rouge, La. 70815. It is a book of over 325 pages about the closely knit families descending from the three sons of John Lipscomb and his wife, Dicey Scott Lipscomb who were married in Halifax Co. Va. (Abstracted from the Book by the compiler)

The book goes into great detail, but since it is available, this chapter will be severely condensed, bringing most of the lines down only into the mid or late 1800s, and carrying down mainly the male LIPSCOMB lines.

Three children were born to the couple, Thos. Jefferson, Wm., and John, and sometime shortly after the birth of the third son, John died as the result of an accidental fall.

In April 1806, Dicey married (2) Daniel Collins and in 1808, they took the 3 boys leaving for Tennessee. In 1810 they moved further S.W.- to Wilkinson Co., Miss. Hence, the family of boys stayed together, and their families grew up and many stayed in that vicinity, especially in Madison Co.- Son, John's in Madison Co., Miss. and the other two in East Feliciana Parish. La..

The three young sons (and the widow, Dicey) had been named in John's father's will of 2 July 1804, Halifax Co., -- (Each of their decendant families will be outlined before proceeding to the next). --

BARNABAS LIPSCOMB, fourth named son in Benjamin Lipscomb's will, would have been born possibly ca. 1740. No other Barnabas Lipscomb shows up in early Lipscomb annals, (except his namesake, Barnabas, son of Joseph, his brother). So, - "Barnabas," too, could have been a name taken from his mother's family (another clue to follow for her identity), or, perhaps a popular Biblical name. His records are difficult to follow.

He must have been born in King William County, but apparently went to the Amelia County area, and remained, in Lunenburg Co. until, later, when he showed up in New Kent County.

1781 A petition from a number of residents of Amelia County, asking for additional arms to replace their own which had been taken from them by marauding British troops, was signed by Uriah, Barnabas, Richard, Luke, and Richard G. Lipscomb.

1782 Executive Papers (VSA) show Benjamin, Benjamin Jr. Uriah and Barnabas on Personal Property list (p.67)

Lunenburg County Deeds include some involving Barnabas Lipscomb --

13 Oct.1796 - to Barnabas Lipscomb from Thos. Williamson (L. D.B.17 p.314)
13 Oct.1796 - " " Jesse D. Green (" p.329)
with dower release 9 July, 1801, from Martha Green (" 18 p.261)

lands which he apparently sold after going to New Kent County --

7 May 1801 - to Josiah Watson, of Prince Edward County, from Barnabas Lipscomb, of New Kent County, 1332 acres, 1082 acres, and 25 acres, for 110. This was apparently re-deeded, 9 July, 1801 (D.B.18 p. 262, after receiving dower release from Martha Green.

(Another puzzling entry in 1850(D.B.35 p.102), in the Index, repeats a "Lipscomb, Barnabas to Josiah Watson".)

By 11 May 1797, he was in New Kent County, where he and his wife, Elizabeth, of New Kent County, deeded 150 acres in King William County, for £150, to William Banks, (son of Tunstall Banks, dec'd), - land formerly purchased by Todd of the aforesaid Lipscomb, and bounded by lands of Powell, and by lands of Mary Banks, widow of aforesaid Tunstall Banks, dec'd. Witnessed by Wm. Parrish, Thos. Ratcliffe, and Mourning Lipscomb. (K.Wm.B.3 p.257)

The adjoining dower release, p. 259, would seem to indicate that the 150 acres were in St. David's Parish (the western portion of King William County) Further research would be interesting to determine how he had acquired that land (Could it have had anything to do with the 155 acres bought 1722 by William and John Lipscomb, perhaps his uncles?) - inherited, or purchased, or even inherited by his wife. He had evidently sold it to ____ Todd, who may have defaulted, earlier, -- no apparent record.

1800 shows Barnabas Lipscomb on a New Kent County Tax record. No record of his marriage to Elizabeth has been found. Also, no record of any children, and no death record. The 1801 deed back in Lunenburg Co. is the last record that has, so far, been found.

RICHARD LIPSCOMB, fifth named son in the will of Benjamin Lipscomb and recipient of one of the six one-shilling legacies, would have been born possibly ca. 1741, in King William County. He was quite probably named for his uncle Richard, eldest brother of his father, Benjamin, - who, in turn was probably named for his mother's father, Richard Gissedge.

He is not to be confused with Richard G. Lipscomb (son of George Major Lipscomb) who came to Nottoway and later Charlotte Co., Va. -- nor, with Richard Lipscomb, the "underage"-in-1779 son of Ambrose and Unity Lipscomb of Amelia County. It seems most conclusive that this Richard Lipscomb was the one who went to Frederick County by 1779.

The "Fairfax Leases "record one obtained and dated 8 May 1779 for 100 acres, "for and during the natural lives of him the said Richard Lipscum Sarah Lipscum and John Lipscum Jun. and the longest lives of them, yielding and paying unto the said Thomas Lord Fairfax his Heirs and Assigns yearly and every year on the first day of May, the rent or sum of forty shillings... in cash or tobacco \$ 10 shillings pr. Hundred. and that he or they plant at least one hundred good apple trees at least 30 ft. distancefrom each other.. keep them pruned and fenced. And also to be built a dwelling house at least 20 feet long and 16 feet wide within three years. Etc."

The insert map inside the back of "The Fairfax Proprietary" — Dickinson, (1959) shows locations of the many, many Leases, and the #294 lease for Richard and his family is just East of Burwell's Island in the Shenandoah River, in what is now Clarke County, very close to and west of the present Va. secondary Road #506, and about five miles east of the town of Millwood. Adjoining it were the #292.-1792 Ambrose. Richard & Lucy Lease; #293,-Wm., Nancy & John. 1792 Lease; #307-1790 Wm. Mardis, James and Wm. Lease; and #308 - 1792 Wm., Nancy and Betsey & Mollie Mardis Lease.

The explanation of the unusual "Three Lives Leases" is given on P. 24 of this same volume. It is to be assumed that, in Richard's lease, Sarah was his wife, and John, his son, indicating that they might retain that lease as long as any of the three were living. No identification for Sarah has been found.

Clarke County was not taken off from Frederick and Warren Counties until 1836, so we look to Frederick County for any records. The "1790 Census of Virginia" (actually compiled from usually 1782 and 1785 Personal Property tax lists, since the original census records were lost) shows Richard with 7 persons, white. In 1785 he listed only himself as over 21, with 2 horses and 3 cattle. He continued on through his last listing in 1791. This may have meant that he had died, or could have just been the result of the entry in the Frederick County Order Book #29 (1780-88) p. 162 (not in Index) 4 July, 1788, --

"Richard Lipscomb a poor man is discharged from paying levies in the future". There is no will on record, so the list of his children have been calculated from Tax records, deeds, Revolutionary War records. Census and otherwise. From these, it might well be assumed that Richard Lipscomb and Sarah had been married by ca. 1759-60, when he would have been maybe still under age 20, and maybe back in King William County. It is not know when they started out for Frederick County, nor when nor where their children were born, since no record has been found before the 1779 Lease on the North side of the Blue Ridge.

The "calculated" list of children of Richard and Sarah (____)Lipscomb of Frederick Co., Va., then, would be, ---

ELIZABETH LIPSCOMB, b. ca. 1757-62 (?) -- (her widow's pension application, on microfilm, Nat'l Archives, Wash. D.C., under her husband's name, William Mardis. #W8410, gives her age as 83, at her death 15 Apr.1840. This, of course, could have been an "approximate age", guessed at by the family, and, also, the approximate birth and marriage dates for her father, Richard, have been purely calculated.); she m. 1 Apr. 1779. (Fred.Co. Rec.) William Mardis (Marders); he died ca. 1802, Campbell Co.,

Ky., and she died 15 Apr. 1840, Kenton Co., Ky.

- of Frederick Co., Va. (his name used on the "three-lives Lease, 1779), was born, possibly back in King William Co., before the young family went to Frederick Co., ca. 1760; he married (____) ca. 1780-2 (?), probably Fred. Co., and took his family to Kentucky; He lived until after 1840, since we do find him listed on the 1840 Census, surely as "male-80-90" in the household of his son, George Lipscomb, in Kenton Co., Ky.
- AMBROSE LIPSCOMB, son of Richard and Sarah (_____) Lipscomb, and bearing the traditional family name of Ambrose, born ca. 1762-4, perhaps back in King William Co.; (See p. 173) served in the Revolutionary War; m. 23 Dec. 1785, King George Co., Va., Winifred (Winnie) Mardis (Marders); died 18 May 1841, Preston Co., (now in West Virginia.)
- WILLIAM LIPSCOMB, son of Richard and Sarah (_____) Lipscomb. of Frederick Co., Va. was born ca. 1765; he married 4 Aug. (See p. 189) 1791 (Fred. Co. Mar. Rec.) Nancy Marcus (Marcuis); he died, 1851, (Will 13 Feb.1851-probated July 1851) Campbell Co., Ky.

ELIZABETH LIPSCOMB's family has been "put together" from material submitted by Jacque Anderson (Mrs. Dan) 4857 S. Herner Rd, Rhodes, Mich. 48652, - from Mrs. James Morris, Route 2, box 868, Front Royal, Va. 22630, and from Frederick County, Va. Court records, etc., by the compiler.

ELIZABETH LIPSCOMB, daughter of Richard and Sarah (____) Lipscomb, was born possibly ca. 1757 (calculated from the age she gave in her widow's Rev. War pension). She was possibly born even back in King William Co., Va. and surely the first-born to her parents who had married early apparently. And, she would have been taken to their new life in the Fairfax Proprietary where Richard, Sarah and son, John. (surely the next born), took their Lease for three lives, in 1779.

Her marriage date, given in her pension application, was 1 Apr. 1779, and since that was the date of the Lease, it probably took place in Frederick Co., Va.. Her husband, William Mardis was, no doubt, a brother of the Winnie Mardis, dau. of James and Ann Mardis, (or at least, in that family) who married Elizabeth's younger brother, Ambrose.

Wm. Mardis and Elizabeth, also, signed for a Fairfax Lease. naming their sons, James Mardis and William Mardis for the other two lives, and adjacent to Richard and Sarah Lipscomb's lease, and later Lipscomb leases. located S.E. of Burwell's Island in the Shenandoah River. (See Dickinson's "The Fairfax Proprietary", with map.)

They seemingly did not keep this land for long, since we find them in Campbell Co., Ky. as early as 1798 on Land tax rolls, with 150 acres. They had most probably gone there along with Elizabeth's brother and his family(John).

William Mardis had served in the Revolutionary War, enlisting as a Private in Capt. Sam'l Hawe's Va. Co. in 1777. His widow's Pension file #W8410.

Land Tax rolls are a splendid source of information. Their 150 acres are shown some years as on Decoursey's Cr. and sometimes on Licking, and since Decoursey's Cr. flows into Licking, it is not hard to determine the location. We can judge that William Mardis died late 1801 or early 1802, since their 150 acres are listed Apr. 20. 1803 under the name of Betsey Mardis, widow, and personal property list shows that she had one son over 16, who would be James. In fact, in 1804, the 150 acres was listed under his name, otherwise, it was under Elizabeth's name through at least 1813.

Elizabeth died (in her Archives Pension record files) 15 Apr. 1840 in Kenton Co., Ky. (from Campbell Co. 1840). This Pension file gives a list of their children, with birth dates on some, ---

JOHN LIPSCOMB, son ofRichard and Sarah () Lipscomb, was born 148 ca. 1760-3, maybe even back in King William Co., Va., before his parents left for the newer county of Frederick in the Shenandoah area. Being their first son, his name was used, along with their own, Richard and Sarah, for their "three-lives" lease in the Fairfax Proprietary, 8 May 1779.

John married, no doubt, in Frederick Co., or thereabout, probably ca. 1782. and one source indicates (without documentation) (Virkus "Compendium" Vol. V. p.323) that his wife was a Havens. No proof has been found, though the records of the Havens family - a fairly large family - in both Frederick Co., Va. and in the area of Kentucky to which they went, have been researched carefully.

There are no records to show that John took out a Fairfax Lease, as did his younger brothers. At least two of their children were born in Virginia in mid and later 1780s, but later Kentucky Census records for their next children. Joel and Richard, indicating that they had been born in Kentucky. would imply that John and his wife had taken their family to Kentucky in the very early part of the1790s. They settled in Campbell Co., in the northern tip of Kentucky (across from Cincinnati, Ohio), where John shows on their Land Tax list of 1800 for 100 acres, and by 1802, for 150 acres on Licking Creek. (Licking Creek became the boundary, later (1840), - when Kenton Co. was taken off of Campbell Co.).

We find, also, Land Tax records, even earlier, in that County, for William Mardis, 150 acres also on Licking Creek, so, it is quite probable that John and his sister, Elizabeth, with her husband, William Mardis, came to Kentucky together. William Mardis and John Lipscomb must have induced John's youngest brother, William Lipscomb, to leave the Monongalia area of (W.) Va., to come, around 1816, to their Campbell Co., Kentucky, also, We find William Lipscomb's name on Campbell Co. lists beginning at that time.

The 1830 Campbell Co., Ky. Census lists John Lipscomb, ac. 60-70, along with only a female, ac. 30-40. The female could have been, just possibly, a younger second wife, since we do find a puzzling marriage record on Campbell County Marriage records, showing that a John Lipscomb gave Bond 28 Dec. 1821 for a marriage to Polly Minter (Winter?), and that George (surely his son) had also been bondsman. They were married 31 Dec. 1821 by Elam Grizzel. Now, since John's son, John, married Lucinda Mardis in 1816 (and they were still living much later). - and William Lipscomb's son, John seems to have stayed in the Monogalia, Va. area (p.191), then, this must have been a second marriage for John Lipscomb, - to a much younger lady. Whether or not they had any children is hard to determine, from the County records.

John Lipscomb assumed civic duties, as did also all of his sons, particularly in the surveying and building of roads in the County, as shown in many County Court Order book records.

A Court Order Book record of 1832 shows, -- "it is ordered that John Lipscomb. an aged and infirm man, be exempt in future from the payment of the County levies." (and possibly just re-married two years before!)

His death date is not known, but surely after 1840, since the 1840 Census for his son, George Lipscomb, includes, in that household, a male, 80-90, who would most assuredly be George's father, John Lipscomb, - a truly rugged individual.

There are numerous LIPSCOMB references in Campbell Co., and later(after 1840) Kenton Co.- in Court records, Census and Tax lists. It has been a monumental task to try to differentiate between the records of the children of John Lipscomb and those of his younger brother, William Lipscomb, who came to the area around ten years later. This is esepcially so, because of the duplication of given names. But, this would seem to be the list of the children of John Lipscomb, son of Richard, —

160 GEORGE LIPSCOMB, son of John Lipscomb, was born possibly ca.1785 perhaps in Frederick Co., Va. He was married 12 Apr. 1810 to Mary Mardis, Campbell Co., Ky. She was daughter of his father's sister, Elizabeth Lipscomb and her husband William Mardis (Marders).

George Lipscomb bought land in three parcels, on Decourcey's Cr., Campbell Co, on the west side of Licking Creek, in the part of the County which became Kenton Co. in 1840, - accumulating, by 1828, around 150 acres.

George Lipscomb's will, recorded Dec. 1873, Kenton Co. W.B.1 p.418 mentions his wife, (not named), Step daughter, Elizabeth Townsend (so, his second wife may have been a widow, Townsend), and his grandchildren, Levi and Mary Jane (who had married a Pickett) whem he had raised, - along with his "other children", not otherwise named. 161 ANDERSON LIPSCOMB, son of John Lipscomb (p. 165)

ANDERSON LIPSCOMB, son of John Lipscomb, was born ca. 1786 in Frederick Co., Va. and was taken by his parents to Kentucky, sometime after 1790. Tradition has it that he was around the age of fourteen, which would make the trek around 1800, but there are earlier records in Kentucky for the family.

No record of Anderson's marriage has been found, but most probably it was in Campbell Co., Ky., and since one son is named Sanford, it could be that she was a Sanford. The 1830 Census, Campbell Co. for him shows,--

He had paid Tax in Campbell Co. from 1811 through at least 1829.

Sometime, by at least 1840, Anderson had taken his family north to Franklin Co., Indiana, where we find his 1850 Census record, very brief, -- p.478, taken 26 Oct. 1850, Salt Creek Twp., at the very N.E. corner of the Twp.

James White is supposedly the son of Anderson's daughter, probably deceased, who had married 21 Mar. 1841, Ind., Jacob White.

In the 1850 Franklin Co., Ind. Census, just above the name of Anderson,

we find his two married sens, Sanford and William, -- ac. 27 and 30, with their families, in adjoining residences.

No identification for his wife has been found, - in fact, it is not known whether or not the Elizabeth, as 40 in 1850 might be a younger second wife, or, even maybe an older daughter, -probably daughter, as named in deed.

No death date for Anderson or fer his wife has been found, nor any record of a will. But, in June 19 1841 (Franklin Ce., D.B.1 p 437-9) Anderson deeded to his son, Sanford, for \$150. a quantity of farm stock, - and, in a separate deed, for \$300. 16 acre pertions, - from the 80 acres he had bought from Ansdenton Pruitt, in 1837, -- to Elizabeth Lipscomb, Sanford Lipscomb, Edith White, (no doubt his children, then) and to Richard Lipscomb and John Lipscomb of Campbell Co., Ky. (these last two, apparently his brothers, back in Ky.). This deed of land parcels gave him life tenancy, and at his death, to go to grantees above.

A series of conflicting deeds follow in the Deed records of Franklin Co. Ind., but one deed, 4 Oct. 1845 (D.B. V, p. 109, indicates that John Lipscomb, and Lucinda, his wife of Kenton Co., Ky. sold a parcel of land in Sect. 10, Twp 11, Range 12, to William Lipscomb of Franklin Co., Ind. for \$36.00, evidently not part of the 1837 land purchase of Anderson Lipscomb's. Anderson Lipscomb's land purchase, 1837, was in Sect. 3, adjoining to No.

Other confusing deeds follow, including names of William and John S., and George W. Lipscomb, - and of Coffee and White. By, 13 Aug. 1868, Sanford Lipscomb deeded a parcel (80 acres ???) to Jarome Wiley, excepting for a portion which had been a graveyard. This graveyard has been checked, and is all overgrown, and no evidence of Lipscomb remains can be found. No evidence of any Lipscombs still in that County, after a John S. (er, G?) sold lands 1869 to 1878.

So, the children's names, of Anderson Lipscomb, must be, -- at least partially-

He was married 20 June, 1811 (Bond, 8 June.) by George Hume, to Sarah Mardis, most probably the daughter of his aunt, Elizabeth Lipscomb and her husband, Wm. Mardis. (See p. 164)

On Apr. 26, 1832, he bought 25 acres on Decoursey's Cr., Campbell Co., and surely had other lands. Decoursey's Cr. runs East into Licking Cr., which became the boundary between Campbell Co, and the new 1840 Kenton Co.

SUSANNA LIPSCOMB, daughter of John, was born ca. 1800. The Campbell Co., Ky. Marriage bonds show, 28 May 1816, that she married Marcus Lipscomb (p.192). (son of Wm. and Nancy Lipscomb), her cousin. She must have died by 1827, since we find a second marriage for Marcus Lipscomb, (Bond, 13 Feb. 1827), - to Isabella Warrington.

Susanna and Marcus must have had three children (if not more), who would be the ones involved in the 1846 deed (p.192) for the 50 acres (Susanna's half of Souire Grant's deed (above)), from Marcus and others named (surely their children) - who had all gone to Missouri by that time.

Did son, Ambrose, perhaps, return to Campbell Co.? Was he the one who married, in 1848), Campbell Co., Ky. -Eliza Jane Standley? (See p. 12)

horn ca. 1762-64, in perhaps King William Co., Va., before his parents left for Frederick Co.. He served in the Revolutionary War, for four months, as stated in his Pension record file W8252, application made 24 June 1833, Randolph Co., Va.. He enlisted at Frederick Co., March 1781 under Capt. Wm. Frost in Va. Militia. He served a second term of three months, from Aug. 1781, under Capt. Geo. Bell.

In his application, he says that he lived in King George Co., Va. for a year after the War, and from there went to Frederick Co. until he later moved to Randolph Co. (later in W. Va.). He married 23 Dec. 1785, King George Co., Va., Winifred Mardis, daughter of James and Ann Mardis (Marders).

His Fairfax Proprietary Lease for one hundred acres, dated 15 Sept. 1792, signed by Denny Fairfax, was recorded, Frederick Co. DB #23 p.306-9, witnessed by Wm. Marders, Wm. Wyley & Michael Reveal (sp?). The Lease included the names of his two oldest children, Lucy (b.1786) and Richard (b. 1788), and was for Lot #354, and required the usual house 20'x16' with brick or stone chimney to be built, and the planting of 100 apple trees, etc.. It adjoined his Ather's Lease, just S.E. of the Burwell Island in Shenandoah River. The annual rent was to be 40 shillings.

Ambrose and his family moved about three counties west into what was then Randolph Co., Va., and settled on Lipscomb Ridge on Limestone Mountain. This area later became W. Viginia in 1863, and over the years, several new counties were created, and Limestone Ridge is on the border, now, of Preston and Tucker Counties. His 1810 Randolph Co. Census shows-- p.425,1.10,

Ambrose Lipscomb died 18 May 1841, and he (and later, his widow, Winnie) is buried in the Lipscomb cemetery, in Preston Co., near the present Tucker Co. line, between Aurora and St. George, W. Va..

Winnie, his widow, lived with her son, Henry, for some time after the death of Ambrose. She applied for her widow's pension 11 May, 1846, Preston Co., W. Va., listing her age as 78, and too old and infirm to go to the Court House to make out the application. Her death date is not presently known, but she did make a request for a correction in her pension payment, 24 Feb. 1847 (from \$20.00 to 23.33), probably when she was living with her son, Henry. But, she is not listed in Henry's household on his 1850 Census, Preston Co., so she may have died meantime.

MILLIAM LIPSCOMB, probably the youngest child of Richard and Sarah (____) Lipscomb, was born ca. 1765 (85/1850), possibly even back in King William Co., before the parents went to Frederick Co., Va. by 1779.

He married, 4 Aug. 1791 (Fred. Co. Mar. Bonds, at Winchester), Nancy Marcus (Marquis), daughter of John Marquis whose will, 12 Nov.1794, prob. 3 Feb.1794, Fred. Co., Va., named a daughter, Nancy.

William took out his Fairfax Proprietary Lease, 17 Nov. 1792, recorded 3 Apr. 1793, Fred. Co. Book 24 p.188, for lot #439, 76 acres, covering the lives of himself, his wife, Nancy, and first-born son, John (b. 1792) This lease was adjacent to his father, and to his sister's huband, Wm. Marders. The main stipulations on most of these leases asked that a dwelling house 20'x16' be built, with brick or stone chimney, and that at least 100 apple trees be planted, thirty feet apart. This area has always been known as splendid apple growing territory.

William sold this land by deed, 27 Nov. 1800, for 140, to Robert Wyman (Fred. Co. D.B.B p 22). His tax record had shown payment of taxes through only 1800, in Frederick Co.. So, it is very probable that he and his brother, Ambrose Lipscomb, may have left together (p.173) for a little farther west, in the then-current trend of expansion beyond the mountains.

We find him on 1810 Census of Monongalia Co., Va. (now in W. Va.), p.518

Ambrose Lipscomb stayed in this area, which later in 1863, became West Virginia, but William seemed more venture-some. 21 Nov. 1815 (Fred. Co. D.B. 37 p.427), he and his wife. Nancy, together with her four sisters, Priscilla, Margaret, Elinor and Betty, with their husbands, sold to Rawley Colston land that they had inherited from John Marcus (Marcuis).

Then, in 1816, we find William Lipscomb's name on the Campbell Co., Ky. Tax lists. He had followed his brother, John Lipscomb (p. 168) and his brother-in-law, William Mardis (p. 164) to Kentucky.

By 1850, his wife had died, and he is listed alone on the Campbell Co., Ky. Census, 2nd District, p. 231, --

His will, 12 Feb. 1851, recorded July 1851, Campbell Co. (W.B.C, p 142) lists his children, -- John. Betsey, Marquess, William, James, Mary, and Joseph. Joseph, his youngest son was named Executor, and the will was witnessed by Wm. Standley, and Wm. Johnstone, both of Campbell Co.

His name was used, with his father and mother on their 1792 Farifax Lease (three-lives lease). He was taken by his parents, before 1810, to Monongalia Co. (W.) Va.. There, he married 15 Feb. 1816, Thursday Coslow, b. ca. 1792 (58/1850), daughter of James Coslow of Harrison Co., (W.) Va.

John had served in the War of 1812, drafted at Morgantown, for 3 months under Capt. Hurry, disch. 13 Aug. 1814, 6th Reg., Va. Militia.

They lived in Harrison Co., in the portion that became Ritchie Co., 1843. The 1830 Harrison Co. (W.) Va. Census lists, -- p. 318,--

ANN LIPSCOME, first named daughter, and sixth named child of Benjamin Lipscomb, in his Amelia County will of 1778, was the last of the children to receive only one shilling as legacy. She was born possibly ca. 1743. She had married Moses Tandy before her father's will. - he named her as Ann Tandy. This is confirmed by the will of his father, William Tandy written 1792 and recorded, Fayette Co., Ky., in which he listed a daughter. Frances Lipscomb (wife of Joseph, brother of Ann) - and a daughter-in-law, wife of his son, Moses. This might indicate that both Joseph and Ann had married back in the King William County area, and neither one went to Amelia County (?).

Further research has not been done regarding her place of residence, but we wonder if she could possibly be the Ann Tandy on Pierce Sanford's list of 25 March 1810 Tax list of Orange County, Va., with one male titheable, 2 slaves and 3 horses.

ELENORA LIPSCOMB, the only other daughter listed in the will of Benjamin Lipscomb, received two negro girls. Jenny and Eve, one bed and furniture, a pewter dish and six pewter plates.

She would have been born probably ca. 1744.

Nothing more is known of her.

134 URIAH LIPSCOMB, Son of Benjamin Lipscomb (p.147)

URIAH LIPSCOMB, last named son in the will of Benjamin, and no doubt, the youngest child, was born in 1746 (according to a DAR descendant's application), probably in King William County.

He went with, or possibly preceded his father to the Amelia County area, where Uriah bought land from Philemon Crain, -200 acres in Amelia County on Winningham's Creek, for £145, 27 July, 1769 (Amelia D.B. 11 p.34). Philemon Crain was designated as of Nottoway Parish, Amelia Co., and Uriah as of Lunenburg County.

His tithe listing is recorded, 1769 in Cumberland Parish, Lunenburg County-Chas. Hamilton, (gentleman)'s list, (?)8 tithes 800 acres (a lot for a young man!) His next tithe list was 1771 Nottoway Parish. (VSA tithe lists)

In 1772, he bought more land from Richard Hudson (Amelia D.B.11 p. 389)

His 1779 tithe list (VSA) Nottoway Parish, AmeliaCounty (list of Sam'l Sherwin) lists Uriah and Benjamin together (the year after Benjamin wrote his will), naming their slaves, - Hanah, Daphne, Cynder, Jane and Leartha (?). So. Benjamin had come to Amelia County by this time.

In March, 1779, Uriah Lipscomb turned in his money \$84.00, to be taken out of circulation (see Nat'l Gen. Soc. Quart., Vol.46 p.190)

He did not serve in the military forces during the Revolutionary War, but he did furnish supplies, recorded --

Amelia County Court Booklet I,62; Certif. 1; List I,1; Commission B.Ip.71

Benjamin Lipscomb's will, written 17 July 1778, was probated evidently in 1783 (not dated in the AmeliaCo. Will Book), and Uriah had been appointed the Executor. He received the bulk if the estate, as well he might, since he had seemingly been the most attentive son. He received eight negroes,— Hannah, Daphne, Cunder, Leante, Lucy, Sam, Rachel, and Jerry... also his stock of every kind, household furniture & plantation utensils. Whether or not Benjamin actually owned land, cannot be determined.

Nottoway County was formed, 1788 from Nottoway Parish in Amelia County, so we look there for continuing records. There he was taxed 1789 through 1798 for 370 acres, then bought additional acreage 1790, on Winningham Cr. from Reynard Anderson (Nott.D.B.1 p.68). Beginning 1804, he had bought 630 acres in Charlotte Co. for which he was taxed through 1819, when his son, Temple Lipscomb assumed the tax. Uriah stayed in Nottoway Co.

Uriah Lipscomb is thought to have married three times. The name of his first wife and date of marriage is unknown. Second wife, Mary ____. Third wife, Susanna ____ named in his will. It seems impossible to determine birth dates or sequence, or the mother of each of his children, who are listed in his will-dated 25 Apr.1825, recorded 6 Oct.1825 (Nott.W.B.5 p.307) --

189 TEMPLE LIPSCOMB . Son of Uriah Lipscomb (p.195)

TEMPLE LIPSCOMB, son of Uriah Lipscomb and one of his three wives, perhaps the 2nd or third. From Census records we assume that he was born between 1770 and 1780, probably more nearly the latter date, since his first marriage was 9 Apr. 1801, to Mildred Lipscomb, daughter of Richard G. Lipscomb of Charlotte Co. (Char. Co. Mar. Hec. 1765-1863, p.78).

Temple had been born in Amelia Co., Va., in probably the portion which became Nottoway Co., 1788, where his father owned land, and lived with his family. Uriah Lipscomb had bought 630 acres on Bluestone, in Charlotte Co., which Temple assumed, taxwise, in 1820 (as 624 acres), so, it is possible that Uriah had sent his son, Temple to manage that land, near their kinsman, Richard G. Lipscomb. Later tax records show this land to be 18 mi. S. of Court House.

Mildred Linscomb died by 1818, and we find a second marriage for Temple, 21 Sept.1818, in Prince Edward Co. records, to Elizabeth A. Hawkins, dau. of Benjamin Hawkins. Her 1850 Census shows her to be 53 years old- so b. 1797.

Temple Lipscomb's will, dated 6 Mar. 1849, was probated 7 Mar. 1849, almost immediately, setting a close approximate death date. (Char. Co. M.B.9, p. 151). His widow, Llizabeth apparently made her home with Coleman O. Lipscomb, being listed in his 1860 Census record, as ae. 61, b. Pr. Edw. Co..

The 1850 Nottoway Co. Census gives a similar and somewhat comparable listing p. 387, line 7, but gives Parsha O. Lipscomb as age 57 (indicating birth 1792), and all names of children are shown as females except Junius Leigh, and possibly the last name.

P.75 "Old Homes and Families (Nottoway)" - Turner, indicates that-Just Fast of Crewe in Nottoway Co. is (or was) Mica Hill, - it was settled by Capt. P.O. Lipscomb whose wife was Mary Hardway. Their children were Mrs. Sidney Graves, Mrs. Hudgins and Mrs. Rowlett Perkinson. The puzzle remains -- which was which? and why the unusual names?

WILLIAM LIPSCOMB II, Son of William and Mary (Swan) Lipscomb (See p. 18)

WILLIAM LIPSCOMB, son, - the "supposed son", as indicated in Thomas Swan's will of 1704 (p. 20), was the son of William and Mary (Swan?) Lipscomb. Though not having actual proof, it is generally accepted that Thomas Swan was the father of Mary, the wife of William Lipscomb. I. William I, was son of Ambrose Lipscomb I. William Lipscomb II, then, was born before 1704.

Due especially to the fact that the records of King William Co.. Va. suffered much damage in a Court House fire, 1885, and practically all records, deeds, wills, etc. are entirely missing from about 1725 to 1785. the time during which this William II would have lived as an adult, there are no records of his life. in King William Co..

Unless, that is, the one deed, referred to (p. 19), to William and John Lipscomb from John Williams, 1722, for 55 acres (perhaps 155 acres) on the west side of Jack's Creek, -- apparently west of the area where the original lipscomb Land Patents were located. It seems, however, that no matter which William and John this may have been-- William I and his brother John, or this William II and a John Lipscomb, -- nothing further can be found of this land ownership - to prove or disprove any identity.

The only possible information of any William Lipscomb to fit the identity of William Lipscomb II found so far, would be the two references in North Carolina. and they seem a bit distant, and yet, timewise, feasible, -

They are, -- ("N. Car. State Record" Vol. 22, p. 323)

- 15 Apr. 1758 Wm. Mansfield Lipscomb was on the list of Craven Co. Troop of Horse. Committee, by Capt. Peter Rutgers.
- 31 May 1758 Wm. Mansfield Libscomb was an Executor of the will of Samuel Lawson, Craven Co., N. Car. ("N. Car. Wills")

Craven Co., N. Carolina is near the central east coast area of the state, formed 1705 as Archdale from the original precinct of Bath, and changed the name to Craven in 1712.

Could our William Lipscomb II have left Virginia as a young man, for the newly opening areas in North Carolina? Could he have assumed a middle name of "Mansfield" from the maiden name of his mothers (Mary Swan Lipscomb) grandmother, Mary (Mansfield) Swan. (p.19, Mary Mansfield had been the 5th wife of Thomas Swan(n)(1616-1680) and was the mother of the Thomas Swan, supposed father of Mary, wife of William I, and mother of William II.

Fanciful imagination might follow this line, --- Thomas Swan (of the 1904 will) (grandfather of William Lipscomb II) was born 1670, son of Thomas Swan(n) (1616-1680) and his 5th wife, Mary (Mansfield) Swan(n). Thomas Swan(n) and his second wife, Sarah Codd, had had a son, Samuel Swan(n), b. 1653. Samuel stayed in Va., Surry Co. until ca. 1700, when he left for N. Carolina, and became Speaker of the Assembly, there, "prior to 1715".

Samuel Swann married twice and had children, one of whom was Colonel Samuel Swann, b. 1704. who was prominent in the State, and retired as Speaker of the Assembly in 1762 after nearly twenty years in office.

No other possible less fantastic reason has presented itself, but could young william Lipscomb II have been drawn to N. Carolina through some such connection? And, could be have used the name "Mansfield" for distinction?
