MARIAH LIPSCOMB, possible daughter of Anderson (p.349)

MARIAH LIPSCOMB, a possible daughter of Anderson Lipscomb, is mentioned only in the will of her brother, Capt. Reuben Lipscomb, when he called her "sister". (She might even have been his sister-in-law?)

Nothing further is known of her. She possibly married.

## Continuing - The Sons of JOHN and DINAH (MACKGEHEE) LIPSCOMB (p.21)

## 17 GEORGE LIPSCOMB, Son of John and Dinah (p.21)

GEORGE LIPSCOMB, has been placed, by early Lipscomb researchers as a son of John and Dinah (MackGehee) Lipscomb. His records can be easily distinguished from those of George Major Lipscomb, who was most likely the grandson of Ambrose Lipscomb II, brother of John (the father of George).

He could have been born ca. 1725-30. "George" was not a typical Lipscomb name, and could have been chosen because of the reigning monarchs of Britain-George I (1660-1727) reigned 1714-1727; George II (1683-1760) reigned 1727-1760.

The name of his first wife, the mother of his children, is unknown. They were married probably ca. 1750. He married (2) Ann (Madison) Lipscomb, widow of his brother John Lipscomb (see p. 423). John had died ca. 1777, leaving in his will a stipulation that his widow should bring her children up to the age when they could claim their inheritances, so she apparently waited until 1785, and, that year, on 16 Sept, she and George signed a special marriage agreement (K.Wm.B.II p.62-67) whereby she would keep title to all her own holdings. (The page # in B.II-above- could be 221 or 227.—Confusing!)

The documents involving the inheritance from his son, Daniel (see later) indicated that George Lipscomb had died"intestate on or about the year 1795 or 6", but other evidence indicates that he died ca. 1800. George Lipscomb witnessed a Deed of gift from Ambrose Lipscomb U.H. to his son, Foster Lipscomb, 25 acres, 23 Apr. 1799 (K.Wm.B.4 p 509). Tax on his 428 acres of land 9/2 was paid through 1800, but in 1801, it is listed in the name of his son, John P. Lipscomb and says "from his father" (425 acres, perhaps resurveyed?) The death date of his wife is unknown, but it was after 1813.

A survey diagram shows Ellett Land on a document (K. Wm. B.4 p.21) and gives a notation of the neighboring land of George Lipscomb, which apparently was north of Acquinton Swamp and very near the Acquinton Church. Later tax record (for John P.) show the land as 5 mi. W. of the Court House.

George Lipscomb furnished supplies for the Colonial Army during the Revolutionary War, on different occasions, recorded K. Wm. Co. Court Booklet 17, 24; Certificates\*2; list I77,8 II 2; Commission BookIII\*251, 252.

A Miscellaneous microfilm Reel #160 at VSA shows an account book for Rob't Pollard's store at Ayletts on which are listed purchases by --

7 Jan. 1782 Henry Lipscomb gauze, linen ribbon & thread 8 Sh.16p.

26 Jan. 1783 Ann Lipscomb (before her remarriage) 3 " 17"

After the death of George Lipscomb's son, John P. Lipscomb (his only son at the time of his death, and heir of his lands), in 1812, Ann Lipscomb, widow of George (& step-mother of John P.) signed a complicated Tri-partite deed, 22 Mar. 1813 (K. Wm. B.6 p.215) with Wily Roy & Thos. Edwards of K. Wm.

of the second part; and William Burke of K.Wm.Co of the third part. (Wily Roy was of K.& Qu. Co.). Edwards and Roy were to stand bond as security for Ann M.R. Lipscomb (bond payable to Temple Ellett, Sheriff of K. Wm. Co.). Ann put up 2 negroes, 2 beds, 1 cupboard, 6 walnut chairs, 2 walnut tables, 1 walnut desk, 6 windsor chairs, 1 iron, tongs, 14 green edge dishes, 1 horse, and 1 gigg & harness. These items were to be sold by Wm. Burke, Jr. at public auction to cover any judgment brought against Edwards and Roy. That was devotion from a step mother! The notation in the margin of the Court Book says "This deed delivered to Wm. Burke, Jr. Over the 3rd April 1815". It had to do with the settlement of John P. Lipscomb's estate.

The signature "Ann M.R.Lipscomb" remains a mystery, -- what did the "R" stand for?

Since no will or administration documents remain, we must rely on the Inheritance records in the Revolutionary War files for the list of the children of George Lipscomb, and his first wife (name unknown), —

- WILLIAM LIPSCOMB, born ca. 1755 (?); apparently had no family; died intestate, "about 1795". (See next)
- GEORGE LIPSCOMB, Jr., born ca. 1758 (?); apparently no family; died before 1799? (See below)
- DANIEL LIPSCOMB, born ca. 1760 (?); did not marry; killed in the Revolutionary War, 1781 (See p.367)
- JOHN P. LIPSCOMB, born ca. 1765(?); married Jane Wiley Beverly; died 1812-3 (?) (See p.367)
- 290 LAVINA LIPSCOMB, born ca. 1756; married Samuel Edwards; died (See p.369)
- MARY LIPSCOMB, born ca. 1770; married Foster Lipscomb; died ca. 1812 (See p.369)

In later records, it would seem that the male line in the George Lipscomb family died out.

## 386 WILLIAM LIPSCOMB , Son of George Lipscomb(p.365)

WILLIAM LIPSCOMB, eldest son of George Lipscomb and his first wife, would have been born possibly ca. 1755, King William Co.. He was listed on 1787 Personal Property Tax list of his father, George, as being over 21, and he may probably be the William Lipscomb on only the 1791 Personal Property Tax list, in his own name. The document dealing with the inheritance from his brother, Daniel, explains that William, being the oldest, would, according to law at the time of Daniel's death, have been the heir, - but that William had died intestate and without descendants about the year 1795. (And that George Lipscomb, his father, would have been next in line of inheritance, but that he, also, had died)

## 387 GEORGE LIPSCOMB, Son of George Lipscomb (p. 365)

GEORGE LIPSCOMB, probably the second son of George Lipscomb and his first wife, was born possibly ca. 1758. He, likewise was shown, in 1787 Personal Property Tax list of his father's, as being over 21. And, he may probably have been the George Lipscomb on the 1795 Pers. prop. list in his own name. He probably died by 1799.

DANIEL LIPSCOMB, son of George Lipscomb and his first wife, would have been born ca. 1760, King William Co.. He apparently did not marry; and he died, -"was killed in the summer of 1781 at James Town" - as a Lieutenant of Artillery - of the Continental Line, in the Revolutionary War.

Numerous War records refer to him, -- Gwathmey pp 477-8; Eckenrode (1912) pp 271-2; Brumbaugh p. 1159; etc.. The National Archives provides the single slip indicating that his balance of pay was collected 27 July, 1784 by Ed Valentine-- 145-13-2.

Most revealing are two documents of 1835 dealing with the disposal of the Bounty Land Warrants due Lt. Daniel Lipscomb, claimed by his heirs. These have been carefully studied, because they disclose the identities of most of the family of George Lipscomb, his father. (See p. 370)

VSA furnished photostats of a letter (63-345, Folder 26) from John H. Smith 24 July 1835, directed to the Governor relative to the claim by the heirs of Daniel Lipscomb, Lieutenant of the Art., State Line for bounty land for his services. It ouotes --

"The facts, which have been proved by living witnesses, were -- that Dan'l Lipscomb was a Lieutnenat of Arty - of the Cont! line - that he was at the battles of Monmouth, and Stony Point - that he served three years in the Continental line, and was killed in the summer of 1781 at James Town. (see the affadavits of Alexander Shackleford - James Jones - James Whitlock - Wm. Terry - Mary Pollard - and Molly Madison) all the witnesses have been satisfactorily proved to be highly respectable & worthy of full credit.)"

Ten full pages of documents are found in VSA Land Office Military certificates Box 111. Folder 32. These begin with a hearing "At a court of Quarterly Session held for King William County at the Court house on Monday the 24th day of August. 1835 --"

It recites the "vital statistics" of the members of the family of George Lipscomb and descridants who are lodging the claim, thus enabling us to put together the family, as listed in the several segments, here related.

The claim was resolved in #707, Exchange Warrant #239 for 2666 2/3 acres (and apparently Scrip for 2400 (3?) submitted to the Scretary of the Treasury. General Land Office, 9 Sept. 1836.

## 389 JOHN P. LIPSCOMB, Son of George Lipscomb (p. 365)

JOHN P. LIPSCOME, only son of George Lipscomb who survived his father, was born possibly ca. 1765. Since he was not listed among his father's sons in 1787 P.P. Tax list, he was probably not yet 21 years of age. He married ca. 1805 (?) Jane Wiley Beverley, daughter of Harry Beverley and his second wife Jane Wiley Roy. He died, according to the Lt. Daniel Lipscomb documents, "intestate sometime in 1812."

He had inherited his father's land, 428 acres, 9/2, as of 28 Sept. 1801

- Land Tax, King William Co.. It became 425 acres on the list, for his father in 1793, and showed 1801 in John P. Lipscomb's name as "from his father". By 1814, his land was listed as "Est." confirming the statement "died sometime in 1812". His death must have been unexpected, he left no will. Ann Lipscomb, his step-mother, signed her Tripartite deed in settling his estate. (See p.365) The children of John P. and Jane Wiley (Beverley) Lipscomb were --
  - 389-A GEORGE WILEY LIPSCOMB, born 1808; married Mildred King; died 5 Dec. 1887
  - 389-B MARGARET A. LIPSCOMB, born ca. 1810 (?); married June 1831 Robert Burke; died after 1835.
    - 389-A GEORGE WILEY LIPSCOMB, Son of John P. (p. 367)
- GEORGE WILEY LIPSCOMB, only son of John P. and Jane Wiley (Beverley) Lipscomb was born in 1808. King William Co., according to the Obituary notice of the "Religious Herald" of Dec. 29, 1887, which gives his death date as 5 Dec. 1887. He married Mildred King, daughter of Walter and Dicey King, apparently late in his life, since the 1850 Census, King William Co., shows, p. 476. #33-27 --

George W. Lipscomb 41 farmer \$2,000 Mil.... " 26 Betty C. " 2 Nannie 6/12

Other children were born after 1850, and were listed in the Daniel Lipscomb document, -- completely -- as well as in George Wiley Lipscomb's will, K. Wm.

- BETTIE C. LIPSCOMB, born 1848; did not marry; inherited, along with her sister, Nannie, the homestead; This land seems to be the 75 acres they deeded, 1919 to Lawrence A. Lipscomb, Sr., (K.Wm.D.B.35 p 237) along with the 160 acres from Mildred Lipscomb. sole heir of their brother Robert S. Lipscomb.
  - II NANNIE LIPSCOMB, born 1850; also did not marry; See above.
  - III CHARLES W. LIPSCOMB, born after 1850; did not marry. Had been given his portion of his father's estate before the writing of his will.
  - ROBERT S. LIPSCOMB, born after 1850; thought by some not to have married, --however, in 1919, his daughter, Mildred Lipscomb, deeded to Lawrence A. Lipscomb, Sr., (along with her aunts), the 160 acres she had inherited from her father, adjoining the 75 acres sold by her aunts, "on the N.W. side of the public road leading from Acquinton Church to Manquin, Virginia". (See bottom page 49, under Temple Nelson Lipscomb) So, Robert S. Lipscomb had a "sole heir" --
    - -1 MILDRED E. LIPSCOMB, b. ; died
  - WALTER S. LIPSCOMB, had inherited, along with Robert, land in his father's will; apparently did not marry.

MARGARET A.LIPSCOMB, only daughter of John P. and Jane Wiley (Beverley) Lipscomb, was born probably ca. 1810. She married June 1831 (or 137?) Robert Burke (1808-1874) and they lived at "Spring Bank". He was son of Waller Burke and Mary Edwards Burke. Her death date is not known.

They had one child, of record, --

-I GEORGE HAVILAND BURKE, not mentioned in the 1835 document, so was evidently born after 1835.

390 LAVINA LIPSCOMB, Daughter of George Lipscomb (p.365)

Mas born probably in the 1750s. She married, as his second wife, Samuel Edwards, eldest son of Ambrose Edwards (b. ca. 1750 at "Cherry Grove". She died, intestate, ca. 1823, leaving the following children --

- SALLY P. EDWARDS, born 1781 (?); married ca. 1822 (?) John Pemberton; She died, intestate before 1835, leaving one daughter,--

- D JOHN EDWARDS, no record, except as listed in 1835.

- -I NAPOLEON BURKE, "infant" in 1835 document. Could he be the Napoleon Burke, ac. 30, in the 1850 Henrico Co. Census, p 289, in the home of Solomon A. Marsh (from Conn.)?
- AUSTIN EDWARDS, no record, except as listed in 1835.
  Census records for these children have not been checked.
  - 391 MARY LIPSCOMB. Daughter of George Lipscomb (p. 365)
- MARY LIPSCOME, was the last child mentioned as daughter of George Lipscomb and his first wife. She was born possibly as late as 1770, and married, probably ca. 1799, a cousin, Foster Lipscomb who died by ca. 1809-10. He was son of Ambrose Lipscomb U.H., who made out to him a deed of gift, 25 Oct.1799, of 25 acres-(possibly a wedding gift?) The deed was witnessed by Mary's father. George Lipscomb. See p.453for children.

### Continuing - The SONS of JOHN and DINAH (MACKGEHEE) LIPSCOMB (p. 21)

DANIEL LIPSCOMB, Son of John and Dinah Lipscomb(p.21)

DANIEL LIPSCOMB, son of John and Dinah (MackGehee) Lipscomb, a fact not proved, but accepted by all the early researchers in the family. It may have come down by tradition. He was born possibly ca. 1728-30. He married by ca. 1746-50, The wife he had at the time of his death was Keziah, and it is generally thought that she was Keziah Yancey, since one son was named Yancey. But, so far, no proof of such can be found, after careful search. It does sound logical, however, and it is quite possible that she was the mother of all his children.

There was a Keziah Yancey, of record, daughter of Richard and Mary Yancey, of Louisa Co., Va.. Richard and Mary sold their Louisa Co. land in 1753 and 1759, and went to Mecklenburg Co. where they died, his will 1780, hers 1795. One of their heirs was Keziah Nuckols, a daughter, so she could not have been the wife of Daniel Lipscomb who died ca. 1777. Daniel and Kezie had given a deed in 1767. A later Keziah Yancey, daughter of Lewis David Yancey, married 1781 Culpeper Co., Va. George D. Freeman (1763-1831) and they went to Woodford Co., Ky.. An even later Keziah Yancey married. 1839, Reuben Edward Lightfoot (Culpeper Marriages, p. 65) (Culpeper County, Va."- Green, p. 81-82, "Yancey-Medearis"- Norwood-1958, DAR Lib. and "Book of Remembrance-Meacham Family" 1953 p. 67 DAR Lib.)

Daniel's name could have been given to him, as named for a Daniel Miles, an early well-respected figure in King William County, - a Justice of the Peace along with Richard Gissedge. Daniel was not a usual Lipscomb name.

No actual records remain in King William books for Daniel Lipscomb. He apparently became somewhat involved in the effort at "western expansion", but he did retain, it seems, his residencey in King William County. Goochland County was created 1727-8, a little farther west of King William County, Their deed Book 9 p.87 shows a deed, 16 Mar.1767, from Daniel Lipscomb and Kezie, his wife, of St. John's Parish, K. Wm. Co., to John King of Goochland Co., 294 acres, L240, "which had been conveyed by Wm. Neaves in way of a swap,"-- land in Goochland and Hanover Counties. This was, no doubt, the 294 acres which Anderson Lipscomb, his brother had bought, 18 May 1762 from William and Christian Neaves (Goochland D.B.8 p.249), and Anderson and Daniel had swapped land in some fashion.

John King had married, according to the Douglas Register, 6 Apr.1766 Mary Lipscomb of St. John' Parish. King William Co. (he of Goochland Co.). It is thought that his wife, Mary was a sister of Daniel, John, George, Anderson, and William, all children of John and Dinah (MackGehee) Lipscomb. (That marriage date is noted, because it is actually the birth date of the first child to John and Mary (Lipscum) King, in his Register, p. 83. Or, wasn't she more probably the daughter of Daniel and Keziah? (See p. 421)

Daniel's death date can be determined as being between 5 Dec.1776, the date of John Lipscomb's will in which he appointed "my brother, Daniel Lipscomb" (and his 2 oldest sons) Executor, — and 21 July 1778, the date of the first record of the furnishing of supplies from his "Estate" for the Revolutionary forces.

The supplies furnished included "Freight of cannon from York to the Capitol

Landing; 475 lbs. beef; and 350 lbs. beef, all allowed to his "estate". These are recorded in Public Service Records, VSA, --

K. Wm. Court Booklet 3,8,24; Certificate 2; List I 5,9; Commission B.III 250,251 & IV 337

Keziah, his widow. is credited with one entry (DAR acceptance) List I,p.7 - (line 24) - 21 July 1783 - To Keziah Lipscomb for carriage ±372-10-0

It is odd that neither Daniel's Estate nor Keziah are listed on the 1780 K.Wm. Specific Tax. But, in the beginning year of general Land and Personal Property Taxes, Keziah Lipscomb is listed -- and two of her sons, 1782 --

Personal Property tax -- Lipscomb Yancey )

Keziah Lipscomb )

Lipscomb, Dan!

Lipscomb Dan!

Lipscomb 240 acres 7/

Keziah " 306 " 8/

Thus, we see that Yancey was still living at home with his mother, - odd that he is not listed as a tithe since he had been a Capt. Lieutenant in the Revolutionary forces, and most surely over 21, -- and, that Daniel had already started on the large accumulation of land in his future years, -- perhaps, this had been given him by his father.

Then, on the 1789 Alterations. the listing would indicate that Keziah Lipscomb had died and that her 306 acres were inherited by son, Daniel (does this mean that Daniel was the eldest?) --

"Heir- Daniel Lipscomb 306 acres 7/4 ... of Keziah Lipscomb"

Yancey was to acquire, by deed apparently, 331 acres on the 1792 Alterations, from William Marshall. And, Anderson, the third son, had acquired 600 acres 7/4. from the Roger Lipscomb Estate (by deed?)

It seems to have taken some years to completely settle Daniel Lipscomb's estate, and Yancey acted in the final affairs. On 23 Oct.1804 Yancey recorded 2 receipts dated 9 April 1798 to himself as Executor, each for one thousand dollars, from Daniel and from Anderson. "in full for my proportion due me from the said estate of my father". (Anderson had died ca. 1800, and quite evidently, the Clerk made an error in dating Anderson's receipt as 9 Apr.1804)(B.4-291) (See p. 390)

The children of Daniel and Keziah (Yancey?) Lipscomb were --

- YANCEY LIPSCOMB, born ca. 1752; married Elizabeth Powell; died 1
  May 1813 (See p. 373)
- DANIEL LIPSCOMB, born ca. 1759; married Jane; died ca. 1829 (See p. 403)
- 394 ANDERSON LIPSCOMB, born ca. 1756 (?); died ca. 1800. (See p. 419)

And, it is to be presumed that there was a daughter, --

MARY (MARIMAH) LIPSCOMB, born early 1750s; married, by 1766, John King. (See p. 421)

YANCEY LIPSCOMB, son of Daniel and Keziah (Yancey?) Lipscomb, was born, King William County, probably ca. 1752. He married Elizabeth Powell ca. 1785 (?). His wife's name has not been proven, but has been accepted by all researchers, especially since they named two of their sons, - Hudson Powell Lipscomb, and John Powell Lipscomb. Elizabeth's mother was probably the "Betty now the wife of Mr. Hudson Powell", grantee of her mother, Mary Cunningham of the Co.of Warwick. - "Rec.of Col. Gloucester Co., Va." - Mason. V.IIp.123.

Yancey Lipscomb distinguished himself in the Revolutionary War. By 13 May 1778, he was listed as 1st Lieutneant in Virginia State Line (Eckenrode-1912 references-- Aud. Acct.1780,293; C.J.1777-8,281; Heitman 266; War 5, 14; Aud. Acct. VII,184). He was promoted to Captain Lieutenant, and served to March 1782. Gwathmey says that he was in Edmond's Command, Artillery in Feb. 1781 under Col. Thomas Marshall.

His Bounty Lands are listed in Wilson and in Jillson, as Warrant #82, for 4,000 acres. for 3 yrs. service as Capt.Artillery of Va. Jillson dates the Warrant as 31 Dec.1782, and Wilson 20 Feb.1783. P.383, Jillson "Old Kentucky Entries and Deeds" places these, in 1784, as 1,000 acre tracts each on four different locations- Pitman Cr.; Cumberland R.; Fk. of Pitman Cr.; and S.Fk. Big Barren River. These lands were later sold by some of the children of Capt.Lt. Yancey Lipscomb.

In addition to his War service, Yancey furnished supplies, as recorded -

These presumeably after the War, when he was listed, for instance, in 1782 Personal Tax, along with his mother, Keziah.

As did his father, Yancey dabbled in "land speculation" in Goochland County. 17 Jan.1786, (Goochland DB.14-p.271), Yancey Lipscomb of King William Co. bought from Stockley and Eliz. Towles of Goochland, 350 acres in Goochland Co. for L812-10-0. This tract, Yancey sold later, having advertised 7 Dec. 1791. a sale of 3 tracts of land, one lying in Goochland Co., another in K. Wm. Co. within 4 miles of Hanover Town, containing 33 acres with a good dwelling house" (Ryland's King William Co. from Old Newspapers and files").

Meantime, Yancey Lipscomb had married, perhaps ca. 1785 (?), Elizabeth Powell, it is thought. On the 1792 Tax Alterations of King William County, he is shown as having acquired (by purchase, presumably) - 331 acres, 6/11, from William Marshall in King William Co. His Personal Property Tax in 1798 showed that he had 17 slaves, 5 horses and 8 cattle, plus a chair. In 1800, he added 100 acres, then, in 1802, he bought from James Dabney the "Brickhouse" tract, 419½ acres. Dr. Malcolm Harris, in "Old New Kent County History" p.888, points out that Yancey and Elizabeth deeded this land, around the time of his death to Benjamin Pendleton (K.Wm.B.6 p.245). The date quoted, 7 June 1813, would have been after Yancey's death, 1 May 1813, but, perhaps that was the date of recording.

On7 July 1807 is recorded (K. Wm. B.5 p.114) a deed from Yancey and Elizabeth of King William Co. to Simon Dogged, same Co., for 94 acres in St. David's Parish, King William County, beginning at Colledge line, — on Cattail Swamp for \$600. Another deed 21 June 1808 has not been confirmed, to Christopher Tompkins, the 330 acres which he had bought, originally shown on 1792 Alterations.

In Dr. Harris: "New Kent County History" pp 858-875, he describes the unique situation of the College Lands which had been set aside to provide funds for William and Mary College, from rents to around fifty families, or more, on various sized sixty lots. This was an area of over 10,000 acres, on the north side of the Pamunkey River, approximately between just eat of Moncuen Creek to around Enfield, in the western portion of King William County.

Yancey Lipscomb had leases involving Lots #4, 14 and 59, in this Upper College Tract. And, his other land holdings all seemed to be in this vicinity-in the western portion of the county.

Yancey Lipscomb was Administrator of his brother, Anderson's Estate, after his death ca. 1800. A Court record (K. Wm.B.4 p.348) reads--

"I. Yancey Lipscomb, administrator of Anderson Lipscomb. Sr., deceased, in County of K. Wm. in Va., and in the State of North Carolina, Richmond Co., do appoint Christopher Johnson and James Lipscomb, Jun.... distributors, to act for me as administrator and guardian for the legatee which is Melinda, to sale and divide the negroes and property agreeable to the decree of the Worshipful Court.... 6th day of Oct. 1804.

Wit: James Lipscomb Sr. & J. Lord Signed Yancey Lipscomb, Adm. of Anderson Lipscomb"

On Tax lists, 1804 and 1805, Malinda's name with 367 acres 7/4, is listed along with Yancey.

Yancey died 1 May 1813. The death date of his wife is not known.

The children of Capt. Lt. Yancey Lipscomb are named in later documents, --

FRANCES (FANNY) LIPSCOMB, Daughter of Capt. Lt. Yancey (p. 373)

and Elizabeth (Powell) Lipscomb would have been born probably ca. 1788-1790 in King William Co. Her listing in 1850 Census shows her to be aged 60, and, though family tradtition says that she died in 1859, she is shown on 1860 Census, in the household of Yancey Mitchell as aged 75. Other Census records, must be balanced in order to calculate her age.

She had married, in King William County, by around 1806, a cousin, James Lipscomb, Jr., son of James Lipscomb (C), - see p. 36 for their activities in King William County, before leaving for Charlotte Co. ca. 1807 to 1809.

Her grandson's wife (Mary Alice Autry, widow of Hudson Powell Lipscomb) made a signed statement in 1941, giving her recollections of the Alabama branch of the Lipscomb family from her knowledge and impressions. In this she said that her father-in-law (Anderson Lipscomb, oldest son of Fanny and James) "also said that his mother was his father's second wife. As I recall, he said that his father, James Lipscomb, first married a first cousin of his, and that his second wife was a niece of his first wife, and that both were named Lipscomb." This statement is hard to untangle, since we cannot find any sister of Capt. Lt. Yancey Lipscomb, but there could have been one, who died soon after marrying James Lipscomb. Or, of course, the recollection could have been mistaken.

James and Fanny had disposed of his lands in King William Co. in 1807 and 1809 (p. 36), and left for Charlotte County, where they were on the 1810 Tax list, and 1820 Census shows them in Campbell Co., next county west.

On 27 July 1821, "Hudson P. Lipscomb (Fanny's brother), James Lipscomb and Fanny his wife. (who was Fanny Lipscomb, heirs of Yancey Lipscomb, dec'd) of the County of Campbell" deeded to their brother, Daniel Lipscomb, Jr., for \$1.00 each, their interest in 3,000 acres of Kentucky land. This land was in 3 tracts, and represented 2/7 of Capt. Yancey's Bounty Lands. (Ky. Court of Appeals, Deed B. V p 76). One tract on N. side of Tennessee R., one on South side Skeggs Creek and one on south side of Cumberland R..

(In 1834. Daniel, who had moved to Green Co., Ala., bought additional portions of these bounty lands from his brother, John Powell Lipscomb and his wife, Ann. In 1821, he had been designated in that deed, as well as on Tax records in King William Co., as Daniel, Jr. to distinguish him from the older Daniel, son of Daniel I.

Quoting Mary Alice (Autry) Lipscomb's statement further, she said that her father-in-law had said "that his father, James Lipscomb, went to Kentucky and sold some property and started home, but disappeared en route, and that it was always believed that he was murdered and robbed while on the boat and that his body was thrown overboard". This may have been in connection with the Bounty Lands, and it was thought to have occurred during the early 1820s.

Fanny must have been a very courageous woman, herself around age 40, to have tried to keep her family of five sons and three daughters together. They remained in Campbell Co., Va., and are listed in the 1830 Census, there, on p. 373, --

FRANCES LIPSCOMB: males 2 5-10; 1 10-15; 1 15-20; 1 20-30 females 1 5-10; 2 15-20; 1 30-40; 1 70-80

Could it be that the 1 female age 70-80 might be her mother, Elizabeth (Powell) Lipscomb?

Sometime after 1830, she took most of her family to Alabama, apparently to be near her two brothers, Daniel and John Powell Lipscomb who had gone to Greene County, Ala. and were on the 1830 Census there.

In the mid-1830s, James Hill Lipscomb, son of Capt. Bernard Lipscomb, had left King William Co., Va. for Sumter Co., Ala.. (p. 357). Records and family stories all seem to indicate that, there, he married Fanny Lipscomb, widow of another James Lipscomb, their mutual cousin. The Lipscombs really did believe in keeping it all in the family, didn't they! He died in 1844—it is thought. It has seemed impossible to find any Census record of 1840 for them.

The 1850 Census of Sumter Co., Ala. p 283 (second page) lists, line 14,--

Then, interestingly, the 1860 Sumter Ala. Census p.598 (or 32) line 21, lists the family of Anderson Lipscomb, age 53, etc. in the household of Yancy Mitchell (his cousin and business associate), and on the last line is Frances Lipscomb age 75, b. Va.

So, her death date cannot be accurately established.

For so very much of the data of Fanny's (and of her sister, Roxanne) we are indebted to the careful research done some years ago by Sunie B. Spear (Mrs. Andrew Franklin) of Birmingham Ala., dec'd 1974, some of which she sent in 1970, and additional material which was sent on, recently, by Lawrence Yancy Lipscomb. from records she had sent him.

Many of the names of the descendants of Fanny and James Lipscomb have been gleaned from such records as the Sumter Co. Ala. Estate file #561 in the settlement of the estate of Fanny's son, Hudson P. Lipscomb "Sr." who died intestate, in 1873, unmarried. (Among Sunie's files).

As well as can be determined, the children and descendants of Fanny and James Lipscomb are (with many incomplete lines, not submitted) --

Lipscomb.

ROXANNE LIPSCOMB, possibly the second child of Capt. Lt. Yancey and Elizabeth (Powell) Lipscomb, was born probably ca. 1790-1. This date is based on calculations made from Census records and the age of her son, Yancey Mitchell. It had been thought, especially from Alice (Autry) Lipscomb's statement of 1941, that Roxanne had married (1) Abraham Archer and (2) Mitchell, but from material sent in by an Archer descendant, there was an indication that Abraham Archer had married an Anna Mitchell. So, further research was done, and since Yancey Mitchell was aged 53 in 1860 Census, and since the 1840 Census of King William Co., Va. shows Roxa L. Archer, aged 40-50, then, --- Roxanne would have had to have been wife of Mitchell before marrying Abraham Archer, and becoming a widow by 1840.

So, Yancey Mitchell would have been born ca. 1807 (53/1860), — and he had a brother John Mitchell, younger or older has not been determined, since no further records have been found, except that he died Dec. 1850, (Sumter Co. D. B.#S p 273, 13 Mar. 1854) according to a statement of Erasmus Archer, a half brother. He also stated that there were no whole sisters of Yancey and John Mitchell.

So, let us consider Roxanne's first marriage, ca. 1806 (?), very young, to Mitchell, whose given name has not been found as yet. Searching King William Co. deeds, and Land Tax records would be very helpful. A spot check of Land Tax, shows several Mitchells, including a John Mitchell as early as 1799, 1762 acres, 6/5, lowered in 1806 to 1262 acres, - and, by 1812 shows as "Est.", so he had died sometime after 1809 (the previous check). It continues as "Est.", fee, through 1829, at least, "adj. Carver King, Est. and Thos. N. Carter, 6 miles west of C.H. He could have been Roxanne's first husband. And, their children --

YANCEY MITCHELL, b. ca. 1807 (?) if the 1860 Census is correct,
King William Co.; he went fairly early to Alabama (with
his cousins in the 1830s?) and seemed cuite close to the
family of Anderson Lipscomb, son of James and Fanny, and
shared a business relationship. The 1860 Census Sumter
Co., Ala. p.598 (or 32) line 21, indicated Yancy Mitchell

Yancey Mitchell's will, 26 Nov.1866, probated Sumter Co., Ala. (W.B.2 p.352), 17 Jan.1867 left \$4,000 to Lawrence Yancey Lipscomb, s. of Anderson and Mary, as soon as he is 21; \$750. to each, Stephen and Hudson P.; and a puzzling legacy to my nephew Zachary Taylor Mitchell -- (Did his brother, John, have a son? - there are so few records of John.) So, Yancey Mitchell d. ca. late 1866 without a family, apparently never married.

JOHN MITCHELL, the other son of Roxanne (Lipscomb) and \_\_\_\_\_\_ Mitchell, would have been born possibly as late as 1812. A Greene Co., Ala. Census record p.38, line 15, 1850, shows a John Mitchell aged 38, Farmer \$800., b. Va., with no family. Was this the John Mitchell we are concerned with?

Sumter Co., Ala. Deed B.#S p.273 includes statements by Erasmus Archer (half brother of John) 13 Mar.1854, and by Frances and her son, Anderson Lipscomb, 14 Mar.1854, to the effect that "Yancey Mitchell is the only whole brother of John Mitchell, and that John Mitchell had no whole sisters". And, indicated that John Mitchell had died in Dec. 1850, in Greene Co., Ala..

Aside from the Census records quoted above, the legal records have been taken from notes in the research files of Sunie (Lipscomb) Spear, dec'd.

Returning, now, to Roxanne (Lipscomb) Mitchell, back in King William Co., Va.. A puzzling entry on K. Wm. Co. Tax records shows, 1816 through 1818--

"Roxelany Lipscomb, life, 40 acres, adj. Chas. Neale Est. & Jas. F. Lipscomb. est. --- "this from Jas. B. Lipscomb, est., for dower" (shown on the 1816 entry) (The 1816 & 1819 entries showed her address as King William Co.; the 1817 & 1818 showed Richmond.)

Had Roxanne married, sometime after Mitchell's death (ca. 1812??)

James B. Lipscomb, son of John Pemberton Lipscomb? (p. 74). Had they had any children? James B. Lipscomb had died, apparently ca. 1815 or 1816.

Roxanne had seemingly lived in Richmond during part of this widowhood.

Had she met Abraham Archer in Richmond, son of Peter Archer, harness maker of renown, of Richmond? They were apparently married ca. 1819. On 10 Feb. 1819. Roxanne's brother and sisters—Hudson P. Lipscomb, Eleanor Lipscomb, and George M. Pendleton (husband of her sister Katherine) and his wife, deeded land to Abraham Archer. (Ida Lee 6W(2)141). And, sometime between 1819 and 1821 (K. Wm.B. 8 p.106) Hudson P. Lipscomb, Abraham Archer and Roxanne, his wife, heirs of Yancey Lipscomb, dec'd, deeded 491 acres to Daniel Ellett, land inherited from Yancey Lipscomb.

The 1820 K. Wm. Co. Census p.310. line 13 shows -- (were some children from former marriages?)

"Abraham Archer: males 1 under 10; 1 26-45 females 2 under 10; 1 26-45" (Roxanne, b. 1775-1794)

The 1830 K. Wm. Co. Census, p.77, line 13, shows --

"Abraham Archer: males 2 under 5; 1 10-15; 1 40-50 females 1 under 5; 2 5-10; 1 10-15; 1 30-40"b.1790-1794(see above)

By 1840, Abraham Archer had died, and the 1840 K. Wm. Census shows --p.71,-

"Roxa L. Archer: males 1 5-10; 1 10-15 females 1 10-15; 1 15-20; 1 20-30; 1 40-50"(herself)

No further Census records have been found. She and her husband had apparently lived in King William Co., tho' tradition had said they had lived in Richmond. Land Tax records and deeds would, of course, be most helpful——Ida Lee's article 7W(2)117 shows that Abraham Archer did pay taxes during 1823 through 1829, King William Co..

There is no evidence that Roxanne went to Alabama to join her two children,

Yancey and John Mitchell, who must have gone there with their Aunt Fanny Lipscomb in the 1830s or shortly thereafter. No record of Roxanne has been found, so far, after the 1840 Census. Tax records might prove the approximate date of her death.

The following information on the descendants of Roxanne (Lipscomb) Archer has been compiled from data sent by Laura Archer Mayeaux (Mrs. Constant H.), P. O. Box 10104, Jackson, Miss. 39206.

HUDSON POWELL LIPSCOMB, a son of Capt. Lt. and Elizabeth (Powell) Lipscomb was born, possibly ca. 1791. This is based on the statement in Dr. Malcolm Harris' "Old New Kent" p. 865, referring to Lot #14 in the Upper College Tract - 491 acres on upper side of Gravelly Run and west of Moncuen Cr., leased to Capt. Yancey Lipscomb on Dec. 1, 1791, and on April 3, 1793, a new lease was given to Hudson Lipscomb, Fanny Lipscomb and Roxanna Lipscomb. So, these three children, still very young, must have been his first three children.

This 491 acre tract, then, was the one deeded by Hudson P. Lipscomb, and Abraham Archer and Roxanne, his wife, to Daniel Ellett. sometime between 1819 and 1821 (K. Wm. B. 8 p. 106). (Fanny had evidently relinquished her rights.)

In 1819, Hudson Powell Lipscomb, Eleanor Lipscomb and George Pendleton, in right of his wife who was Katherine Lipscomb, deeded to Abraham Archer- perhaps at the time of Roxanne's marriage to Abraham Archer.

The 1820 King William Co. Census shows him unmarried, with no children, --p.305 "Hudson P. Lipscomb: males 1 16-26; 1 26-45" (b.1775-1794)

In all probability, he is the older one listed, and the younger one, his brother, Daniel, b. ca. 1797.

On 27 July 1821, Hudson Powell Lipscomb, James Lipscomb and Fanny, his wife, deeded Bounty Lands in Kentucky which they had inherited from their father, Capt. Lt. Yancey Lipscomb, ie. their portions of these lands, to the somewhat younger brother, Daniel Lipscomb. (p.375) (Ky. Court of Appeals, Deed B.V. p.76).

This is the last that has so far been found about Hudson Powell Lipscomb. Did he die young?

## 399 DANIEL LIPSCOMB (Son of Capt. Lt. Yancey) (p. 373)

DANIEL LIPSCOMB, son of Capt. Lt. Yancey Lipscomb and his wife, Elizabeth Powell, was born ca. 1797, King William County. (53/1830).

He had been called "Daniel Lipscomb, Jr." in the deed from his brother Hudson P. Lipscomb and James and Fanny Lipscomb mentioned above, 1821, - in order to distinguish him from the older Daniel Lipscomb in the same King William Co.- the Daniel, son of Daniel and Keziah.

By the mid-1820s, Daniel and his slightly younger brother, John Powell Lips-comb, had left King William Co. for greener fields in Alabama. There, Daniel married 6 Dec. 1826, Greene Co., Ala. Amanda Sadler. (Greene Co. Mar.).

They lived in Greene Co., Ala. in 1830 (Census), and by 1840 were in Sumter Co., adjoining, where the Census record shows, p 112 --

"Daniel Lipscomb: males 1 under 5; 1 20-30; 1 40-50 females 2 under 5; 1 10-15; 2 30-40"

He may not have made much use of the Bounty Lands he had bought from his brothers and sister (p. 375). He had, in 1834, bought additional portions from his brother, John Powell Lipscomb and his wife, Ann, - lands on the South Fork of Skegges Cr., in Kentucky.

There is one deed on record, 21 Mar. 1841 (Barren Co., Ky. D.B. "Q"p. 73)- a deed from Daniel and Amanda S. Lipscomb of Sumter Co., Ala. to Batley and Lewis Wilkinson of Barren Co., Ky. for \$2,100, for 900 acres on Scaggs Creek, from the Military Claim of Yancey Lipscomb. This, then, was the major portion of the land, 1,000 acres, he had bought from John Powell Lipscomb, in 1834, for \$234.00. A tidy profit!

It took a bit of sleuthing to find them in 1850! But, a church record in Sumter Co., Ala., the Concord Presbyterian Church, in 1852 shows a record of their dismissal to Green Lake, Texas. So, checking the Calhoun Co., Texas Census, 1850, finds them, p 267 #7 --

Between 8 July and 7 Aug, 1867, Daniel Lipscomb died, - probably the yellow fever epidemic, - and he is buried in Indianola Texas.

Further records have not been found. A puzzling entry in 1850 Census, in Goliad Co. (2 counties west of Calhoun) p. 843 under a listing line #3, a hotel's register, was listed a --

"W. Lipscomb. M.D. 22 b. Ala." Could he have been a son of Danand Amanda, b. 1828, after their marriage in 1825, - who had studied medicine and had gone to the community in Goliad, Texas, to start his practicein probably a typical frontier community? No further record has been found for him, as yet. Did he marry and have a family? There were a number of Lips combs in the newly set up State of Texas, by this time, and even one town was named Lipscomb.

Daniel Lipscomb, carpenter and builder had gone west to help build up the new areas. - one of the venturesome Americans with a mioneering spirit.

As baken from the Census records, we can assume that their children were, at least, partially, ---

## 400 KATHERINE LIPSCOMB, Daughter of Capt. Lt. Yancey (p373)

KATHERINE LIPSCOMB, daughter of Capt. Lt. Yancey and Elizabeth (Powell) Lipscomb, was born, according to family records, 18 Mar.1798, and surely in King William Co., Va., though her mother was from King and Queen Co.. She married, 6 Nov.1816, George Macon Pendleton (1792-30 July 1866), son of Philip and (2) Mary Ann (Fleete) Pendleton, of King and Queen Co., where they continued to live. Katherine (Lipscomb) Pendleton died 22 Apr. 1873, King and Queen Co..

The 1830 Census of King and Queen Co. p. 281, line 11, shows their family"Geroge M. Pendleton: males 1 under 5: 1 5-10; 1 30-40 22 slaves
females 2 under 5; 1 30-40"

By 1850, their older children had, no doubt, married, and their younger children are listed by name, -- King and Queen, p. 172 #380/380

"George M. Pendleton 58 Farmer \$6,000 all b. Va. Catherine " 52
Benjamin F. " 15
Ella " 9
Wm. F. " 62 (brother of G.M.P.)

Katherine's inheritance from her father seems to be mentioned only once,in the deed to Abraham Archer in 1819, from Hudson Powell Lipscomb, her brother, and from George Macon Lipscomb in right of his wife". (p. 382)

George M. Pendleton acted as Administrator of the estate of his father-inlaw, Yancey Lipscomb, as attested in the document included in the Pension files (Nat'l Archives), having been appointed in the stead of Philip Aylett, sheriff whose letters of administration had been revoked. (So, Yancey Lipse comb apparently died without a will?)

And, as Administrator de bonis non, received, according to a letter from the Auditor of Va., Jas. E. Meath, as follows --

"I do hereby certify that I have this day paid to George M. Pendleton, administrator de bonis non of Yancey Lipscomb, deceased.... the sum of Six thousand two hundred and sixteen dollars, that being the amount received from the General Government to satisfy the judgment obtained for the half pay due said Yancey Lipscomb, as a Capt. Lieut. in the State Regiment of Artillery leaving a balance due to the said Geo. M. Pendleton adm. as aforesaid of thirty dollars & 67 cents; which balance arises as follows to wit: The original estimate of the amount was made upon the supposition that Lieut. Lipscomb died in March 1813- but it was proved to the Court of Appeals that he died on the 1st day of May 1813 and that Court corrected the judgment of the Court below accordingly. Given under my hand at the Auditor's Office, Richmond this 27 February 1833." (signed) Jas. E. Meath Aud. of Va.

It is interesting to note that Government affairs moved slowly then, as now, — and the payment of the \$30.67, balance due because of the error in calculating the amount of half pay, was not made until 31 May 1851, to William F. Pendleton, brother of George M. who presented it to the Pension office 8 April 1851. This had been in accordance with the Congressional Act of the 5th of July 1832, granting half pay to the Officers of the State Line until the time of their deaths.

Evidence of the names of the children of Katherine (Lipscomb) and George M. Pendleton has come from different sources, and this is, at least, a rartial list of their children--

JOHN POWELL LIPSCOMB, son of Capt. Lt. Yancey and Elizabeth (Powell) Lipscomb, was born "ca. 1805" (he was listed as aged 45 in 1850 Census) -- so, someone fudged on ages -- if his sister (next), Eleanor Lipscomb, was also born in 1805 --- unless they were twins? The date of his death has not yet been found.

He went to Alabama, perhaps at the same time as his brother Daniel (p.384)a-long with the new-land seekers. On 22 Oct. 1827, Greene Co..Ala., he married Ann Whitsitt, daughter of Wm. Whitsitt, at which time he was listed as "over 21, and she over 18".

John Powell Lipscomb early became a Justice of the Peace in Greene Co., serving several years during 1827 through 1841, and many of the marriages performed in the County records, there, were performed by him.

His 1840 Census record, Greene Co., Ala., p. 103, shows , line 11, -- 2 20-30 (who?)

"J. Powell Lipscomb: males 3 under 5; 1 5-10; 1 30-40 many slaves females 1 under 5; 1 5-10; 1 10-15; 1 20-30

He was a young lad when his father died in 1813. and had left his home state to venture into new areas, with his brother almost ten years older, to make

a new start for a successful future, in Alabama which had become a State on 14 Dec. 1819. Other Lipscombs, descendants of the ones who had gone to the Carolinas soon after the Revolutionary War, were in that part of Alabama, and, it is to be wondered if they were in close touch with each other.

Having a number of slaves, it is supposed that both John Powell Lipscomb and his brother Daniel, perhaps, were planters.

ROLAND GREEN, b. Aug. 21, 1824, Richmond; d. Nov. 20, 1885. A Mt. Vernon, Texas. In 1830, George W. Green took his small son, Roland, and went with relatives bound for Alabama. He decided to settle in Pulaski, Tenn. and build River Boats. He married 2d a Miss Moore. In 1838, young Roland felt he had received unjust punishment at the hands of his stepmother because of a watermelon. He decided to run away from home. He secreted himself in the wagon train of a young honeymoon couple on their way to the Republic of Texas. They must have been surprised to find themselves the parents of a thirteen-year-old son, but they made him welcome and he made his home with them until his marriage in 1850 to the niece of his benefactor. Bad roads, because of heavy rains, forced the Texas-bound settlers to stay in Mississippi with relatives. They reached the settlement on Boggy Bayou near the present town of Daingerfield, Jan. 1, 1841. In 1850, they went farther westward to Lone Star, now Mount Vernon, Texas. In 1860 when his father died, Dr. Green returned to Tennessee to help settle the estate. He freed the slaves he received and started home with his fine saddle, saddle horse, and a sizable amount of money. He stopped at a Louisiana Plantation and found there another traveler. The two seemed to have a friendly interest in religion, one of Dr. Green's great interests. The plantation owner put them in the same room and the next morning Dr. Green awoke to find his new-found "friend" gone and with him the doctor's horse and saddle and money!

Dr. Green had a successful practice in Mt. Vernon for more than thirty years and never lost a patient in childbirth. He married March, 1850, Sarah Frances Holbrooke, b. 1834 in Pulaski, Tenn.; d. 1885 Mt. Vernon, Texas. They had ten children. See Census Records of Franklin County, Texas, 1850, 1860, 1880, and Records of Franklin County.

DANIEL LIPSCOMB (II), son of Daniel and Keziah (Yancey?) Lipscomb, was born ca. 1759 (if ae.53 in 1812), King William County. He married, ca. 1780 (?) Jane \_\_\_\_\_. He died ca. 1829, King William County (at which time the 500 acres he had deeded, but had kept life tenancy, - to his son, Temple, was turned over to Temple).

Since earlier records are missing, the first record we have of Daniel (II) is the 1782 Land Tax where he is listed with 240 acres, next name after his mother, Keziah Lipscomb, with her 306 acres. By 1789 Tax Alterations --

"Heir- Daniel Lipscomb 306 acres 7/4 - of Keziah Lipscomb"

Since she is no longer listed in K. Wm. Tax records, it is assumed that she had died. It is hard to determine why her land went to Daniel, - unless he may have been the eldest of the three sons. The other two sons. Yancey and Anderson, apparently did not inherit. Daniel I, the father had died when Daniel II was possibly around 21 years of age, and perhaps the father had given him the first 240 acres, by deed or will. It was perhaps in the area, just west of the original Lipscomb Land Patents, and where young Daniel later built up a large tract. (Could there be any connection between this 240 acre tract, and the 240 acres listed 1788 Alterations - "Heir- Thomas Lipscomb 240 acres 8/3 - of James Lipscomb C. "?-possibly not, since the value of the land was different (see p. 34), but that land was perhaps in the near vicinity)

By 1793, Daniel (II) had added 409 acres from Frances Quarles, being taxed that year for 955 acres 7/3. Adding 20 Feb. 1807 (K. Mm. B. 5 p. 83) 26 acres. in line of the estate of John P. Lipscomb, dec'd, to a corner on the Public Road, and May 1809 (K. Wm. B. 5 p. 368) 2663 acres on Acquinton Swamp, both deeds from Wilson C. Pemberton and Welthea, his wife, he had increased his holdings to 1237 acres, 7/3, through 1822.

23 Apr. 1817 (K. Wm. B. 7 pt. 1 p. 85), Daniel and Jane Lipscomb deeded to their son, Tample, - but kept life tenancy on it, -- 500 acres, where they then lived, and including the "land called and known by the name of Pembertons", bounded by the road leading from Putney Ferry to King Will am Courthouse, by land of Wm. Hill, Hardin Littlepage, Wm. Ellett and Levina Allen. The deed was witnessed by Ro: Hill, Sr., Wm. Hill and Thos. Hill. The marginal note in the Court record indicates that it was acted upon in M rch 1830, thus setting a death date for Daniel (II) and probably his wife, Jane, for-by or before 1829.

In 1824, 450 acres had gone to his son, John A., and the 1829 Tax shows that 370 acres had been deeded to his son, Austin. All this land was around one mile south of the Court House, and it adjoined, partially, Acquinton Creek. "Green Level", the portion inherited by Temple Lipscomb is on the north side of road 621, just west of "Springfield", the Hill land which begins at the Lanesville road 633.

Daniel Lipscomb (II) was apparently a very successful tobacco planter, having, during most of the time usually 19 slaves, and, part of the time, a chair (a carriage) listed on his Personal Property bax.

On 9 Apr. 1798, Daniel Lipscomb signed a receipt to his brother, Yancey Lipscomb for \$1,000., his portion of his inheritance from their father, Daniel Lipscomb (I). (K. Wm.B.4 p.291) (See p. 372)

In 1812, the list of volunteers of King William County, in case of necessity for the impending War between the United States and the United Kingdom of Great Britain, includes the name of Daniel Lipscomb, age 53. A Daniel, age 53. could be only this Daniel, son of Daniel & Keziah.

No records of any kind, so far found, can indicate any Revolutionary War service, nor any Public Service. Unfortunatley, - with so many Daniel Lipscombs to untangle, - many have been misled to conclude that he was the Lt. Daniel Lipscomb of Revolutionary War record (see p.367). That Lt. Daniel Lipscomb was a son of George Lipscomb, (thus probably a first cousin), who was killed in 1781, without having any family.

Another error accepted by many has been the assumption that he was the Daniel who married 1792 (by special marriage agreement) Jane Frazer, widow of John Frazer, who was, in reality, the son of George Major Lipscomb (see p.105)

The names of the children of Daniel and Jane Lipscomb (her surname unknown) are listed in "Old King William County Homes and Families" - Clarke, p. 80. (the names of Elizabeth and Malinda have been doubted, thinking that they were the daughters of his brother, Anderson, -- but, perhaps Daniel and Jane did have daughters by the same names), ---

403 ELIZABETH LIPSCOMB , Daughter of Daniel and Jane (p.403)

ELIZABETH LIPSCOMB, if she was, as is listed in Clarke's "Old King William Homes and Families" p. 80, a daughter of Daniel and Jane Lipscomb, she was born, according to that data, 7 Dec. 1782, - probably their first child.

This material on her descendants has been sent in by Dr. R. Gregory Magruder P.O.Box 55, Charlottesville, Va., 22902, gathered from many sources, see list at end.

ELIZABETH LIPSCOMB, born 7 Dec. 1782, King William Co., married Ottoman Slaughter (1776/7 - 10 June 1858, buried at "Springfield", land adjoining "Green Level". Daniel's Land). Elizabeth's death date is not known, but after her death, Ottoman Slaughter married (2) Judith Edwards (1790-1847), Clarke says there was no issue from this second marriage.

Elizabeth and Ottoman Slaughter had two daughters, --

404 JOHN A. LIPSCOMB, Son of Daniel and Jane (p. 403)

JOHN A. LIPSCOMB, son of Daniel and Jane Lipscomb, was born, according to Clarke p.80, 9 Apr.1786. Little is known of him. He may have married, ca. 1819, Judith Lipscomb, daughter of Reuben and Ann Lipscomb (p.70) but that remains to be proved.

His tax listing is somewhat involved, but brief. His first Land Tax, 1822 and 1823 was for 10 acres. "this from Daniel Lipscomb by deed from Wm. P. Claiborne". This must have been the 10 acres deeded to Wm. Claiborne for \$300.00, 27 Mar.1816 by Daniel and Jane Lipscomb, "a corner on Main Road from West Point to Court House". (K. Wm.B.6 p.485), and deeded, then, in 1817 to John A. Lipscomb, by Wm. Pressley Claiborne.

The 1824 Tax listing indicates that he had died, showing 460 acres "est.", noted as "450 acres of this from Dan! Lipscomb by deed", no doubt his allowance as inheritance. Following tax records do not indicate that his widow retained the land, - but perhaps she remarried? The land did not remain on the Tax lists in her name, as a Lipscomb.

NOTE: Please refer to p. 417-8 for further information, in an Addendum.

405 STERLING LIPSCOMB, Son of Daniel and Jane(p.403)

405 STERLING LIPSCOME, son of Daniel and Jane Lipscomb, was born, according to Clarke p.80-81, 1 Mar.1788, King William County. He married three times, - (1) Elizabeth Ammon Johnson, of Old Town (dau. of Christopher and Elizabeth Y. Johnson?), 4 children; (2) Mary DeFarges, no issue, but that is

to be questioned; (3) 7 Dec.1837, Louise Hart (b.1816, -"widow of Austin Baughan," 7 children -- Clarke. He died at "Sweet Hall," 8 Dec. 1867 (on tombstone, 19 Dec.1867, Bible record, in the 70th year of his age. ("Religious Herald", Baptist, 13 Feb.1868). His tombstone is in the burial plot at "Sweet Hall" overlooking the Pamunkey River.

"Sweet Hall" had been built around 1720 on old Claiborne land, by Thomas Claiborne (1680-1732), husband of Anne, daughter of Henry and Anne(West) Fox. (this couple buried in the burial ground at "Sweet Hall"). "Sweet Hall" is on the north bank of Pamunkey River, a few miles east of the mouth of the Cohoke Creek. The home is still in good repair today, and is occupied by pleasant owners.

From Thomas Claiborne, the land went to his son, Nathaniel Claiborne, who died in 1756, leaving the land to his son, Thomas Claiborne. Robert Ruffin acquired "Sweet Hall", and it passed on to his son, James Ruffin and his wife, Mary who, both died before 1815. Their son, James and Agnes, his wife, then, sold 4 Dec. 1815, to Wm. George Vidal of King and Queen Co. 580 acres "by the name of "Sweet Hall".

After a short time at "Sweet Hall", Wm. George Vidal "died by his own hand", and his widow remarried. The plantation was then sold to Capt. Sterling Lipscomb of King William Co. ("Old New Kent" p. 598-601) - Dr. Malcolm H. Harris. The land was apparently divided, because, beginning 1816, and through at least 1829, Sterling Lipscomb was taxed for 290 acres, 12 miles S.E., 12/, adjoining Pamunkey River, and in the later years, - "Wm. Ruffin & Francis W. Richeson's est."

The origin of the caption "Capt." is not known. Did he serve in the War of 1812?

### 406 AUSTIN LIPSCOMB, Son of Daniel and Jane (p. 403)

AUSTIN LIPSCOMB, son of Daniel and Jane Lipscomb, was born, according to Clarke, 10 Apr.1790, King William County. He married, as her second husband, Mildred, the daughter of Capt. Bernard Lipscomb. The date of their deaths is not known, but, though they are both indicated in the 1840 Census records, they do not show in 1850, so must have died between those dates.

Clarke indicates )p.81) that they lived at "Rosegarden" and Gwathmey states that Austin Lipscomb built the original home at "Green Level" ("Twelve Virginia Counties" 1937, p.77) -- but these staements have not been confirmed.

Mildred's first husband, as is explained (p. 358) was supposedly Wm. Clone, but since this cannot be confirmed, and since there are many records for a Wm. F. Olonne who had land in the vicinity of "Rosegarden", and his tax listing showed that he had died by 1814, it may be assumed that this was her first husband's name. Especially so, since in the 1819 tax, Austin's name is shown along with "Wm. F. Olonne, est". Perhaps they were married at that time.

As did his brother, Temple, so did Austin Lipscomb receive at the time of their father's death, 1829 Taxes, — Austin's being 370 acres, adjacent Temple, 1 mile S. of the Court House, which, added to 311 acres, 7 miles East, from George W. Quarles, made his taxable land, 681 acres.

The 1820, 1830 and 1840 Census records, King William Co. are shown p. 358

Lines, -the descendants of Austin and Mildred Lipscomb, have been gleaned from the book "THE WILLIAMS of UPSHOT in VIRGINIA- 1613-1976" p. 340-343, by the Very Reverend J. L. B. Williams, whose ancestry goes back through this line, through Capt. Bernard and through Daniel, -- also, through John Pemberton Lipscomb. and Philip Lipscomb, in another branch.

This ends the available data on Austin and Mildred Lipscomb.

TEMPLE LIPSCOMB, son of Daniel and Jane Lipscomb, was born, according to Clarke, in 1791, but the Family Bible (VSA) gives the date as 10 Apr.1792. He married, by 1818, Margaret Lipscomb (b. 23 Feb.,1797), the daughter of Reuben and Ann Lipscomb (p. 70) (Bible record). Margaret's father, Reuben, had died when she was only about 3 or 4 years old, and she was evidently raised as Margaret Brett, since her mother married, for the second time, John Brett, soon after the death of her first husband. This entangled later records somewhat, since many have thought that Temple's wife was Margaret Brett.

Daniel and Jane had deeded to their son, Temple, 23 Apr.1817 (K.Wm.B.7 pt.1 p.85) 500 acres, apparently "Green Level", but they kept life tenancy for themselves. Perhaps this was at the time of Temple's marriage to Margaret? And, it is quite possible that Temple and Margaret lived there with his parents. The marginal note in the Clerk's book, indicates that this deed had been validated in March 1830. Temple's Land Tax record, 1829 showed that he had assumed title, and paid taxes on 500 acres, "on the Acquinton, adj. Austin Lipscomb, 1 mile S. of the Court House... this from Daniel Lipscomb, est., by deed".

Temple Lipscomb wrote his will 23 Feb.1835. He died (Bible record, VSA) on 6 Sept.1835, and his will was probated 26 Oct.1835. Temple divided his land equally between his wife, Margaret, and his children. His mother-in-law, Ann (Lipscomb) Brett, had lived with them, and she was to remain in the home with her daughter, Margaret (his widow). It is interesting to note that, in the late 1960s, the portraits of Margaret and of her mother were still hanging over the mantlepiece in the living room of the then-empty "Green Level" home. Temple named his "friend and brother-in-law, Hutson Brett" as Executor. (Hutson Brett was the son of Ann, by her second marriage).

The tangled history of "Green Level" began when Margaret (the widow) married for her second husband, 21 Dec. 1837 (Bible record), Ambrose White, and they continued to live at "Green Level", having one child, James A. White, born 28 Dec. 1839 (Bible record), who married (1) Harriet Claiborne Hill and had 4 children, married (2) Gay Taliaferro Hoskins of Essex Co. and had 4 more children.

After James A. White's death, Gay Taliaferro (Hoskins) White married (2) James Burnet Hill. They continued to live at "Green Level" and had two children who inherited "Green Level". Thus, it had gone "out of the family", entirely.

Meantime, in 1847, Ambrose White had exchanged land he had acquired in 1841, called "Huntsville" for the portion of "Green Level" then owned by the son, Preston. Preston was the only surviving child of Temple and Margaret, at that time, hence Ambrose White had secured the whole of the land, along with Margaret's portion.

Temple and Margaret apparently had no daughters, and the only Census record for Temple is King William, 1830 p.72, line 24,--

The story of "Huntsville and the continuing history of Preston Lipscomb's family have been supplied by Marion Edythe Timberlake Yobs;\*\*
(Mrs. Robert O.), 9201 Lyndonway Dr., Richmond, Va. 23229. Condensed, it runs. as follows. -- (For her listing, see p. 413)

Three daughters were born to Preston and Mary Ann Lipscomb, - Mary Corbin Lipscomb, 1857, Margaret Temple Lipscomb, 1858 and Nannie Thomas Lipscomb, 1864.

"Huntsville" was about 7 miles west of West Point, on the Main Road, now on present County route 625, a typical Williamsburg style home, with dormer windows, wide pegged floors and fireplaces. It has been neglected by later owners, and has since burned.

Preston divided the land into three portions for his three daughters and their families, and built homes for them, --

- MARY CORBIN (called "Corbin") LIPSCOMB, b.1 Jan.1857, at Huntsville; married 29 Nov.1877, Francis Eugene Martin, who
  died at age 40, at "Pine Grove" (Bible record), son of

# ADDENDUM on possible lineage of JOHN A. LIPSCOMB (#404,p. 406) Son of Daniel and Jane Lipscomb (p. 403)

Recent correspondence from Mrs. Martha Rasbury, 300 Floyd St., Hohenwald, TN 38462, sets forth several clues pointing to possible descendants of John A. Lipscomb. This all bears further investigation, of course.

From her family records, she gives names of her grandfather and grandmother as --

Sterling Brett Lipscomb, b. 9 Jan. 1823, VA, - d. 5 July 1907. Angelina Ellett, b. 30 Aug. 1824, VA, - d. 20 Feb. 1897.

and, saying that they "had 10 children, all born VA, one mile from King William Co. Court House", and gives names of nine of the children, including her father. She was under the impression that Sterling Brett Lipscomb's mother was a BRETT.

Thereby hangs the clue! Couldn't she have been the Judith Lipscomb, daughter of Reuben and Ann (Lipscomb) Lipscomb (p. 69) as indicated (p. 404)?

Judith, b. 1801, about the time of her father's death, was reared by her mother, Ann, who married ca. 1804, (2), John Brett, and quite probably even as a "Brett", along with Hutson (Hudson) Brett, b. 1807 to the new couple.

(This is all explained, (p. 70-72) in the complicated story of Judith's sister, Margaret Lipscomb "Brett" who married Temple Lipscomb, brother of John A.)

Martha Rasbury's father had spoken of a cousin, "Huddy Brett".

So, if Judith Lipscomb "Brett" married John A. Lipscomb ca. 1816-1822, they could very well (before his apparent death,-from Tax records,-ca. 1824) have had a son, b. 9 Jan. 1823, named Sterling Brett Lipscomb, named for John's brother, Sterling, and for her step-father.

The 1850 Census record for Sterling B. Lipscomb had been a puzzle, since he did not fit into the family of Sterling Lipscomb, his uncle, or into any other family. --

So, fitting Martha Rasbury's family story together with the 1850 Census, we can "assume" this possible outline, down through at least the one son, John Floyd Lipscomb, her father, son of Sterling Brett Lipscomb, --

ANDERSON LIPSCOMB, son of Daniel and Keziah Lipscomb (and brother of Yancey Lipscomb and Daniel Lipscomb, husband of Jane \_\_) could have been born in the 1750s or 60s. He died between 1798 and 1800. The name of his wife, as well as the date and place of marriage are unknown.

There have been problems in untangling the various Anderson Lipscombs. His uncle Anderson (brother of Daniel, his father) had died before 1785 leaving sons, Capt. Bernard, etc.. A later Anderson, son of Colonel Lipscomb in Buckingham Co., was on 1810 Census, and went to the southern states. Another Anderson, born 1786 in Va. (probably, Frederick Co.) went to Campbell Co., Ky. ca. 1800.

Anderson Lipscomb, son of John Lipscomb (will 1776) inherited 150 acres"Hunts" and he also died ca. 1800. His tax continues on through 1817 as
"Est.", adj. his brother Reuben's Est. 4 mi. So.. So, this leaves Anderson, the son of Daniel and Keziah as the only one left to have received 600
acres, 7/4, from Roger Lipscomb's Estate, on the 1791 Tax Alterations. It
does not say "heir", so he must have purchased the land. It had been, since
1782, taxed under the name of Elizabeth Lipscomb (who was the widow of Roger
Lipscomb). (p.134)

He was taxed on this 600 acres 1793 through 1799, then marked "Est." 1800, through 1803, all as Anderson, Sr. to distinguish him from the Anderson, son of John, who was younger. Complete disposition of that 600 acres has not yet been determined, - but it is almost obvious that 367 acres, 7/4, was received by his daughter, Malinda Lipscomb, whose name is shown, for that acreage, along with the name of her guardian, Yancey Lipscomb in 1804 and 1805 taxes. After that, ----? A nice research problem!

Now, another earlier aspect of Anderson Lipscomb, son of Daniel and Keziah. Was he lured south for 'greener pastures"? But, later returned to King William County? The 1790 North Carolina Census shows Anderson Lipscomb, of Va., in Fayette District, Richmond Co., with 6 slaves. And, did he later die therebecause 6 Oct. 1804 (K.Wm.B.4 p.195) records that Yancey Lipscomb, administrator of Anderson Lipscomb Sr., King William County, deceased in the state of North Carolina, Richmond, Co., appointed Christopher Johnson and James Lipscomb, Jr. as distributees and guardians of Anderson Lipscomb's legatee, Melinda. (Their subsequent taxes do not reflect any indication of Melinda's land holdings). (Incidentally, a North Carolina record shows a Samuel Lipscomb taxed in 1784-7, same County, as being either under 21 or over 60 years of age. Could this have been a connecting clue? Or, even a mistaken name, instead of Anderson?) (See State Census of North Carolina, 1784-7 Register '73')

That same year, 23 Oct.1804, Yancey recorded the two receipts from his brothers, Daniel and Anderson Lipscomb (K. Wm. B.4 p.291) for \$1,000 each, from their fathers' estate. (It is understandable that the date given on Andersons, as 9th April 1804 was an error, and should have been 9 Apr. 1798, as on the receipt from Daniel.) (See p. 390)

It is quite evident that Anderson Lipscomb did have the one daughter, Melinda. No further record of her has been found, however. Then, did he also have a daughter, Elizabeth Y. Lipscomb, — who became the wife of Christopher Johnson before the appointment of Christopher Johnson as one of the guardians of Melinda? Elizabeth Hawes Ryland strongly suspected such, and did a lot of research trying to prove that the "Y." in her name was for "Yancey".

The Tax listings of Christopher Johnson have been carefully studied, to see if he accuired the remaining 233 acres from the original 600 acres, after Melinda's 367 acres had been taken off. Christopher Johnson did begin paying Land tax 1804 on 765 acres, 7/3, and on through 1807. In 1808 (K. WM.B.5 p. 194). 12 March, Christopher Johnson and his wife, Elizabeth Y. Johnson. exchanged lands he had obtained by his wife, with Wm. D. Chamberlayne for 305 acres he had obtained from his father, - land on Mattapony River. But, no further proof of Christopher Johnson's land, or amount of land, for this exchange has been found. Perhaps it WAS land she had inherited from Anderson, 233 acres or so. Even following Wm. D. Chamberlayne's subsequent taxes has not produced a solution. Will someone please go further?

And, finding that the "Y" stands for Yancey (what else?) would be a tremendous help for descendants of Christopher and Elizabeth Y. Johnson, -- such as Elizabeth Hawes Ryland, who is now deceased.

Of course, the duplication of the names, Malinda and Elizabeth as also daughters of Daniel and Jane Lipscomb (p.404) does create a problem, but it could be possible that brothers did have two daughters with the same names.

And, so, shall we consider that Anderson Lipscomb (wife unknown) had possibly two daughters, --

ELIZABETH Y. LIPSCOMB, daughter, possibly, of Anderson Lipscomb, born possibly ca. 1782-5, was possibly the one who married Christopher Johnson ca. 1804. In "Hawes Family of Caroline Co.. Va." Elizabeth Hawes Ryland says --

"Christopher Johnson was sheriff of King William Co. for many years...
He died Dec.13,1832 in the 53rd year of his age.. Richmond Enquirer...
owning nearly 4,000 acres of land in the County, including.."Lestor Manor! "Old Town" and several contiguous tracts. ... was son of James Johnson, Jr. (dec'd 1826) and his wife, Lucy Ammon. ..."

MARY LIPSCOMB, one of the puzzles! The few theories have placed her in this branch, somehow. The only record actually applying to her personally is from the "Douglas Register"— the now published register kept by Rev. Wm. Douglas, the protestant minister who kept such remarkable records of baptisms, funerals, etc. in the Goochland area in the late 1700s. The entry (p.231 of the published book) shows,—

John King and Mary-Meak (Marimi?) Lipscum, a daughter named Nunie, born Oct. 2, 1769, Baptised Mar. 2, 1770. (p.87, his register) So, Mary could have been born ca. 1745-8, and married ca. 1764.

King is a King William County name. Probably John King took his young bride to the newer area of Goochland Co., second County S.W. of King William.

Copies of the puzzling Goochland County land transactions have been secured from the County Clerk, especially Deed B.9 p.87 in which Daniel and Kezie Lipscomb of St. Johns Parish, K. Wm. Co., deeded to John King of Goochland, 16 Mar. 1767, for £240, 294 acres in Hanover and Goochland counties, adj. James Cock, Major Powers, Wm. Powers and Henry Adkins (land which Daniel had obtained "by way of a swap" from Wm. Neaves).

20 Mar. 1769 (B.9 p.191) John King, Southam Parish, Goochland Co. and his wife, Marimi (as written several times in the document by the Clerk) deeded to James Lipscomb 150 acres, for L90, adj. Major Powers and Henry Atkins. (Many further transactions followed, -- (See p. 138).) (See p.422)

But, this is the main portion of what has been gathered in information about Mary, or Marimi Lipscomb, supposed daughter of Daniel and Keziah Lipscomb. Perhaps she had more children, but the only ones we know of, are,--

# Continuing - The SONS of JOHN and DINAH (MACKGEHEE) LIPSCOMB (p. 21)

### 19 JOHN LIPSCOMB, Son of John and Dinah (p. 21)

JOHN LIPSCOME, son of John and Dinah (MackGehee) Lipscomb, was born probably ca. 1724-1728 (?). He must have married about 1748, King William County, Ann Madison, probably daughter of Thos. P. (Pemberton?) Madison. Her relationship in the Madison family has not been determined, but she may have been closely related to the Mary Madison, wife of Philip Lipscomb (see p.55). After John's death in 1776/7, and, in 1785, when her children were all grown, she married (2) George Lipscomb, who is thought to have been brother of her husband, John. (see p.365).

Most of what we know about this John Lipscomb is garnered from 1. His wife's records, and 2. from the copy of his will, dated 5 Dec. 1776, which was fortunately preserved by a descendant of John Quarles, one of the witnesses, and quoted by Mrs. Herbert Lipscomb, Richmond, Va. in 10W(2)183-5. (Also, possibly on file at VSA,-Accessions #20009). The lack of information about John Lipscomb is no doubt due to the fact that records from his time were destroyed in the Court House fire of 1885.

#### Ann's records include --

- Public Service during the Revolutionary War -- King William Co. Court Booklet 4; List I 7; Commission Book III 249.

  List I p.7 seems to list 20 Sept. 1783(?) to Ann Lipscomb for (and the item is crossed out), but indicates payment of 1335
- 1782- Ann Lipscomb Personal Property Tax- 1 titheable; 11 slaves; 5 horses; 9 cattle; 2 wheels
- 1782-3 Ann Lipscomb Land Tax: 387 acres 10/ in 1782, 9/2 in 1783.
- By 1785, her children were grown, apparently, and she was "released" from the requirement in her husband's will- that she support and maintain her children".. until they become of age of 18 years. She began portioning out lands -- Alterations, 1785-
  Deed-John Lipscomb, Son of Ann, -of T.P. Madison(her father)107 A "Madison Lipscomb of Ann Lipscomb 187" Pemberton Lipscomb -of T.P. Madison 125
- 1785, 16 Sept. (K.Wm.B.IIp.63-68) Ann Lipscomb signed a special marriage agreement with George Lipscomb (brother of her first husband, John) by which she would retain her rights to properties already her own. See p. 365 for further details. \*(or 221.or 227?)

John Lipscomb dated his will 5 Dec. 1776 - "being in a weak & low state of life, but of sound mind and memory". It was probated at King William Co. May Court ,1777. He appointed his wife as Executrix and his friend Richard Taylor, his brother Daniel Lipscomb, and his sons Pemberton and John, Executors. Witnesses were John Quarles. Thomas Chamberlain, Jr., Thomas King and Edward Pye Chamberlain.

In his will, he provided generously for his heirs, -

To his wife, Ann, - he lent, in lieu of her dower, during her widowhood-All the tract of land where he then lived, with those he had purchased "of Daniel Lipscomb & William Neaves (Goochland) containing ... 537 acres... negroes. Dingo, Judy, Ellsy & Moll, all stock except that given to each of the children, all house and kitchen furniture, crops; and that she was, from estate, to support and maintain the children until they become eighteen years of age when they were to receive their "fortune". This was for all except Henry who was to be bound out to Mr. Philip Lipscomb, Jr. until aged twenty one.

Each of the children was to receive at least two negroes, a cow and calf, a ewe and lamb. and horses, plus usually a bed and furniture. In addition to these, they were to receive, individually --

Pemberton, -- 1200

John. -- 1200

Elizabeth, -- a sealed skin trunk marked E.L.

Ann, -- a sealed skin trunk

Henry. -- 1200

Madison, -- Tract of land he had bought from his brother. Daniel Lipscomb. - 125 acres, - also that he was to "be bound out after he
get such schoolin as my executors hereafter shall think necessary
to Mr. Frank Graves until he shall arrive to the age of eighteen
years".

Martha, -- 125

Reuben, -- "my home house, tract of land containing two hundred acres".

Anderson, -- "tract of land called "Hunts" containing one hundred & fifty acres which I purchased of William Neves"

Patsy, -- apparently nothing extra.

Another provision was "that if my wife lives a widow until my three youngest sons arrive at the age to demand the land given them" that then my wife shall have a third part of each tract of land together with the use of my dwelling house during her natural life, & at her death all the estate lent to her was to be sold, and the money divided equally among the heirs.

From this will, we have the names of the children of John and Ann (P.) Lipscomb possibly all born after 1758, if they were all under 18 in 1776. --

PEMBERTON LIPSCOMB was, very probably, the eldest of the children of John and Ann (Madison) Lipscomb, since he was first named in his will.

And, he was evidently named for Ann's father, Thomas Pemberton Madison. He is not to be confused with the older Pemberton Lipscomb (p. 469)

His land, -- 125 acres, - received from T. P. Madison on the 1785 Tax Alterations show, valued at 9/2, through 1795, and then is listed under his widow's name, - Lucy Lipscomb through 1812. It is then listed as Lucy Lipscomb "Est." through 1818, 2 mi. E. of C.H.

A document (K. Wm.B 6 p.107) 24 Feb.1812 deals with a matter of slaves, and lists the heirs of Pemberton Lipscomb as, -- John Lipscomb, Wm. B Lipscomb, Beverly Lipscomb, and John Quarles and Johnson Eubank, husbands of two daughters. Lucy's obituary was given in the Richmond Enquirer, 20 Aug.1811.

# 426 JOHN LIPSCOMB, Son of Pemberton and Lucy (Above)

JOHN LIPSCOMB, son of Pemberton and Lucy Lipscomb would have been born probably ca. 1780 or before. He and his brother left King William Co. to go to Richmond, Va. and, from there, John and Wm. B. Lipscomb paid tax in King William Co. for 135 acres. adj. Lucy Lipscomb's "Est." 1814-15. 1816 thru 1818, for 65 acres, which they deeded in 1819 to Beverly, their brother.

Further data cannot be found. No John Lipscomb is indicated on Census indices for 1830-40-or 50. Could be have married Harriet Lipscomb, daughter of Capt. Bernard Lipscomb (See p. 356)?

# 427 WILLIAM B. LIPSCOMB. Son of Pemberton and Lucy (Above)

WILLIAM B. LIPSCOMB, son of Pemberton and Lucy Lipscomb, was born probably ca. 1782-85 in King William County. He married Ann Johnson, (25 Dec.1781-25 Sept.1819), daughter of James and Lucy Johnson of King William County. She died 25 Dept.1819 and is buried at "Oldtown" beside their son, Jack, who died just a few days after her death.

Wm. B Lipscomb married (2) Elizabeth Meredith (b. 1799), according to a record in "County Court Notebook" Vol.2 p.12(4) (Apr.1923) under "Occasional", "From an old family burial-place, King William County Court House, Va.--"Elizabeth, consort of Wm.B. Lipscomb, daughter of Samuel and Elizabeth Meredith, born ..1799; died .. 1839, leaving a husband and 3 sons'".

This is difficult to reconcile with the Census record of Henrico Co.,1830-p.286 --

Wm. B. Lipscomb: 2 males under 5; 2 5-10; 3 15-20; 2 20-30; 1 40-50 1 female 15-20; 1 20-30; 1 30-40. (several slaves)

(perhaps part of these were from the family of his brother, John.)

The 1850 Census record, Henrico Co., for Wm. B. Lipscomb is even more difficult to understand, -- p. 527 (Western District) line 32,--

So, as of the present, it is impossible to list the children of Wm. B. Lips-comb and his first and second wife, except for the one son, Jack. who died.

427-A JACK LIPSCOMB, b. ; died young, Sept. 1819

BEVERLY LIPSCOMB, Son of Pemberton and Lucy (p.425)

BEVERLY LIPSCOMB, son of Pemberton and Lucy Lipscomb, would have been born in the early 1790s. He married ca. 1810 (?) Mary Watkins, daughter of Wm. Watkins and his wife. Susanna Lipscomb (daughter of Ambrose Lipscomb U.H. - see p. 453)

In 1817, King William Co., there was litigation regarding the division of land (which had been conveyed for the use of Susannah Watkins-Mary's mother). This mentioned the names of the heirs of Susannah Watkins. which included "Edwin Lipscomb. infant child of Beverly B. Lipscomb and Mary, his wife, who was Mary Watkins". Since it did name the other daughters of Susannah, by name, it is evident that Mary had died, and apparently Edwin was the only child. (2LV-393)

The above record does not tally, however, with the 1820 King William County Census. p 312, which shows more children, but, of course, Beverly Lipscomb could have married again, meantime.

The 1820 Census -- p. 312, King William Co. --

Beverly Lipscomb: 2 males under 10; 1 16-26; 1 26-45 1 female under 10; 1 16-26

In 1818, (K.Wm.B.7 pt.2 p.347). a deed indicates that Beverly B. Lipscomb and Marv, his wife. of City of Richmond, sold to Richard King for \$500.00 a tract of land. The document is very much mutilated, but it could indicate that it may have been land inherited from John F. King, 1/6 part of land...(?) Could it be possible that he may have married (2) a Mary (another Mary) King and that this was her inheritance that they were selling? And, that they had more children? The male 16-26, in 1820, is a puzzle.

Beverly Lipscomb is included first, in 1819, on King William County Land Tax Rolls--

Beverly B. Lipscomb: Res. Rich'd., fee 266 acres, adj. John C. Pollard and (Wm. White)

John Smith dec'd., 2 miles N.E., value \$6.50, "76 acres (1819 only)

from John Whitworth, 125 acres from Lucy Lipscomb est., 65 acres from J. & Wm. B. Lipscomb, by deeds"

In 1821, his listing appeared as "Est.", so he had died at an early age.
The listing continued as "Beverly B. Lipscomb Est." on through at least 1829
-- the last date checked, as of K. Wm.Co.

So far, only the one child of Beverly B. and Mary (Watkins) Linscomb is of record. --

428-A EDWIN LIPSCOMB, no further records found

LIPSCOMB, a daughter of Pemberton and Lucy Lipscomb, married John Quarles. Research has not been made to determine her given name, but searching King William records could perhaps reveal her name—from possible deeds from John Quarles.

430 MARTHA (PATSY) LIPSCOMB. Daughter of Pemberton and Lucy (p. 425)

MARTHA LIPSCOMB, daughter of Pemberton and Lucy Lipscomb was born ca. 1790, according to the 1850 Census. She married Johnson Eubank, named Johnson Sellars Eubank in "For King or Country" Vol. I- Orange Co.

Calif. Genealogical Society, p.111, which give his parents as Wm. Eubank (1755-1829 - a Rev. War soldier who d. Ky.) and his wife Sally Tinsley. It cuotes, also, that Johnson Eubank and Patsy Lipscomb were married in 1810.

Ida Lee. (7W(2)142), abstracted that Johnson Eubank and Patsy, his wife of Richmond. deeded to Beverly Lipscomb, land of Pemberton Lipscomb and wife, Lucy, deceased, May 10. 1818. This may have been Patsy's portion of the inheritance.

The 1850 Census of Henrico County, p. 441 (B) line 6 gives a partial list of their children. ---

The last of the family of Pemberton Lipscomb, son of John & Ann (p. 423)

- JOHN LIPSCOMB, son of John and Ann(Madison) Lipscomb, has been an unusual research problem. A definite date of birth cannot be established due to conflicts.
  - If his father's will meant that ALL his children were under 18 in 1776, he'd have been born ca. 1761.
  - If his first tax, paid 1785 (300A) meant that he had become aged 21, he'd have been born ca. 1764.
  - If he is John Lipscomb, the 1812 Volunteer, aged 58, he'd have been born ca. 1754.
  - If he is Cpl. John Lipscomb (Rev. War) whose pension application of 1819 said he was aged 67, he'd have been born ca. 1752.(d.1824)

Records showno other contemporary John Lipscomb, except John, son of Nunn Lipscomb, and he was usually designated John N to distinguish him from John A or "Ann". John N's records are clear. He began taxes on his inherited land 1787, (234 acres), volunteered 1812, ac. 59, and died 1821. (p.462)

So, it is quite possible that all four of the above possiblities are this same John Lipscomb, with misinterpreted ages.

The name of his wife and date of marriage remain a puzzle. See later. He paid taxes on his land through 1824, and in 1825 his listing was marked Wohn Lipscomb (Gent.) Est.", so he died late 1824 or early 1825.

John Lipscomb/Ann/ was taxed 1785 and 1787 for 300 acres, 8/11. In the Alteration list of 1788, are two listings--

Deed John Lipscomb 187 (acres) 8/11 ... of Madison Lipscomb Exchange Madison Lipscomb 107 9/2 ... of John Lipscomb

Since the Land Tax lists are missing between 1787 and 1793, and we have only the Alterations lists, we cannot explain the disposition of John's 300 acres. (8/11), but in 1793, he began paying Land tax on 175 acres (perhaps resurveyed?), as John A. and continued on until 1824, though his designation was changed in 1817 to John "Gent", since a younger John A. (for Anderson) Lipscomb was being listed (son of Daniel and Jane Lipscomb).

This land continued to be listed as "John Lipscomb (Gent.) Est", beginning 1825 as 172 acres (-- 2 acres charged to Keziah Lipscomb) adj. Binion Slaughter and Reuben Lipscomb, est., on through 1833 (3 miles S.) 1835-39, it was reduced to 40 acres, and in 1841 Oscar D. Lipscomb, of Petersburg. Dinwiddie Co. began listing for 147 acres, adj. Reuben Lipscomb and Robert Hargrove, Jr. 3 miles S.E. with the notation "This from John Lipscomb est. by will". This land in near vicinity of the original John Lipscomb 1714 200A.grant.

The 1820 Census for King William County (1810 is lost) shows- for John Lips-comb, p.299

John Lipscomb, (Gent.) 1 male 26-45; 1 male over 45 1 female 10-16; 1 over 45

Could the male 26-45 have been Oscar D. Lipscomb, a son? No Census records can be found for him. For lack of better conclusion, let us consider him as son of John Lipscomb --

431 OSCAR D. LIPSCOMB, born ca. 1785-90 (if 26-45 in 1820) (?)

Now, the puzzle is this! Was John Lipscomb 4 or "Gent.", (son of John and Ann (Madison) Lipscomb) the same person as Corporal John Lipscomb of Revolutionary War records, who had married Elizabeth Lipscomb, 24 Dec. 1783. This would seem to be very probable (except for a few simple questions).

Corporal John Lipscomb, according to Pension records, died 28 Sept.1824, and John Lipscomb "Gent." died late 1824 (or early 1825). And, there were no other contemporary John Lipscombs in King William County, except John N. who has been accounted for.

Books on Virginia Soldiers -- Eckenrode, Wilson, Jillson, Brumbaugh, Gwathmey and Saffell all indicate that John Lipscomb enlisted 14 Feb.1778, engaged in the battle of Savannah, was discharged. 22 Dec.1780, after three years service as Corporal in Capt. John Bellefield's 1st Light Dragoons, under Col. Theodorick Bland and Col. Benj. Temple. Military slips at the National Archives confirm this, except that, for some reason, they list him as Pvt..

Two affadavits are on file at VSA -- (See p. 440)

"I do certify that Corporal John Lipscomb served three years in the first Reg't of Light Dragoons on Cont. establishment.

King Wm. County May 20 1783 Thomas Pemberton 1st Regt Light Dragoons"

"Please to deliver my Land Warrant to Capt. Thomas Pemberton for my allowance of Land as Corporal of Light Dragoons To Col? Mearaweather John Lipscomb" May 25,1783

This latter document may have been an assignment to Capt. Pemberton of the 200 acre Land Warrant --

"Land-Office Military Warrant, No.683" -- to John Lipscomb, 200 acres, due .. "in consideration of his services for three years as a Corporal of the Virginia Cavalry" ... dated 30 May 1783.

Care has been made to separate these records from those of John Lipscomb, of Louisa Co. (1761-1827)(son of William (1731-1810) and Elizabeth (Smith) Lipscomb) who went to South Carolina shortly after the War. His military records are scant, but he could possibly be the John Lipscomb referred to in Gwathmey p.477-8 as a Corporal in the Infantry. Gwathmey also includes Corporal John Lipscomb of the Light Dragoons (which is cavalry). Another single reference is to a John Lipscomb in the Artillery, at White Plains 1778.

In microfilmed Pension files W5323 JOHN LIPSCOMB under Elizabeth's (his widow) application, is described the application for his own pension (certificate 14785). This was made 27 May 1819 at Court Quarterly Session, King William County Court House, saying that he had enlisted in 1778 at King William in Company commanded by Bellefield, and was discharged 22 Dec. 1780 from Anson Courthouse, S.Car. having been in the Battle of Savannah. And, that he was "in reduced circumstances and stands in need of the assistance of his country for support".

His pension was granted, as to John Lipscomb of King William Co.. Va., Corporal, under Col. Temple, 3 years, -- \$8.00 per month, certificate of Pension issued 24 Sept. 1819, and sent (as requested) to John Mill, Esc., Lilly Point, K.Wm. City, Va.

Questions #1 and #2 -- Could it possible be that a man who owned 175 acres would be"in reduced circumstances"? Possibly after the land had been used

for over a hundred years without proper "rotation of crops". Or, it could have been just whatever other men were doing who had fought in the Revolutionary War. And, why did he have the certificate (and payments?) sent to Rev. John Mill? Was he perhaps in debt to him? (John Mill died ca. 1822).

John's Pension application was made under the Pension Act of 18 March 1818, and it was paid, with arrears, up to 4 Sept. 1824, the month in which he died. In 1819, he had given his age as 67, so, at the time of his death, he would have been 72. (See p. 441 and 442 for Bounty record & a letter)

Then, in accordance with the later provision, the Act of July 7, 1838, his widow. Elizabeth (Lipscomb) Lipscomb, applied for a widow's pension, the details of which are in the Military Archives Pension (Rev. War) microfilmed records, W5323, as mentioned above.

She gave her age, 1839, as 78 (born 1761), - the date of her application, - 25 Feb.1839. She had married John Lipscomb 24 Dec.1783 giving an affadavit to this effect. Her name, before marriage, was Elizabeth Lipscomb, daughter of Ambrose Lipscomb. (Next problem- which Ambrose - Ambrose Jessee, or Ambrose Lott?)

Her pension was granted, and, as she requested, - to be sent to R.B. Gaines, Ayletts Warehouse, Va. Including arrears, her allowance up to granting date, 4 Sept.1839, was \$420.00. Unfortunately, there is no indication as to the last payment - which would indicate date of her death.

Two Elizabeth Lipscombs, (widows), had shown on the 1830 King William County Census. One was very definitely the widow of Philip Lipscomb. The other must be the widow of John Lipscomb, and lists, p.78, line 19 --

This can easily be interpreted as, — Elizabeth, b. 1760-70 (she was b. 1761 estimated from her pension declaration), with the daughter who was 10-16 in the 1820 Census (b. 1804-1810) who could have married by 1830, showing as 20-30 (b. 1800-1810) and had become widowed, with 3 children b. 1815-1825. And, in this situation, — by 1839, Elizabeth could well have been in need of a pension! Even though probably still living on the 172½ acre tract listed as "John Lipscomb "Gent" Est." up through 1824, changing to 40 acres, 1835-1839. Her name is not included in the 1840 Census, so she must have died soon after her pension was granted,— or, she could have been living with someone else.

The name of her daughter has not been ascertained. Gaines family records have not, so far, revealed any connection by marriage, nor any clues.

So, Question #3 remains, -- Why were her payments to be sent to R.B. Gaines at Ayletts Warehouse (a P.O. address on the Mattaponi River in North western part of King William Co.)?

A mystery! We hope some descendants may come forth to help clear the problem.

417 <u>ELIZABETH LIPSCOMB</u>, Daughter of John and Ann (p. 423)

ELIZABETH LIPSCOMB, daughter of John and Ann (Madison) Lipscomb would have been born possibly in the 1760s. No records have been found except that she was living at the time of her father's will, 1776.

## 418 ANN LIPSCOMB, Daughter of John and Ann (p. 423)

ANN LIPSCOMB, daughter of John and Ann (Madison) Lipscomb. would also have been born, possibly in the 1760s. No further records.

# 419 HENRY LIPSCOMB, Son of John and Ann (p. 423)

HENRY LIPSCOME, son of John and Ann (Madison) Lipscomb, was under twenty-one when his father wrote his will, and his father asked that he be bound out to Philip Lipscomb. Jr. until that age. So, he must have been born after 1760 or thereabout.

His father must have been especially solicitous of his well-being since he wanted him to be bound out until age 21, when the others were to receive their legacies when 18. See p. 55 for the explanation re: Philip Lipscomb, "Jr.".

To untangle the many vague references of the many Henry Lipscombs cannot vet be accomplished satisfactorily. But, for this Henry Lipscomb, son of John, we might start with the Revolutionary War Pension files, which have a very brief report, -- (with no further papers in the file)

Henry Lipscomb, Private Virginia Line Bounty Land Warrant Record Card.

Warrant #12325 100 acres issued to Francis Graves. assignee May 11, 1792

The "Francis Graves" is the significant clue, here. Remember that Henry's next younger brother, Madison Lipscomb, was, according to their father's will, to be bound out, until the age of 18, to Mr. Frank Graves. If this is the same as Francis Graves, then, it is understandable that he was probably a family friend and counselor, after the death of their father. And, this might point to the fact that son, Henry had enlisted at an early age, as a private.

He is probably to be distinguished from the Henry Lipscomb, Fifer for the duration of the War, who received Bounty Land Warrant #1234 for 200 acres, (Jillson, #18on, etc.)

In fact, he could well be the Henry Lipscomb listed on the Chesterfield Supplement (VSA), p.11 --

ae.20, 5'll2", Planter: b.K.Mm.Co., Va.; residence, K. William; brown hair; Gray eyes; Inlisted 6 Sept.1780; for 1 year, 6 months and 2 weeks(?) And, oh, yes, Complexion-Fair.

Men from different Counties are on this Chesterfield list, and on this same

page, for instance, same date, is listed Harden Lipscomb, same age, also from King William County. (Harden, p. 509)

One record, VSA War 5,109, indicates that Henry Lipscomb, Sol. Inf. collected his own Balance of Pay. 8 May 1783, - 118-0-0.

But, what happened to him after the War- or, after the 1792 assignment of his Bounty Land to Francis Graves? His father's will had given him a sum of \$200, and no specific land legacy. (The will had given to the three older sons, - each \$200, and to the younger three, parcels of land).

The only records of a Henry Lipscomb, later, in King William County would seem to be the heir of James (T.) Lipscomb, who inherited land 1801, but disposed of it shortly (see p.139), and he apparently remained in the County paying only Personal Property Tax for a period of years, and, on the 1820 Census, p.296, and 1830, p. 72, listed only himself- no family.

"Hanover Henry" Lipscomb seemed to stay in place, and was probably born 1765-75. possibly son of Manoah Lipscomb. In addition, there are records of Henry Lipscombs (contemporary) in Orange County, Cumberland Co., and Chesterfield County. None of them have conclusive records of families.

So, unless other research turns up any descendants, we may have to conclude that this Henry may not have married and had a family. There is, of course, a record of a marriage in Caroline County Marriages 1782-1810 (Va. Hist. Soc. Quarterly 1972, p.86)

Henry C. Lipscomb married 8 Feb. 1804 Polly Dickerson, dau. of Thos. Further seaching has produced nothing helpful.

# 420 SALLY LIPSCOMB, Daughter of John and Ann (p.423)

SALLY LIPSCOMB, daughter of John and Ann (Madison) Lipscomb, would have been born probably in the 1760s. Nothing further is known of her except what is listed in her father's will of 1776, in which she received the usual negro, her £25, and "fether bed and furnature", plus a cow and calf, a ewe & lamb, (for each of his daughters).

However, a question has been lurking in the background! Could this Sally Lipscomb be the one who married William Elliott in 1786, King William Co.?

Fleet, Vol.XV,p.26 quotes the marriage bond, signed by William Elliott and Francis Graves (here is that family friend and couselor, again, (see above)) Dated 31 Jan.1786, it says, in part,--

"The condition of the above obligation is such whereas wm. Elliott hath this day obtained a license for his marriage to Sarah Lipscomb daughter of James Lipscomb, dec'd. ...."

The opening statement had been --

"Know all men by these presents that we William Elliott and Ann Lips-comb are held and firmly bound.... 50 pounds..."

Since no possible James Lipscomb, of record, had died leaving a daughter of marriageable age in 1786, isn't it possible that she may have been this Sally Lipscomb, daughter of John, and that the account might have been misread? In the marriage bond, it does not stipulate that Ann Lipscomb was actually her mother, but, since her father was deceased, it would be quite logical that Sally's mother, Ann, would have been named in the bond. And, that the friend of the family, Francis Graves, would have signed?

This was all brought out in the Pension record of Sally's husband, and her application for her widow's Pension, dated 21 Sept.1845, King William County, age 85 (b. 1760) stating that she was married to Wm. Elliott 15 Feb.1786, and her husband, Wm. Elliott died 15 Dec. 1814 in King William Co.

Her daughter Ann Bosher, made the statement that her mother had died 23 Jan.
1847, not long after her application for a pension. A problem seems to have arisen in that she had asked R.B. Gaines to handle the presentation of her application, but something had gone awry. Her daughter Ann was trying to clear it up. The 1840 King William Census, St. David's Parish (western half of the County), p.64. shows -- (Ann's communication was addressed from Richmond)

Could Ann Bosher have been the wife of Wm. Bosher? and, living as neighbor of Robt. B. Gaines? Ann would have been born ca. 1790-1800. Were there any other children? And, was, in fact, Sally Lipscomb, daughter of John and Ann (Madison) Lipscomb, actually the one who married Wm. Elliott? Or, was Ann Bosher wife of James Bosher, 1840 Henrico, p 185 --

James Bosher: 4 10-15; 17 15-20; 6 20-30; 1 40-50; 1 50-60 (a school?) females 1 10-15; 2 15-20; 1 20-30; 3 50-60; 1 70-80 (Sally?)

421 MADISON LIPSCOMB, Son of John and Ann (p. 423)

MADISON LIPSCOME, fourth named son (in the will) of John and Ann (Madison) Lipscomb was born probably ca. 1765. This is calculated from the list of 1812 Volunteers (21T125-6) which lists Madison as aged 47. In his father's will, he was to "be bound out after he get such schoolin as my executors hereafter shall think necessary to Mr. Frank Graves until he shall arrive to the age of eighteen years". He may, then, have been around 11 years of age.

He was also to receive (at age 18?) one hundred and twenty five acres, the tract which his father had bought from his brother Daniel. No Court records exist to identify such land, but, in 1785, according to the Alterations, he was given, by his mother, 187 acres, 9/2, as she was preparing to marry for a second time. This 187 acres, however, Madison traded to his brother, John, 1788 Alterations, for 107 acres.

This he held until 1802, by that time having obtained a "Tavern License". In 1802, however, (K.Wm.B 4 p 299) Madison bought, for £300, from Bartlett Lipscomb and Polly, his wife, "Blakesville", "where Bartlett now lives", bounded by Thomas White, dec'd, R. Wm. Frazer, Philip Lipscomb and s. Bartlett - "beginning at his upper gate, running a straight line to Frazer Ferry Road, etc." (no acreage listed) 22 Nov. 1802. (Bartlett, p. 76)

In 1805, he bought from Bartlett and his wife. (K.Wm.B.4 p.349), 2 May, 1805,

an additional 532 acres, bounded by Cohoke Swamp, to a tree dividing from James Lipscomb's land, ... on the road that leads over Cohoke Bridge to Putney ... down the road towards Blakesville.. to Madison Lipscomb's line".

(He had, meantime, sold to Thomas Hill (K.Wm.B.4) 22 Nov., 1803, "land which he had bought from his brother, John"- (the 107 acres?))

His holdings continued, then, 1805 through 1814, for 1582 acres, 11/5 4 miles East of the Court House, with an Ordinary license, land called "Blakes-ville", surely on the Main Road of King William County, and in the basic portion of the original Lipscomb Land Patent of Ambrose Lipscomb II.

The 1815 Land tax listing shows his 1532 acres as "Est.", Relict. So, he had died. The 1816 Tax lists Conway O. Lipscomb-pt.fee- 2903 acres, called Blakesville- 4 E.- "1583 of this from Mad? Lipscomb est. by will & 107 from Patty White by deed". (Included in the 2903 acres, was an originally held 25 acres from Parkes Bailey, whose daughter, Sarah Parkes Bailey, he had married).

The 1803 deed to Thomas Hill had included the name of his wife, Mary. It has been thought that Mary was a Madison, and this may have been based on the fact that their only (?) son Conway, might have been named such because back in the Madison family, James Madison (father of the President, James Madison) had married Rose Conway, (1718), of an early Virginia family. This could, of course, have come through Madison Lipscomb's own connection with the Madison family, through his own mother, Ann Madison. It would be a good project to try to identify Ann's father, Thos. P. Madison.

From all existing records, then, we can glean the name of only one child of Madison and Mary Lipscomb, -- (no will seems to be in existence).

CONWAY O. LIPSCOMB, born ca.1790-4; married Sarah Parkes Bailey ca. 1810-12; died between 1840 and 1850.

(See below)

432 CONWAY O. LIPSCOMB, Son of Madison Lipscomb (p.434)

CONWAY O. LIPSCOMB, perhaps the only son of Madison and Mary Lipscomb, was born ca. 1790-4, (calculated from Census records). He married Sarah Parke(s) Bailey, (daughter of Parkes Bailey), ca. 1814. He died between 1840 and 1850.

His marriage date is judged from the notation on his first Land Tax entry

"Conway O. Linscomb 25(A.) life adj.Jn. Powers est. & Hy Madison 2 mi.E. 9/2 338 .32 This land acqd from Parkes Bailey's est. by marriage"

In 1816, his land holdings increased to 2902 acres, -- "Called Blakesville" -- adding "1582 of this from Mad! Lipscomb est. by will & 107 from Patty White by deed". 4 miles E.

This acreage was diminished 1817 by deeds to Thos. Hill and to Theodoric Lipscomb for 942 acres, plus a note that his acreage "falls short by late survey". His holdings remained 1522 acres "called Blakesville", 4 mi. E. through the 1820s, with some small amounts sold off, but still called "Blakesville".

The deed for the 94th acres (K. Wm. B.7 pt. 1 p.132) describes it as bounded by "corner dogwood in Main Road to Bridge; S.E. 37 poles.. to corner hickory at T.T. Neal's gate .... up Cohoke Swamp to a pine tree; thence along Main Road up to the beginning dogwood" signed Conway O. Lipscomb, and Sarah P. Lipscomb. 15 Mar. 1817, recorded 6 Oct.1817.

The 1820 King William Co. Census shows, for Conway O. Lipscomb -- p. 301 Conway O. Lipscomb: males 2 10-16; 1 26-45 females 1 under 10; 1 16-26; 2 26-45

1830 Census, King William Co. p. 70 line 22 --

Conway Linscomb: males 2 5-10; 1 10-15; 1 30-40 (3 slaves) females 2 uner 5; 1 10-15; 1 15-20; 1 30-40

1840 Census, King William Co. p. 76 line 24 --

Conway O. Lipscomb: males 1 5-10; 2 15-20; 1 20-30; 1 40-50 females 1 5-10; 2 10-15; 1 20-30; 1 40-50

By 1850. Conway O. Lipscomb had died, and his widow is listed in Henrico Co., Va.- the City of Richmond, Census p. 382, line 28 --

REUBEN LIPSCOMB, son of John and Ann (Madison) Lipscomb would 423 have been born ca. 1768-70. He married Ann Lipscomb, daughter of John Pemberton Lipscomb, (see p. 68)(1771-1859). He died fairly young, in 1800 or 1801.

His father's will (1776) did not provide for education or apprenticeship for Reuben, but gave him 200 acres-" my home house", and the later indicated location of his land might indicate that it could have been either the actual or very near the original 200 Acre Land Patent to John Lipscomb, 1714 - his grandfather. -- 3 mi. S.. His 200 acres were turned over to him, as indicated in the 1790 Land Tax Alterations, valued at 9/0, -- by his brother, John, perhaps when he reached age 21, possibly from out of the 300 acres their mother had given to John in 1785 when she remarried.

Reuben Lipscomb married Ann Lipscomb around 1791. They had five children before his death by 1801. His "Estate" carried on ,on the Tax Rolls as such through at least 1829, 3 mi. S., adj. John "Gent" on Cohoke. From 1815 through 1820, the name of Ann Brett is added to his listing. Ann had married (2) John Brett before Aug. 1804. (And, by John Brett, she had one more son, Hutson Brett, born 1807). P. 69 describes how Ann, widow of Reuben, protected her children in the matter of inheritance due them from her father. After John Brett's death, 1810, Ann lived with her daughter, Margaret, (who had been raised as Ann Brett) at Green Level, where she died 1859.

The children of Reuben and Ann (Lipscomb) Lipscomb were. (Bible records) ---

- JOHN LIPSCOMB, born 27 Sept. 1793 (See #59-I p. 70) 433
- REUBEN LIPSCOMB, (Jr.) born 17 May 1795 (See #59-II p.70) 434
- MARGARET LIPSCOMB, born 23 Feb.1797; married (1) Temple Lips-435 comb, son of Daniel & Jane Libscomb (see p.411) married (2) Ambrose White; death date unkn. (See #59-III p. 70)
- SAMUEL LIPSCOMB, born 26 Nov. 1798 (See #59-IV p. 70) 436
- JUDITH LIPSCOMB, born 14 Jan. 1801; supposedly married, 1819(?) 437 John A. Lipscomb, son of Daniel & Jane Lipscomb; died 1849 (?) (See #59-V p.70. also p. 406 and 417)

ANDERSON LIPSCOMB, youngest son of John and Ann (Madison) Lipscomb was born probably ca. 1772-3, and was, no doubt, named for Anderson, brother of his father, John Lipscomb. If he married, the name of a wife is unknown. He died early, in 1800 or 1801. Like his brother, Reuben, his tax record begins to show "Est." in 1801.

His father, John Lipscomb, had left, in his will, to Anderson, the land called "Hunts", - 150 acres - which he had purchased from Wm. Neves. Anderson had become of age, and shows on the Land Tax lists his 150 acres beginning in 1793 (1791 & 2 are missing), valued at 9/2. He is designated as Anderson Jr. to distinguish him from the older Anderson Lipscomb who had, at about the same time, acquired the 600 acres, 7/4, from the Roger Lipscomb Estate.

Anderson Lipscomb's land tax ran on, then, as "Est." 4 mi. S., adj. Reuben Lipscomb Est. (his brother) and Cohoke, through 1817, and in 1818 was reduced to 58 acres, 92 acres having been sold to P. B(?) Davis. Thereafter, no further Tax listing.
