"Methodism in Washington, District of Columbia" says that he was a member of the Baltimore Conference for nearly forty-eight years.

He was listed on the 1830 Preston Co. (now in W.Va) Census, p. 17 line 2, and, in 1850, he was on the Jefferson Co. (now in W.Va) Census, p. 297, line 11, --

JOHN PEMBERTON LIPSCOMB, possibly the son of the hypothetical Ambrose Lipscomb, is thought so, especially because, in 1775, he seems to have been the Executor of the estate of an Ambrose Lipscomb as indicated by this advertisement in the Virginia Gazette, page 2 Col.3-27 Oct., 1775 (Purdie's)

"To be sold pursuant to the last will of Ambrose Lipscomb, dec'd, on Friday the 17th of November next, on the premises, five likely negroes, the stock of cattle, household and kitchen furniture, tobacco, corn and fodder, wheat, cider and brandy. Twelve months credit on bond and security.

- John P. Lipscomb, Executor"

The only other known John P. Lipscomb of this period was the son of George Lipscomb (p.367), and would have been only a very small child in 1775.

This John Pemberton Lipscomb had children born probably in the 1770s, hence probably married around 1767-69, and so, would have probably been born ca. 1745. This would have been somewhat late for him to have been a son of Ambrose Lipscomb II (who is thought by some to have died by the time of the granting of his 1714 Land Patent), or, even of Ambrose Lipscomb III who would have been having his family around 1720-35. Hence, the "invention" of the "hypothetical" Ambrose Lipscomb IV, born possibly around 1722, married ca. 1738-40, and died by 1775. And, in this case, he had selected his son, John Pemberton Lipscomb, as his Executor. Purely a product of imagination, - but wouldn't it be interesting to find that it might be true?

John Pemberton Lipscomb was appointed assistant Inspector at the Williams and the Piping Tree Ferries, on Wednesday the 18th of June 1777. Robert Drury and Thos. King were the Inspectors (Journal of Council of State of Virginia, Vol I p 434)

He furnished supplies for the Revolutionary War (though he apparently did not serve in the Army. His Public Service is listed (VSA) -- (DAR acceptance)

King William Co. Court Booklet I p.1, 19 & 25; 2 certificates; List I 7,8, List II 1,2; Commission Book III 252 for beef & 32-17-0

The 1780 Specific Tax in King William County lists John Pemberton Lipscomb for 15 bushels Oats.

His Land Tax shows 1782 to 1785 650 acres (which, on the 1789 Alterations, went to his son, Samuel as "heir"). The 1786 Alterations "collectible in 1787" show that he acquired 70 acres 9/2 from Thomas Neale, increasing his acreage to 720, but there is no record of any disposal of this 70 acres.

Among the salvaged Court records, (B.Ilast portion p. 107-8) there is a mutilated deed to John Pemberton Lipscomb, apparently 1785 or 6. from Major Powers and wife, Dorothy and Wm. Powers and wife, Judith, but quantity of land being deeded is not discernible. If land, it was quite evidently in the same vicinity as the earlier Ambrose Patent and to the west of it, because the Powers were neighbors. And the names of adjacent land owners are familiar—Keziah Lipscomb, himself, and Quarles. Whatever quantity was involved, it seemingly made no difference in his tax listing.

Since his 650 acres went to his son, Samuel as "heir" on the 1789 Alterations this must indicate his approximate death date, fairly young because none of his children were yet married, and his apparently last son, James Burwell

Lipscomb had been born, it seems, just a couple of years or so before his death, since, in 1803/4 documents, he is listed as still and "infant"- which meant underage.

Could this later birth- after the other children were all older, have indicated a possible second marriage?

Name or names of his wife or wives are not known, but his was probably first married around 1767-69, and his children, determined from later documents, mostly having to do with the settlement of his legacies, are --- and, perhaps not in the proper order,----

ELIZABETH LIPSCOMB, born ca. 1770-2 (?); married Philip Lipscomb. 58 Jr., her cousin; died between 1830 (&'40 (See p. 56) ANN LIPSCOMB, born 21 Feb. 1771 (family records); married (1) Reu-59 ben Lipscomb, son of John (see p. 437) and (2) John Brett (before 1804); died 11 Oct.1859 ae.88 (See below) SAMUEL LIPSCOMB, born ca. (?) 1773; married ca. 1793 Lavina Whitworth; 60 and died 1796 or 7 (p. 73) JUDITH LIPSCOMB, born ca. (?) 1775; married Reuben Madison before 61 18 July 1804; died (date ?) ELIZABETH LIPSCOMB, daughter of John Pemberton Lipscomb would have been born ca. 1770-2 (?) and married her (probably) first cousin, Philip Lipscomb II ca. 1791 at which time her brother, Samuel deeded to Philip a tract of 167 acres (which he had received from Jessee Lipscomb's son, Ambrose the year previous.

ELIZABETH LIPSCOMB

Apparently 450 acres of her father's land was divided among the four other heirs (other than Samuel) since each of them, Elizabeth, Ann Judith and James B. Lipscomb are shown, one way or another, with 112 acres of land, around 1803/4- after the death of Samuel, their brother, who had inherited his father's 650 acres. Samuel's widow, Lavina, probably received the balance.

ANN LIPSCOMB, daughter of John Pemberton Lipscomb, born 21 Feb.1771 (family Bible record), married (1) Reuben Lipscomb, son of John Lipscomb (of the will recorded 1777), and (2) John Brett. She died 11 Oct. 1859, ae. 88 (same Bible record).

It has been very difficult to untangle the full story of Reuben and Ann, due

to the duplication of given names in the different branches, involved in various documents in Court records. Because of this, let us consider Ann and Reuben and their family, as well as Ann's second husband in this section.

Ann Lipscomb and her first husband, Reuben Lipscomb, son of John must have married ca. 1791 or 2. Their children, according to the family Bible records were -- (See p. 437 for continuous Lipscomb numbers- 433-437)

- 59-I JOHN LIPSCOMB, born 27 Sept. 1793 (See p.70)
- 59-II REUBEN LIPSCOMB, (Jr.) born 17 May 1795 (See p. 70)
- 59-III MARGARET LIPSCOMB, born 23 Feb. 1797; married (1) Temple Lipscomb, married (2) Ambrose White; (See pp 70 & 411)
  - 59-IV SAMUEL LIPSCOMB, born 26 Nov. 1798 (See p. 70)
  - 59-V JUDITH LIPSCOMB, born 14 Jan. 1801; married John A. Lipscomb; died (?) 1848. (See p. 70 &406 & 417)

These children were reared by their mother and Step-father, John Brett.

Reuben Lipscomb, son of John Lipscomb and his wife Ann (Madison) Lipscomb, and husband of Ann Lipscomb, died in 1800 or 1801, shown by the entry on his Land tax record in 1801 as "est." He had received 200 acres shown in the 1790 Alterations from his brother, John<sup>A</sup>, probably part of the settlement of his father's estate. This 200 acre tax entry continued. "adjoining John on Cohoke" through 1814- Reuben Lipscomb "est.". Then it was listed under the name of Ann Brett through 1820, going back to Reuben Lipscomb "est." 3 miles south of the Court House. This was in the vicinity of the original 200 acre Land Patent of John Lipscomb, 1714, and just could have been the exact land.

A document is recorded (evidently prior to Ann's second marriage, sometime before 18 July 1804, to John Brett), entered in King William Co., 27 June 1803 (B.4 p 189) in which Ann Lipscomb deeded to her children, John, Margaret, Reuben, Samuel and Judith, two negroes, --"with all my reversioning right in the property now in possession of Frankey Allen, wife of William Allen, Junior, which the said Frankey Allen holds by right of dower from John Lipscomb deceased, reserving to myself all the profits... during my life and at my decease to go into the possession of my said children."

From this document, it is evident that Lawina, wife of Samuel must have had a nick-name- "Frankey", and that Ann was protecting her children in the matter of inheritance due them.

On the 18th of July, 1804, Ann's sister, Judith and her husband, Reuben Madison, deeded to Ann Neale 112 acres (Lot #2) which they had purchased of Ann and her second husband, John Brett, land from her father's estate.

John Brett died before 1810. They had had one son -59-VI HUTSON BRETT, born 8 July, 1807 (Bible record)

Ann (Lipscomb) Brett lived her later years at "Green Level" with her daughter, Margaret (who had been raised as Margaret Brett- but that's another story-see below) and her husband, Temple Lipscomb, and later her second husband, Ambrose White; and she died 11 Oct. 1859 (Bible record).

(See also p. 437) 59-I JOHN LIPSCOMB, Son of Ann & Reuben Lipscomb (See p. 68)
59-I JOHN LIPSCOMB, son of Reuben and his wife, Ann (Lipscomb) Lipscomb, was b. 27 Sept. 1793. He has not been identified with any further records, taxes or otherwise. (See p. 514)

59-II REUBEN LIPSCOMB, Son of Ann & Reuben Lipscomb (See p. 68)
59-II REUBEN LIPSCOMB, son of Reuben and Ann (Lipscomb) Lipscomb, was b. 17 May 1795. Nothing further is known of his later years. Some have thought that he was the Reuben Lipscomb in the War of 1812, but, that was quite probably the Reuben, (son of Capt. Bernard Lipscomb), b. 1780. (p. 353) It was very probable, too, that the Reuben Lipscomb to whom Lavinia Allen (formerly wife of Samuel Lipscomb) deeded, in 1810, 200 acres near Acquintom Church, was also the son of Capt. Bernard, - since Ann's son would have been only 15 years old.

Note: change of order 59-IV SAMUEL LIPSCOMB, son of Ann & Reuben Lipscomb See p. 68)

59-IV SAMUEL LIPSCOMB, son of Reuben and Ann (Lipscomb) Lipscomb, was born 26 Nov. 1798. No further record for him has been found. It was probably his first cousin, Samuel B. Lipscomb who was on the 1850 Census, ae.51.

59-V JUDITH LIPSCOMB, Dau. of Ann & Reuben Lipscomb (See p. 68)

59-V JUDITH LIPSCOMB, daughter of Reuben and Ann (Lipscomb) Lipscomb was b. 14 Jan. 1801 She died, supposedly, in 1849, and is supposed to have married John A. Lipscomb, son of Daniel and Jane (\_\_\_\_) Lipscomb. (p.406)

59-III MARGARET LIPSCOMB, (also a double LIPSCOMB), daughter of Reuben Lipscomb (son of John, 1777, p. 437) and his wife, Ann Lipscomb, daughter of John Pemberton Lipscomb, was b. 23 Feb. 1797. She married (1) Temple (411) Lipscomb, son of Daniel and Jane (\_\_\_\_) Lipscomb (p. 411) for that marriage and descendants). She married (2) 31 Dec. 1837, Ambrose White. Their death dates are unknown, but it may be presumed that they were both buried at "Green Level", where they lived, as described later. Their son, --

59-III-1 JAMES AMBROSE WHITE, b. 27 Dec. 1838, at 'Green Level"

The following "insert" story of Margaret's descendants, through her son, James Ambrose White (from her second marriage) entails the continuing tale of "Green Level" and the "People of Green Level", much involved with marriages and second marriages.

The 500 acres, inherited by Temple Lipscomb had a frame home on it, one story, built possibly ca. 1750. It was probably Ambrose White who had the one story lifted and built a first story under it, which with other additions, makes a very imposing structure, - set back from the road, with a white fence around the house yard. When shown, in the early 1970s, to the compiler by the owner (with his brother), Thomas T.H. Hill, then Co. Clerk of King William Co., peacocks still roamed through the box and Crepe myrtle. The burying ground overgrown, - slave quarters deteriorating.

Even though unoccupied, tradition abounded. Portraits of Margaret and of her mother, Ann, whom Temple wanted to stay on, too, at "Green Level". still hung above the parlor mantel.

Would that "Green Level" could be acquired and restored, - as a memorial to the LIPSCOMB family, - so near the earliest land-holdings in King Wm. Co.

The Lineage material in this segment has been supplied by Thomas T.H. Hill, "Gaylan", King William, King William Co., Va., 23086, who is not a descendant, - but, almost!

Referring to p. 411 under "Temple Lipscomb", we find a brief resume of the tangled history of "Green Level", the five hundred acre plantation inherited by Temple from his father, Daniel, (son of Daniel and Keziah) who had accumulated the large land holdings from the area of the Court House south to the Acquinton Swamp. And, the story of the descendants of Temple and Margaret Lipscomb, her first marriage.

After Temple's death, Margaret married (2), 21 Dec. 1837, Ambrose White, and they remained on at "Green Level", where they raised her children and the one son of their own, James Ambrose White, b. 27 Dec. 1838.

In 1847. Margaret's son, Preston Lipscomb, had inherited his portion of "Green Level", for which Ambrose White exchanged his "Huntsville" land (see p. 411). This, added to Margaret's portion, kept "Green Level" intact, and thus begins the tangled story of the ownership of "Green Level"through an interesting sequence of marriages and second marriages, tho' actually not passing out of the hands of Lipscomb descendants until the death of James Ambrose White in 1903. Thus, - pursue the story of the "People of "Green Level", -- with the son of Margaret Lipscomb and Ambrose White, -

Both are buried at Jerusalem Christian Church. Their two sons, born and raised at "Green Level", still have an interest in it. James Burnett Hill, Jr. b. 14 Apr. 1909; m. 9 Dec. 1933, Emily Elizabeth Taliaferro and live at adjacent "Springfield", old Hill landmark. Thomas Taliaferro Hoskins Hill, b. 24 Dec. 1911, lived at "Green Level" until 1967, when he built "Gaylan" just across the pond from the house. He retired as Clerk of Circuit Court, K. Mm. Co., 31 Dec. 1977. He

has been very helpful in furnishing information to the compiler.

To continue, now, with other children of John Pemberton Linscomb, --

60 SAMUEL LIPSCOMB, Son of John Pemberton Lipscomb (p67)

SAMUEL LIPSCOMB, son of John Pemberton Lipscomb (wife's name unknown), was born ca. 1773(?). "Samuel" a new name in Lipscomb family, may have been from his mother's family, - perhaps a clue to her name? Samuel had married, before 31 Dec. 1791, Lavina Whitworth, dau. of Wm. Whitworth, for, on that date, he acknowledged receipt from Isaac Quarles for "the estate and full amount of the profits of the estate left to Lavina Whitworth, my present wife, by her late father, William Whitworth, dec'd..." - 165 acres, 6/5, which added to his 720 acres from his father, plus 133 acres deeded to him by Thos. Moore (B.3-p.24), 13 July 1794, totaled 1018 acres. These were on his tax record, 1793-7, when the listing was marked "Est."-so, he had died, 1796 or 97- a short life of only around 24 years.

He had received, 1790 (p. 76)a deed for 167 acres from Ambrose Lipscomb, (son of Jessee). For some reason he re-deeded this 167 acres on to Philip Lipscomb II, in 1791, - possibly at the time Philip married his sister, E-lizabeth.

Samuel and Lavina (Whitworth) Lipscomb had two children, --

- 60-I AGNES LIPSCOMB, who may have married (1) Charles Neale, (2) Allen Blackwell, and possibly (3) in the 1820s, John Harvey (see later in story of her brother, Samuel B.)
- 60-II SAMUEL B. LIPSCOMB (see next)
  - 60-II SAMUEL B. LIPSCOMB, Son of Samuel Lipscomb (above)
- 60-II SAMUEL B. LIPSCOMB, son of Samuel and Lavina (Whitworth) Lipscomb would have been b. by 1796 or 7 (before his father's death, or shortly after). He must be the Samuel B. Lipscomb listed on King William Land Tax records, --

1819 thru 1822 179½ acres 6 mi.S. oc C.H. ("from his mother")
1823 " 1828 (or 202 acres (22 acres added, 1823, "by late survey"

The land and detailed to big sister first shows as Amer Blackwell

The land was adjacent to his sister, first shown as Agnes Blackwell, later changing to Agnes Harvey, - later under name of John Harvey.

The full name of his wife is not known, but the 1850 and 1860 Census records, K. Wm. Co.. show his wife's first name and initial as "Mary G."

They show on 1830, 40, 50 and 60 Censuses. The 1850 Census gives us, probably the list of their children's names, all b. Va.

60-II-1 MARIA E. LIPSCOMB (18/1850), b. ca. 1832

60-II-2 SAMSON LIPSCOMB (16/1850), b. ca. 1834 (25/1860- carpenter)

60-II-3 LITTLETON LIPSCOMB (15/1850), b. ca. 1835 (24/1860)

60-II-4 LOFTIN LIPSCOMB (14/1850), b. ca. 1836 (Could Mary G. have been a Littleton?

60-II-6 SAMUEL B. LIPSCOMB, 5/1850), b. ca. 1845(Jr.)

The father, SAMUEL B. LIPSCOMB, is shown as. 51 (Mary G. 41) in 1850, - and as. 60 (Mary G. 54) in 1860. This would indicate his birth 1799-1800, which raises a cuestion, of course, but his father, Samuel Lipscomb, had been indicated as deceased by 1796-7 (see above), So, ---?

JUDITH LIPSCOMB, daughter of John Pemberton Lipscomb, would have been born in the early 1780s.

Sometime, before 18 July 1804, she married Reuben Madison (parentage not known). On that date, Judith and her husband deeded to Ann Neale Lot #2, 112 acres (B.4 p.289) which they had bought from her sister, Ann, and her husband, John Brett, (inheritance).

On 30 July, 1804, a coparcenary deed is recorded (B.4 p.273), briefly--

Reuben Madison and Judith, his wife. who was Judith Lipscomb, one of the children of John Pemberton Lipscomb, dec'd, to William Allen, Jr. (who was marrying Lavina (Whitworth) Lipscomb, widow of Judith's brother, Samuel). Judith Madison is entitled, with Elizabeth Lipscomb, wife of Philip Lipscomb, Ann Brett, wife of John Brett and James Burwell Lipscomb, infant son, and Samuel B. Lipscomb and Agnes Lipscomb, infants of Samuel Lipscomb, dec'd. who was also a parcener, - to one undivided fifth part of two tracts on Acquinton, adj. Frazer's and Cramp's, - 300 acres, - for (?) L52-10-0. On this document, one of the witnesses was James Lipscomb, - (probably James Lipscomb C) (See p. 34).

On 28 July 1805, Judith and her husband sold to Powers the 112 acres which she had inherited from her father. (B.4 p.265).

Nothing further has been found in records for Reuben Madison and his wife, Judith.

62 JAMES BURWELL LIPSCOMB, Son of John Pemberton Lipscomb, p. 67

JAMES BURWELL LIPSCOMB, last child of John Pemberton Lipscomb, was born only a few years before the death of his father in 1788 or '89. He was underage in the document of 1804 (see above). Was his mother a Burwell?

His first tax was 1803 and in 1804, and being underage, was listed along with James Lipscomb C (perhaps his namesake?) for his 1122 acres. Evidently James C was his guardian. His tax was increased in 1810 to 169 acres, then reduced 1816. to 158 acres, (formerly overcharged) 3 miles south of the Court House, adj. Levina Allen.

But. in 1816, his listing is marked "est.", so he had died. It is listed "est." on through 1829, however the 112 acres were disposed of in 1821.

One puzzling aspect is an additional listing 1816 through 1819 "Roxelany Lipscomb 40 acres 7/4" adj. Chas. Neale est. & James B. Lipscomb est. - for her "life" and marked in the margin "this from Jas.B. Lipscomb est for dower". On the 1817 list and later, she was listed as living in Richmond.

This could only mean, surely, that Roxanne, daughter of Lt. Yancy Lipscomb (see p. 382) had married, first, James Burwell Lipscomb, before she married 10 Feb. 1819, in Richmond. her second husband, Abraham Archer, at which time, of course, she would have relinquished her "life" tenancy of her dower land. It had been a short marriage, if not just a betrothal.

No further records have been found for James Burwell Lipscomb.

JESSE LIPSCOMB, born possibly ca. 1725-35, and possibly a son of 22 third-generation Ambrose Lipscomb III, left very little record. But, we pick up the pieces in the fact that the 1782 King William Land tax shows an "Ambrose Lipscomb (Jessee)" with 500 acres, continuing on, 7/4, deducting the 167 acres on the 1790 Alterations (deeded to his cousin (?), Samuel, which, without even showing on Samuel's tax, was deeded on, 1791 to Philip Lipscomb II) (See p. 36), shows 333 acres until Sarah Lipscomb assumes tax on the land in 1796. Sarah Lipscomb was probably his widow, and she held the 1 and in her name until the son, Bartlett assumes it in 1799. So, do we have Sarah\_ as wife of Ambrose (Jesse). and their son, Bartlett? (See Bartlett) Could these 500 A. have been mainly the original Ambrose Lipscomb II patent, 470A.? The name "Jesse" is a new name in the family, possibly from the Bible, or maybe a favorite name of his mother's?

The name of Jesse Lipscomb's wife is not known. One strange item, coming out in later documents (See p.20) is the deed 28 July 1800 (recorded B.3 p. 463) in which Nathaniel Cobb and his wife, Fenette, (daughter of Pemberton Madison) deeded to James Lipscomb C, 30 acres bound by swamp and Cohoke Bridge, a tract delivered to Fenette by will of Jesse Lipscomb, Sen. to the said Fenette, who was Fenette Madison! (These will records are, of course, missing.) For what reason had Jesse Lipscomb, Sen. willed this 30A. parcel to Fenatte Madison? Had she been related to his wife?

Aside from Jesse's son, Ambrose, we may assume that he had possibly another since there are Revolutionary War records for such a name. Brumbaugh's records show him as a soldier in the Infantry, private. It would seem unlikely that a man ( the "father")born as early as 1725-35 could have served in the infantry. There are few other records, --- Gwathmey's "Historical Register of Virginians in the Revolution" (p.477-8) shows "Jesse Lipscomb nbll" which means that he had not received Bounty Land. Eckenrode's 1912 "List of the Revolutionary Soldiers of Virginia" codes "War 4, 250" (and "War 5,251" which was not checked) which showed that his balance of pay was collected by Capt. Pemberton, - 182-13-9, 18 Mar. 1783. (Balance of pay collections by someone else does not always mean that the soldier was no longer living.) No other records for Jesseg Lipscomb, a soldier have been found, -- so, perhaps we can surmise that the Jesse, the son, probably died, during or shortly after the War.

But, the assumption that there was a son, Jesse, can well be made, since the Nathaniel and Fenette (Madison) Cobb deed had definitely said "Jesse Lipscomb, Sen.", which would have meant that, at the time, whenever it was. there had been two Jesse Lipscombs.

There is no Jesse Lipscomb on the 1780 King William Co. Specific Tax list, none on Public Service Lists, nor on the list of Virginians who "turned in their money", so it can be well assumed that Jesse Lipscomb, Sen. died before 1778, (also, quite probably Jessee, Jr.) No land tax or census for Jesse.

His sons may, then, be listed as -

- AMBROSE LIPSCOMB. born about 1750-3; married Sarah \_\_\_\_; died 63 ca. 1795/6. He was listed "Ambrose(Jesse)"
- JESSE LIPSCOMB, born ca. 1750-5; probably died by 1780. There 64 are brief Rev. War records, for him? Nothing further. Turn page for Ambrose (Jesse) --No Bounty Lands.

AMBROSE LIPSCOMB (Jesse), would have been born probably around 1750-3, and apparently the son of Jesse Lipscomb. This date is picked because of the probability that this Ambrose Lipscomb (who had a wife Sarah), of St. John's Parish, King William Co., Bought 300 acres, for 1170 in Trinity Parish, Louisa Co. on Long Creek, adj. Francis Lipscomb, from John Stewart and his wife, Anne, 11 Oct.1773 (Louisa Co. D.B.D. p.539). He'd have surely been aged 20 or more to have made this purchase.

On 8 June 1778 (Louisa Co. D.B. E p.266) Ambrose Lipscomb and Sarah, his wife, of St. John's Parish, sold this same acreage, same price, to Samuel Shelton. Could this have been a start at western migration — perhaps as a young man, before his father's death, and even before a brother, Jesse's, death, expecting him to inherit the family lands? Or, just pure speculation?

Now, who was that Francis Lipscomb? His earliest record was, in Louisa Co., in the above 1773 deed showing he owned land. He had nine children, born probably in the 1770s to 90s, and he died in 1802. (See p. 465)

Anyway, in 1782, Ambrose Lipscomb (Jesse) was settled in King William Co., paying tax on 500 acres -- inherited from his father, Jesse (?). As stated before, the 1790 Alterations show that he had deeded 167 acres to Samuel Lipscomb reducing his land to 333 acres through 1795, at which time he apparently died, because his widow, Sarah, assumed the tax through 1798, and their son, Bartlett took it over, in 1799. There were no Rev. War records.

So, it is evident that Ambrose Lipscomb (Jesse), who had been so marked in the tax records, in order to distinguish him from other Ambrose Lipscombs, and his wife, Sarah \_\_\_\_, had, at least, one son, \_\_\_

65 BARTLETT LIPSCOMB, born ca. 1775; married by 1798; died (not known)

## 65 BARTLETT LIPSCOMB. Son of Ambrose Jesse Lipscomb

BARTLETT LIPSCOMB, son of Ambrose Lipscomb (Jesse) - and Sarah (\_)
Lipscomb, his wife, would have been born possibly ca. 1775, to have been married, before 1798, to Polly \_\_\_\_\_, at which time he appeared on Personal property tax lists, with 2 titheables.

Several Land transactions followed, leading us to believe that the land he had inherited was part of, or near the original 1714 Land Patent to Ambrose Lipscomb II, perhaps a little west, and was what became known as "Blakesville".

20 June 1798 (B.3 p. 339) Bartlett Lipscomb, and Polly, his wife, deeded to James Lipscomb (surely C) 5 acres in low ground of Cohoke Swamp, adj. land already owned by James Lipscomb and land of Philip Lipscomb, near the bridge over Cohoke. This land was a parcel which Bartlett's father, Ambrose (Jessee) had actually sold to James, but Ambrose had died without making out the deed.

22 Nov.1802 (B.4 p.299) Bartlett and Polly Lipscomb sold to Madison Lipscomb. for £300 (acreage not given), "where Bartlett now lives, which is called 'Blakesville', - bound by Thos. White, dec'd, R.W.M.Frazer, Philip Lipscomb (II), and sd. Bartlett, beginning at his upper gate, running a straight line to Frazer's Ferry Road, etc. etc."

2 May 1805 (B.4 p.349) Bartlett and Polly sold to Madison Lipscomb 53½ acres on side of Cohoke Swamp, - up the Swamp to a tree dividing James Lipscomb's land, to a corner tree standing on the road that leads over Cohoke Bridge to Putney, down the road towards Blakesville to ... to Madison Lipscomb's line.

Beginning in 1802, Bartlett Lipscomb was taxed, in addition, for a Tavern License, so his land was evidently on the Main Road East of the Court House. Madison Lipscomb seems to have continued, having a Tavern License, and, by 1815, (when the Tax lists had begun to show distance from the Court House, his listing was indicated as "Blakesville", 4 miles East of the Court House, value 11/5.) (Had this, indeed, been part of the land of Ambrose Lipscomb II?)

By 23 Feb., 1807, Bartlett and Polly seem to have deeded what land they had left-to Thomas Neale (6W(2)141), and Bartlett's name continues on through from 1806 to 1811 on only the Personal Property tax list, with only one titheable... Did he die at that time? And, when did Polly die? There is no probable Bartlett or Mary (Polly) on either the 1820 or 1830 Census record.

There is, however, on the 1830 Census, a younger Bartlett Lipscomb, ae. 30-40 (b. 1790-1800), and another male 20-30. Also, on the 1850 Census, to confirm the probability that Bartlett Lipscomb, and his wife, Polly \_\_\_\_, had had at least one son, —

- BARTLETT LIPSCOMB II, born evidently 1799; married Eliza :
- 65-A BARTLETT LIPSCOMB II, Son of Bartlett Lipscomb (p.76)

BARTLETT LIPSCOMB II, quite probably the son of Bartlett Lipscomb and Polly(\_\_\_\_\_) his wife, was born probably 1799, and the 1850

BENONI LIPSCOMB's DEED, 16 April, 1801, to John Mill KING WILLIAM COUNTY Record Book 4 p. 65-66 Land from his father, George Major Lipscomb (See p. 80) GEORGE MAJOR LIPSCOMB, was born probably ca. 1725, and we list him as a possible son of Ambrose Lipscomb III for two reasons,—1. he had a son named "Ambrose" (named for his father), and 2. the land which he left to his children was very evidently the 300-or-so acres just to the east of Ambrose Lipscomb II's 1714 Land Patent,— which was very possibly the acreage which was deeded by Joseph Bickley and his wife, Sarah, land which she had from her former husband, Richard Gissedge, and which they deeded to "Ambrose Lipscomb and his wife, Mary," (See p.13 & 27) in 1722. If that Ambrose Lipscomb could have been the son of Ambrose Lipscomb II, he might have just been married, in 1722 to Mary \_\_\_\_\_, and would be having children within the next several years, hence the probable birth date of 1725 fits in here nicely.

One additional possible reason is a chance that one of his sons, Richard, may have had a middle name, "Gissedge" (see p. 15)

The reason for the middle name of "Major" for George Major Lipscomb remains a complete mystery. There was a large Major family, - one member even named George Major - in the not-near vicinity, - with many land patents north of the fork of the Pamunkey R. and Mattaponi River. But, a fairly thorough study has produced no connection with the Lipscomb (or, Gissedge) family. Further research, however, just might prove even that Ambrose Lipscomb III had mar ried a Major. Or, perhaps it was merely a popular family name in the vicinity. On the other hand, he could have assumed the name "Major" if older (or larger) than the other contemporary George Lipscomb (See p. 365)

Both he and his "assumed" brother, Henry Lipscomb, had one daughter each named "Mildred", a name which carried down for some generations. A clue of any kind?

So far, no record of his first wife has been found- (the mother of his children). But, he did marry, (2) by 1782, Jane \_\_\_\_\_, a widow of, as Dr. Harris surmises, another \_\_\_\_\_ Lipscomb, tho' we cannot find any deceased Lipscombs who might fit as her first husband, as yet. Dr. Harris also believes that Jane might have been a daughter of Nathaniel Claiborne and his wife, Jane (Cole) Claiborne. She had two daughters, Jane Cole (?) Lipscomb who married Benoni Lipscomb, and the other daughter, Jane (?) Lipscomb, who married Daniel Lipscomb, both sons of George Major Lipscomb. (See below)

His will is missing, and the only records we have of him are, (beside the deeds to John Mill from his sons indicating that he had left a will), are

March 1778 - he turned in his money, entry #1263 576.

17 Mar. 1780- Specific Tax, King William Co. 168 lbs. tobacco

The 1782 Land Tax shows his widow, Jame Lipscomb taxed for her dower land, 100 acres 6/11, so this shows that George Major Lipscomb had died between March 1780 and tax time 1782. In 1785 she had deeded 50 acres of this to her son-in-law, Benoni Lipscomb, and this same year, she had married (3) Bernard Hornett who assumed these taxes until his death around 1800. In 1810 she deeded some of her own slaves to the children of Benoni and Mary Cole Lipscomb. By 1816-17, she had died, and her 50 acres had been transferred to John Mill.

George Major Lipesomb's land must have been around 280 to 300 acres all together, which John Mill began buying up in 1801 from the individual heirs of George Major Lipscomb, until, by 1816, he had it all. Rev. John Mill

had come to King William County a few years before 1800 and became pastor of the Lower College Church, later Colosse Baptist Church. By 1825/6 after his death, his over-1100 acres were divided up between his three sons, John, George and James. The part on the south side of the Main Road, including the lands formerly George Major Lipscomb's was the "Lilly Point" Plantation.

The individual deeds from the heirs to John Mill, were considerably complicated by "portions now in possession of Jane Hornett as dower," and also "portions allotted to one son, Daniel"who died, 1796, and his widow, Jane, held possession, --- so it is impossible to add up the actual acres involved. These deeds are, as far as can be determined --

then, the portion, 29 acres bequeathed to Richard G. never was absorbed.

So, from these land transactions we can determine that George Major Lipscomb and his unknown first wife had had these children, after a marriage in possibly ca. 1749/50, --- not necessarily in proper order, by birth --

MAJOR LIPSCOMB, who appears only on Revolutionary War records, and we have no place for him, unless he just might be a son of George Major lipscomb (named "Major"). There are no tell-tale deeds of land left to him by George Major Lipscomb, and this may be because he might have died early.

Records at the National Archives indicate that he was a sergeant in Capt. Drury Ragsdale's Company in the Regiment of Artillery commanded by Col. Charles Harrison, and two vouchers, signed by Drury Ragsdale certified that he had served three years having enlisted 16 Jan.1777, - discharged 10 Jan.1780. One of his Military certificates shows that he served at Valley Forge in May of 1778. He collected his own balance of pay 22 Oct.1783, 184-18-9.

Jillson's "Kentucky Land Grants" p 201, lists for him, 10-11-1793, Book 5 p. 287 a grant of 200 acres in Military Co., on Drakes Creek. Efforts have been futile to try to find out whether or not he took up this grant, and no record for him has been found in Kentucky, - or, in Virginia after he paid his Personal Property Tax in only 1782 and 1783. No Land tax.

Can anyone identify him further?

66 AMBROSE LIPSCOMB (GM), Son of George Major Lipscomb (p. 79)

AMBROSE LIPSCOMB (GM), son of George Major Lipscomb and his first wife, whose name we do not know, would have been born, probably anytime between 1750 and 1765. There is no clue to prove that he married, since his two deeds of record do not (as they usually do) name the wife or bear her signature. And, likewise, there are no evidences of any children.

He apparently began paying Personal Property Tax in King William Co. in 1791 as Ambrose Lipscomb Jr., 1799 as "S.G.", and 1800 and afterward as "G.M." for George Major, no doubt.

His only actual Land Tax record is 1812 and 1813,  $24\frac{1}{2}$  acres, which is probably the "estimated 29 acres" which Benoni, his brother, and his wife, Mary Cole, deeded to him 6 Feb.1813 (B.6 p.257) rec.27 Sept.1813. This parcel was probably one of the lots which Ambrose (GM) deeded on to John Mill, lots #3 and #6 "containing by survey fifty three and a half acres", 18 Oct.1813, recorded 24 Nov.1813 (B.6 p.288). Ambrose had previously deeded to John Mill, Mar.5,1813 (B.6 p.230) his right to his portion of the dower land of Jane Hornett, plus his portion due him from his dec'd brother, Daniel's part. Benoni's deed was for land bound by W.F.Olonne, Martin Turner's representatives, Theodoric B. Lipscomb. Jane Lipscomb and Ambrose Lipscomb, so all of this land was contiguous, and still East of the original Ambrose Patent.

From 1815 through 1818, Ambrose Lipscomb (GM) must have been managing the two tracts of land of the Thomas King estate, whose widow married Philp Johnson in 1815. This land was 672 acres in two tracts, 5 and 10 miles east of the C.H.and Ambrose Lipscomb (GM)'s name shows on that Tax list for those years under the name of the estate.

After 1818, we have found no further clues, except that he must have been the Ambrose Lipscomb on the 1820 Census, aged 26 to 45 (no others in his listing, male or female) with six slaves. No Ambrose on 1830 Census. So, he must have died between 1820 and 1830.

#### 67 RICHARD G. LIPSCOMB, Son of George Major Lipscomb (p. 79)

RICHARD G. LIPSCOMB, son of George Major Lipscomb was born ca.

1750 (over 45 in 1810 Census- and defendant in two suits in Louisa Co., in

1767 & 8). The obituary of his second eldest son, William, lists his mother
as Frances, but we do not know her surname. So, since the eldest son, George
was born before 1775, we place their marriage at ca. 1770-3. Richard G.Lipscomb died between 11 June 1812 and 4 Jan.1813.

As a young man, could he have been "visiting" his Aunt Kitty Gissedge Poindexter in Louisa Co., and had two escapades resulting in law suits? Louisa Co. O.B. 1767-1772 p.49 records that John Edwards, plaintiff, had sued Richard Gizzage Lipscomb, but whatever the problem was it was "agreed by parties-12 May 1767". And, (Ibid p.150) 13 Apr.1768 Court, George Pottie, plaintiff, had sued Edward Wade and Richard Gizzage Lipscomb, defendants, the record ending ... "It is ordered that the same be inquired of by a jury at the next Court and the said Richard not being arrested and not appearing on the motion of the plaintiff an attachment is awarded him against the Estate of the said Richard for Ten pounds and costs returnable to the next Court." These entries

have been a problem, but at least, it does indicate a close tie with Richard Gissedge (See p.15) who was no doubt his great grandfather, for whom his father named him.

The next we have of him is the 1779 Nottoway Parish. Amelia Co. tithe list of Sam'l Sherwin (VSA) showing Richard Lipscomb with 2 slaves- Charles and Mage. Slave names carry through, -- 1782, - Charles, Sue, Marg(?), Bob, Aggy; then, Charlotte Co; 1784, - Sue, Sam, Bob & Aggy; and 1786 Sue, Bob, Clocy, Aggy and Marge(?). Names of slaves are a good way to identify and follow owners.

He had left Amelia County about 1783, when he bought 300 acres, Parish Cornwall, Charlotte Co., from Thos. Walters (Char.Co. D.B.5 p.29), and in 1785, 50 acres from Fr. Cardwell. Oddly, though, his Land tax remained 270 acres in Charlotte Co. 1788 through 1812, at head of Jones Cr.. Probably part of his land was in Halifax Co., though, - for, in 1801. he bought 158 acres on Staunton R. from his brother, Luke Lipscomb (Char.Co.D.B. 18 p.450) 170.

Differentiating the records of this Richard G. Lipscomb from those of Richard Lipscomb, son of Ambrose and Unity Lipscomb of Amelia Co. (See p.34) has been carefully studied and the problem untangled. Ambrose Lipscomb's son, Richard, born ca. 1762, inherited 134 acres in Amelia Co. from his father, which he held until he went to Charlotte Co. in 1804, (as attested in his Pension file), and married in 1806, Polly Cobb of Halifax Co. His Charlotte Co. Land tax began in 1804, - 286 acres, adding 54 acres in 1809, totalling 340 acres, on Sycamore Branch, adding 28 acres in 1833, -- until his death in 1838. His Charlotte Co. entries were marked "Richard Lipscomb, Jr." until after 1812 when Richard G. Lipscomb died.

An odd situation occurred back in King William Co., where we find, beginning 1812 (the year of his death down in Charlotte Co.) on Land Tax lists of King William Co. "Richard G. Lipscomb, (address) unknown, 29 acres 7/6 5 miles S.E. (later) adjoining John Mill on both sides, (and still later Geo. Mill)." It is likely that the 12¢ tax assessment didn't warrant trying to locate his whereabouts. This entry continued for many years, at least through 1830, and, it is through these that it can be definitely determined that Richard G. Lipscomb whose 29 acres, similar area to those of the other heirs, and engulfed within John Mill's land, even he, too, was a son and heir of George Major Lipscomb, who, for some reason had missed "selling" his 29 acres to John Mill.

On Sept. 7,1793, Richard G. Lipscomb served on a Jury in adjacent Prince Milliam County District Court (Cal. of Papers V.6 p.520) - trying a case of burglary.

#### DESCENDANTS OF RICHARD G. LIPSCOMB

It is difficult to place the children of Richard G. Lipscomb timewise, except to take them in the order of their listing in their father's will, as shown in the preceding list. George is named first, etc. However, at the end, we find the names of the three children of the deceased son, John (as of 1812). and we find that John had married 15 Dec. 1796, Prince Edward Co. (adjoining) Patsey Russell. So, judging that he may have been ca. 20 years of age in 1796, he may have been born ca. 1776— and, one of the older children. Let us simply take them in the order in which they appear in the will of their father, dated 11 June 1811.

#### 73 GEORGE LIPSCOMB, Son of Richard G. Lipscomb (p.81)


GEORGE LIPSCOMB, very probably named for his grandfather, George Major Lipscomb, and very probably the oldest son, was born perhaps as early as 1773-4, in Amelia Co., Va.. He married 1 Dec. 1800, Polly Morton, dau. of John Morton, after the family had moved to Charlotte Co. (Char. Co.Mar. Rec. p 78). He was named Executor of his father's will. In the will he inherited "all my tract of land in Halifax County lying on both sides of Mortons Ferry Road, whereon my said son, George now resides".

Little has been found in the way of information on George and his family. His 1820 Halifax Co. Census record, p. 82, shows,--

1 male under 10; 1 over 45 :: 1 female under 10; 2 10-16; 1 26-45; slaves

A will is recorded in 1825, Halifax Co., Va. for a George Lipscomb, and this should be checked. Was his widow the Mary Lipscomb, ae.40-50 (b.1780-90). with 4 male and 7 female children. 1830 Halifax Co. Census, p. 410?

MILIAM LIPSCOMB, second son of Richard G. Lipscomb, was born in Amelia County, Virginia in 1775, according to the census of 1850 of Charlotte County. He died 18 April 1861 in the same county with pneumonia, age 86 years. His parents were Richard G. and Frances Lipscomb. (Death Certificate)

After his marriage to Caty (Catherine) Huddleston, daughter of Benjamin Huddleston, 20 January 1804, in Halifax County, Virginia, William Lipscomb must have lived in Caswell County, North Carolina for awhile, as his first two children were born there, according to the 1850 census. However, he was back in Charlotte County, Virginia by 1813, as the land tax list showed him in possession of the 260 acres of land his father had left him by will, proved 1813. (Charlotte County, Virginia, W.B. 3, p. 214)

A family tradition is that Richard Lipscomb received 17 bankruptcy notices in one week after the War 1861-65, from commission merchants in Richmond, who had handled his tobacco on the market and acted as bankers, as was customary in that day.

However, Richard Lipscomb continued to live on his plantation in Charlotte County until his death in the fall of 1876 or 1878.

It is not known when his wife died, but it must have been before 1901, when their children sold part of the land of Richard Lipscomb, deceased. (Charlotte Co., Va., D. B. 48, p. 404) (Charlotte Co., Va., D. B. 50, p. 300- Deed of Partition)

PLEASANT LIPSCOMB, son of Wm. and Caty (Huddleston) Lipscomb, was born (calculated from 1850 & 60 Census records), 1805-1808, and would have been probably their first child. He was born in N.C., where his father was still on the 1820 Census. in Person Co., just south of Halifax Co., Va. (That Census listed two sons under ten. so a little difference in calculation!) He was apparently named for his father's brother, Pleasant.

The name of Pleasant's first wife is unknown, but probably ca. 1830. His first wife seems to have had three children. He married (2) 24 Oct. 1843, (Char. Co. Mar. Rec.) Elizabeth W. Lester, dau. of Thomas. His death date is not known, nor that of his wife, but he seems to have lived in Charlotte Co., Va. during his later life, as shown by Census records, which list his children, --

MILDRED LIPSCOMB, another one of the many Mildred Lipscombs. This 76 one was daughter of Richard G. Lipscomb, born possibly ca. 1775-80. She married 8 Apr. 1801, a distant cousin, Temple Lipscomb. son of Uriah (son of Benjamin Linscomb of Amelia Co.). See p. 197 - for the further story of their children.

She apparently died by 1818, since we find a second marriage record for Temple, -- 21 Sept. 1818, Prince Edward Co., VA, - to Elizabeth A. Hawkins.

#### 77 KITTY LIPSCOMB (daughter of Richard G. Lipscomb)(p.81)

KITTY LIPSCOMB, daughter of Richard G. Lipscomb, and his wife, Frances, is mentioned in only one reference so far found. Her birth date is not known. Charlotte Co. Marriage records show that 12 Nov. 1813, she married Laban Palmer, -- or rather that the marriage bond was taken at that date. (Was she, perhaps, named for her father's "Aunt Kitty" (see p. 81)

Further data could be gleaned from Census records of later dates under his name.

# 78 MARY (POLLY) LIPSCOMB (daughter of Rich'd G. Lipscomb) (p.81)

MARY LIPSCOMB, daughter of Richard G. and Frances (\_\_\_) Lipscomb, is likewise mentioned briefly. Her marriage bond, dated 2 July 1798, (Char. Co. Mar. Rec.) to Nathan Buckley would indicate that she must have been one of the older children.

She had apparently died by 1824, since a record of Person Co., N.C., dated and recorded 14 Dec. 1824 showed that Nathan Buckley of Summer Co.. TN, had appointed B. Dollarhide, Power of attorney to receive his wife, Polly's (now dec'd) legacy from her father's estate, from George Linscomb, Executor.

Further records could probably be found.

# 79 JOHN LIPSCOMB, dec'd before 1812 (son of Richard G. Lipscomb) (p. 81)

JOHN LIPSCOMB, was possibly one of the older sons of Richard G. and Frances (\_\_\_\_) Linscomb, born perhaps as early as 1776. He married, 15 Dec. 1796, Pr. Edward Co. (next Co. N. of Charlotte Co.) Patsy Russell, dau. of Joseph Russell (whose will, Pr. Edw. Co. B.7 p 469-70, 9 June 1832, does not name her, but does name her children who were his grandchildren.)

Caswell Co., N.C., (just S.W. of Halifax Co., Va.) marriage records show a John Lipscomb marriage, 14 Dec. 1808 to Phoebe Richmond. Caswell Co. D.B. (1804-13) p. 342-3, 24 Jan. 1809 show that she had dower land from a previous marriage to Joshua Richmond," now dec'd.

John Lipscomb, otherwise unaccounted for, does not show in 1810 Census, but Lipscomb, Pheby: males: 3 under ten; 1 26-45 (who?)

Caswell Co. Court records show, in Apr. 1810, that Phoebe Lipscomb was appointed guardian of orphans of Joshua Richmond, - Warren, John & Robert Richmond, who were probably the 3 males under ten in 1810 Census, - rather than the three sons of her last husband, John, who had no doubt died before 1810. So, whether or not. this was the same John Lipscomb remains a mystery.

The above material, and the forthcoming data have all been gathered by the compiler from many different sources, mostly as a matter of trying to place, in the proper order, so many of the names found in Virginia records.

At least, we know that John Lipscomb had died before the 11 June 1812 date

102 of the will of his father, Richard G. Lipscomb. And, we know that his wife, Patsy, had died by 1832, from her father's will.

The will of Richard G. Lipscomb, as recorded, left to the "orphan Grandchildren-Joseph R. Lipscomb, Richard Jordan and Henry Lipscomb, sons of my deceased son, John Lipscomb £100 to be divided among them when Henry the youngest comes to age 21 years." A comma does not appear between Richard and Jordan. But, they were probably two different grandsons (See p. 104)

In Joseph Russell's will, 1832, it might seem that there were four grand-sons, Richard and Jordan being two. However, records for a possible separate Richard have not been found, as yet. Several records for the three men have been found, leading to the conclusion that there may have been only the three sons of John Lipscomb, and Patsy, -- (Note-see late data-p. 104)

JOSEPH RUSSELL LIPSCOMB, son of John and Patsy (Russell) Lipscomb. was born ca. 1800. He m. 11 Mar.1830, Caswell Co. N.C. Eliza Harralson, who d. fairly soon. He m.(2) Caswell Co., 29 May 1833, Margarette Graves (3 July 1795- d. 1853) dau. of Barjallai and Ursula(Wright) Graves of Caswell Co. (Tylers 19/181). After Joseph's death, she m.(2) Jesse W. Cross.

J.R.E. Lipscomb was apparently (Census Index) on 1840
Fayette Co., TN Census, p. 143. This is born out by
the affadavit in Caswell Co., N.C. Abstracts of Minutes
-1777-1877 - Kath. K. Kendall (1976) p.82-3. -- Apr.,
1856, stating that Joseph R.E. Lipscomb, formerly of
Caswell Co., afterward of Fayette Co., TN ..... knew
sd Lipscomb well and was at his residence in Tenn. when
he died. That sd Lipscomb married, Caswell Co. Margaret
Graves by whom he had one son and only child, Wm. R.

79-B (RICHARD) JORDAN LIPSCOMB, b. ca. 1802 (48/1850 census). Va.(?), son of John and Patsy (Russell) Lipscomb, married, as possibly her second husband, Mary DeJarnette (d. 1836), dau. of George DeJarnette of Pittsylvania Co., Va.. She had m. (1) 22 Apr. 1816, Pitts. Co., Wm. H. Carr, and had three Carr children. ("DeJarnette & Allied Fam."-E.C.Frost). He died 24 Nov.1884 or 1888.

But, -- NO! See next page for later research for clues to the possible fourth son of John, -- Richard Lipscomb!

Just last-minute calculations in behalf of some descendants of Alabama Lips-combs point to the strong possibility that there could have been that fourth son, Richard Lipscomb! Process described, as follows, -- (See p. 101)

79-D RICHARD LIPSCOMB, a fourth son of John Lipscomb (son of Richard G. Lipscomb)?

Descendants of Sarah Lipscomb, widow, of Madison Co., AL had supposed that her husband had been Theophilus Lipscomb whose death is recorded in their family Bible as 1862, with her death as 1868.

Checking the 1850 Census showed that Theophilus was a son, born ca. 1838. And, the 1840 Census, Madison Co. shows on p. 178, —

Richard Lipscomb: males 1 under 5; 1 10-15; 1 15-20; 1 30-40 females 1 " 5; 2 5-10; 2 10-15; 1 30-40

No Alabama record on 1830 Census, but, back in VA, Charlotte Co., p. 234, --

Richard Lipscomb: males 1 under 5; 1 5-10; 1 20-30 (9 slaves) females 2 " 5; 1 20-30

And, a Charlotte Co., VA marriage record, showing bond, -19 Dec. 1823 Richard Lipscomb and Sarah McCargo, Sec. Allen
McCargo (whose identity has not been established)

The 1850 Census, giving names and dates with places of birth of the members of Sarah Lipscomb's family, shows that the first four children were born in Virginia - (as well as Sarah, herself) -- Robert Ae. 24, Martha A.R. 23, Minerva 21, and John 20, -- the next child, b. Alabama, Mary E. ae. 18. (b.1832)

So, this would show that the family had gone to Alabama between 1830 and 1832.

It all fits so perfectly, and consequently, the family of descendants has been outlined on pages 507-8 under the number 79-D. Further proof may sometime be found.

# 68 DANIEL LIPSCOMB, Son of George Major Lipscomb (p.79)

DANIEL LIPSCOME, son of George Major Lipscomb, would have been born anytime between 1750and 1765. He married, 1792 Jane (Lipscomb?) Frazer, widow of John G. Frazer (See p.79). He died 1797 after which his widow, Jane took over the taxes. We know so very little about Daniel.

On 3 Nov.1792 a marriage agreement was written (B.3 p.1&2) in which it was agreed that Jane Frazer might, after her intention of marrying Daniel Lipscomb shortly, be assured, in a complicated arrangement, of receiving all of Daniel's Estate, in case of his death first; of retaining in her name, the slaves due her, but now in her mother's possession, to be divided between her two children, John Gustavus Frazer and Elizabeth Frazer, along with any children born from this marriage; and, that if she should die first, Daniel might enjoy for his lifetime, one third of her Estate, which would go to her children (if they had no issue) at his death. This document was signed by them both and witnessed by Wm. Alvey, Senr., Benoni Lipscomb & Ambrose Lipscomb. Jane was quite apparently the daughter of Jane (Lipscomb?) (widow) who had married (2) Daniel's father, George Major Lipscomb— all in the family!

Daniel lived only until 1796/7 when his taxes stopped, with apparently no issue. Jane did deed, 4 May 1800 (B.3pt.l p.460) to her daughter, Elizabeth Frazer one half of her Estate, retaining the use of it during her own lifetime. No record of a similar deed to her son, John Gustaves Frazer.

Daniel accuired 64 acres 9/2, 1793 Alterations, from J.G. Frazer estate, which, added to the 61 acre deed from Benoni, totalled 124 acres which went to Jane. By 1814, Jane had married (3) Mourning Lipscomb. (See p. 141)

# 69 LUKE LIPSCOMB, Son of George Major Lipscomb (p. 79)

LUKE LIPSCOMB, son of George Major Lipscomb would have been born ca. 1756. He was my introduction to the Virginia family of Lipscombs, when I found that he was the father of, and had signed the permission to marry for my Milly Lipscomb, in Halifax Co., Va. - where she married my Moses Overton, on 25 June 1801 and soon went to Kentucky. Then, came to deeds to John Mill from the heirs of George Major Lipscomb, -- and then, the whole family unfolded, with much difficulty, since 1967, with years of research.

Luke Lipscomb's brief encounter in the Revolutionary War is shown on the one certificate, dated 21 May, 1777, "Company formerly belonging to Capt. HoltRicheson of the 7th Virginia Regiment of Foot, commanded by Alexander McClenachan, Esq." This voucher shows, under "remarks" -- "Deserted Jan'y 15. 1777". Let us hope that it was not an altogether dishonorable desertion!

Luke must have married ca. 1780 in either King William Go., or, more probably in Amelia Co. where he was listed, in 1779, on the Nottoway Parish tithe list of Stith Bolling, near Richard G. Lipscomb, his brother, and Uriah Lipscomb and his father, Benjamin. All three of these Lipscombs signed a petition, 1781, from Amelia County inhabitants, asking that their militia be furnished with arms and amunition, since so much of their own supplies had been confiscated by plundering British troops. (Executive Papers, reported in the "Virginia Genealogist" Vol 18 (1974) p. 288-290)

On 6 Aug. 1782, Amelia Co., Luke Lipscomb was surety and witness to consent

106 along with Ellis Evans and James Hollingsworth), in the marriage record of Rhody Phillips and Ann Isbell.

The name of his wife is not known. She had died before his death-before 28 Apr. 1803. Names in the above marriage record, as well as other witness-to-document names have been researched in hope of finding clues as to her identity. No record has been found in Amelia Co. marriage lists.

Luke Lipscomb seemingly did not own land for any length of time, - none in Amelia Co., where his Personal Property Tax in Oct.1782 listed 5 white, 1 black, but the Bolling tithe list of 17 Apr.1782 showed 1 white (over 21), 1 horse and one slave, Daphney.

By 1785, he had taken his family to Halifax Co., and, on 7 Sept. 1790, he bought 158 acres of land, £55, bound by John Cobb, Thos. Walters and John Walters, from Thos. Walters. (Hal.D.B.18 p 381).

This 158 acres he sold the next year, 27 June 1800, for 170 (at least he made 115 in the deal!). land on Staunton River in Halifax Co. to his brother Richard G. Lipscomb. This deed (Hal. Co. D.B. 18 p.450, or 458?) was witnessed by Wm. Roberts and Jane Dickerson.

Luke was the second of George Major Lipscomb's children to make his deed to John Mill for land inherited from his father. His deed dated 11 Dec.1801 was recorded 26 Apr.1802 back in King William Co. (B.4 p. 101). It sold to John Mill, for \$120.00 "the one sixth part of that tract or parcel of "Land which George M. Lipscomb late of King William County died seised off situate "in said County of King William and now in the possession of Jane Hornet, Benoni Lipscomb and Jane Lipscomb, the one sixth part of which tract contains by estimation thirty two and two thirds acres be the same more or less, including the one sixth part of that part of said tract allotted to the widow of the said Geo.M.Lipscomb and now in her possession and to pass to said John Mill at her death by virtue of these presents and devised to the sq Luke Lipscomb by virtue of the last Will and Testament of his father Geo.M. Lipscomb, dec'd...."
Complicated, -- wasn't it!

Luke's name showed on Pers. Prop. tax list, Halifax Co., 1802, North Distr., and the 1803 tax list showed Luke Lipscomb "Est." So.not very old, he had died 1802 or 3, apparently intestate. His son-in-law, Daniel Parker was Administrator, and his Inventory (Hal.W.B.6 p.499-500) showed 1358-7-0, taken by Wm. Thweatt. Jose Nichols and John Martin.

Luke's children were --

- BETSEY LIPSCOMB, born ca.1782(?); married Daniel Parker 20 Mar.1799 (See p.107)
- 81 LUCY LIPSCOMB, born ca. 1783/4; married Gabriel Beasley 24 Sept. 1804 (See p. 107)
- MILDRED (MILLICENT) LIPSCOMB, born ca.1785; married Moses Overton 25 June 1801 (See p. 107)
- JASON LIPSCOMB, born ca. 1786-91; married Nancy Hood 1 Mar. 1811 (See p. 112)

It is apparent that Moses Overton and his new bride, Mildred, were anxious to be on their way to Kentucky, because the Nov. Court 1803, Halifax Pleas Book 22 p.144 shows that they, with the sister, Lucy, and brother, Jason, an infant, sued Daniel Parker, Administrator et al. for their equal parts of the slaves and other personal estate that Luke Lipscomb died possessing.

# DESCENDANTS OF LUKE LIPSCOMB, son of George Major Lipscomb

This portion has been assembled by the compiler, herself a descendant of Luke Lipscomb, - from Census records, family histories, records and traditions.

### 80 BETSEY LIPSCOMB, Daughter of Luke Lipscomb (p. 105)

BETSEY LIPSCOMB, daughter of Luke lipscomb (wife unknown) would have been born ca. 1782, probably in Amelia County. She married 28 Mar.1799, in Halifax Co. (where the father had taken the family by 1785), Daniel Parker, who was later to be appointed Administrator of his father-in-law's estate in 1803. He was vestryman in Antrim Parish Church, 1803 and 1807. He witnessed Luke's permission, 1801, for Luke's daughter, Mildred's marriage to Moses Overton.

There are records of an earlier marriage, 15 Mar. 1781, Halifax Co., of a Daniel Parker to Mary Ann Easley. Also, partial records of a will of 10 Apr. 1809, Halifax Co., for a Daniel Parker, showing legatees, Betsey Parker, Isaac, Patsy, Phebe, Polly and William. (If a father, - no son Daniel!)

Otherwise, the 1840 Census, Halifax Co., North District, shows,-Daniel Farker 70-80; wife 60-70

Then, 1850 Halifax Co., North District, p. 13, -Elizabeth Parker 60 \$235 (R.E.) born, VA (no other names)

### 81 LUCY LIPSCOMB, Daughter of Luke Lipscomb (p. 105)

Blucy LIPSCOMB, daughter of Luke Lipscomb, would have been born probably ca. 1783-4 in Amelia or Halifax Co.. She married, 6 Oct. 1804, Gabriel Beasley in Halifax Co.. No further proven records have been found for this couple, except that possibly Gabriel was the legatee in the will of John Beasley, 24, Feb. 1801, Charlotte Co., VA.

A Gabriel Beasley married, 14 July 1835, Wake Co., N.C. (2nd Co. So. of Hali-fax Co., VA), Mary Ann Smith. Was this a second marriage? Or, a son's mar-riage?

### 82 MILDRED LIPSCOMB (MILLICENT), Daughter of Luke Lipscomb

MILDRED LIPSCOMB, was born ca. 1785 (was 65 in 1850 Ky. Census) in Amelia or in Halifax Co., VA. She married 25 June 1801, Halifax Co., Moses Overton, son of Wm. Overton, and his wife, Judith (Brumfield) Overton of Charlotte Co.. Herfather, Luke, signed her marriage bond. (Hal. Co. Record)

Mildred and her husband, Moses Overton, after collecting the inheritances from both their parents, left around 1806 for Kentucky, where they settled in Gallatin Co., by 1809. He died 1 Apr. 1815 as a soldier in the War of 1812, leaving Mildred with eight children and a mortgage on the 117-acre farm on Corn Creek. Her sons helped to keep the family together, and to save the farm. In 1836, the area where they lived in Gallatin Co. was partitioned, and became Trimble Co., Ky.

Turn page, --

On the Tax lists, after her husband's death, she became "Milly" Overton, as well as on the 1820 Census, and then by 1840 Census, and concurrent tax lists she began to use the name "Millicent". It is interesting to note that the name Mildred appeared several times in the Lipscomb family, - in the line of George Major Lipscomb, and of his supposed brother Henry. Luke had named his daughter "Mildred" for his sister who used the name "Millicent" interchangeably. (See her deed p. 113). Had there been a favorite Grandmother who bore the same interchangeable names? Many avenues have been searched, with no results. Millicent (Lipscomb) Overton died by 9 Dec. 1850, Trimble Co.Ky.

70 MILDRED (MILLICENT) LIPSCOMB (Dau. of George Major Lipscomb) (p. 79)

MILDRED (MILLICENT) LIPSCOMB, only known daughter of George Major Lipscomb, could have been born anytime 1760 to 1775 (See Census records below). She married Martin Turner, possibly in King William Co., Va., and, so far, we have found no record of them until, for instance, 1812 King William Co. Land Tax, -- Martin Turner - 29 acres, tax 12¢, (Millicent's part)

At some time, they had moved to North Carolina. Their deed, dated 23 Sept. 1813, recorded in King William Co.. 6 June 1814 (B.6 p 331-333), from Martin Turner and Millicent, his wife, of Caswell Co., N.Car., to John Mill, for \$120, for 1/5th part of the tract which George M. Lipscomb, late of King William Co.died seized off situate.... 43 acres by estimation (29 acres in lot #1. and the balance now in possession of the widow of George M. Lipscomb - to pass to s. John Mill at her death, and also their interest in the part allotted to Jane Lipscomb, widow of Daniel, now in possession of Mourning Lipscomb and Jane, his wife, to pass, at her death, to John Mill. (Complicated, isn't it?) The deed was signed by Martin Turner and "Mildred" Lipscomb. (Note the interchange of names!) It was witnessed by Jno. Camm Pollard, Madison Lipscomb, Wilson C. Pemberton and John Lipscomb.

The document on p. 332-3 is a deposition from Caswell Co., N.Car., certifying Millicent's willingness to sell. Thus, John Mill was almost completing his purchase of George Major Lipscomb's land. (See p. 80)

Further accounts of Millicent and her husband are scarce. The 1820 Caswell Co., N. Car. Census shows --

Martin Turner-Males 1 -16 1 over 45: Females 3 -16,1 -45, 1 over 45 (10 slaves, all over 26.)

(were they both born before 1775, then?)

# 71 BENONI LIPSCOMB . Son of George Major Lipscomb (p.79)

BENONI LIPSCOMB, one of the oldest sons of George Major Lipscomb, was born ca. 1757 (See Pension record). It is to be wondered if, by chance, he might have been the last son born to a very first wife of George Major Lipscomb. "In the Bible, Rachel died at the birth of a son who was named BF-NONI, 'child of my sorrow", hence this name was often given to a boy whose mother died at his birth." -("Hale, House and Related Families" --Jacobus and Waterman, p.582).

Benoni married Mary Cole Lipscomb (?), apparently (but without proof) one of the daughters of Jane (\_\_\_\_) Lipscomb who became George Major Lipscomb's last wife. He died sometime after 25 Apr.1819, one of the dates mentioned on his Pension payment records. His taxes had stopped in 1816.

Benoni's Pension request. 23 Mar. 1819, at age 62, declared that he had en-

listed in the Revolutionary Army (DAR acceptance) for three years, on the 1st listed in the Revolutionary Army (DAR acceptance) for three years, on the 1st day of January, 1776, in King William County, in the Company commanded by Capt. James Gray, Regiment commanded by Col. James Innis, in the line of the State of Virginia, on the Continental Establishment. Having fought at the battles of Stony Point, Brandywine, and Germantown, he was discharged late in 1779, at Philadelphia, Pa.

1786 Tax Alterations shows a transfer of 50 acres, 6/11, to Benoni from Jane Lipscomb, by deed (payable 1787)

13 July 1810 (B.6 p.3) Jane Hornett (who had been, as above, widow of George Major Lipscomb) probably the mother of Benoni's wife, Mary Cole Lipscomb, deeded to Wm. Gregory, trustee of Benoni's wife and her children. Susannah, Thede, Milly Cole, Thornton Claiborne and Austin Lipscomb, for love and affection, for 1.00 the following negroes- Sarah, Palmer, Sarah, Tom, Nelly and child. This is a very good indication that Mary Cole Lipscomb was Jane's daughter.

Benoni was the first to deed part of his inheritance to John Mill. (B.4 p.65—6) on 16 Apr.1801. for \$31, he deeded his 1/6 part of land now in possession of Jane Hornett. late Jane Lipscomb, which was to be divided between Benoni and the other heirs, at her death. (See p. 80) (His deed, See p. 78)

On 6 Feb.1813 (B.6 p.257 Benoni and Mary Cole Lipscomb deeded to his brother, Ambrose Lipscomb (G.M.), for \$116., his 29 acres, bound by Wm. F. Olonne, Martin Turner's representatives, Theodorick B. Lipscomb (Benoni's own son), Jane Lipscomb (widow of Daniel) and Ambrose Lipscomb (G.M.) (See p.81)

Then, 27 June 1814, (B.6 p.342) Benoni and Mary completed their deeds. by deed-in to John Mill, for \$6., his portion of interest in the parcel allotted to Jane Lipscomb, widow of his brother, Daniel.

Benoni and Mary Cole Lipscomb had the following children (determined from the deed above from Jane Lipscomb, her probable mother,) --

#### 84 SUSANNAH LIPSCOMB, daughter of Benoni Lipscomb (p. 113)

SUSANNA LIPSCOMB, the first named child of Benoni and Mary Cole Lipscomb, in the deed of 13 July 1810, from Jane Hornett (apparently the mother of Mary Cole Lipscomb) (See p. 79). - to her grandchildren, Susannah, Thede, Milly Cole, Thornton Claiborne and Austin Lipscomb, - was probably the oldest child, and perhaps born ca. 1790. Nothing further has been found regarding her, after the date in 1810.

#### 85 THEODORICK BLAND LIPSCOMB, son of Benoni Lipscomb (p. 113)

THEODORICK BLAND LIPSCOMB, called "Thede" in Jane Hornett's deed of 1810, son of Benoni and Mary Cole Lipscomb, was no doubt named for the popular Revolutionary War personality, Col. Theodorick Bland, in the Continental Line. He was born between 1790 and 1794, as calculated from Census records.

King William County records show a deed, 12 Dec. 1809 (B.5 p.405 or 426?) from Christopher Johnson and Elizabeth Y., his wife, for 160 acres, called "Greens", to Theodorick B. Lipscomb. He paid taxes on these 160 acres from 1810 through 1816, - 4 miles S.E. of the Court House. This was reduced to 27 acres by his sale of 148 acres to T.T. Neale, recorded 24 Mar. 1817 (K.Wm.B.7 pt. 1, p. 78) - land on Cohoke, adj. Wm. Olonne and Thos. Jones. In 1818 (Ibid p.314), he sold 2 acres to Thos. Douglass, - then, (Ibid p.375), the remaining 25 acres to Thos. Douglass. Apparently no further land holdings, at least through 1829.

On 1817 list of members, he is shown as a member of Collosse Baptist Church.

His Census records, all King William Co., show several sons, and only one daughter. ---

Theodorick B. Lipscomb, she quoted, married (1) Fauntleroy, and had two sons. John and William Peter who went west (Wm. P. settled in Arkansas) after their father had married (2) Sarah (Sally) M. Hargrove (b. 1798 - d. 1860 K. Wm. Co.), and that the children of Theodorick B. and Sarah M. Hargrove Lipscomb were, -- (without dates, or order of births) --

It is difficult to reconcile all these sons, by name, with the census records by ages, especially since the DAR application of Jammie Williamson shows Wm. Peter was born 25 Mar. 1827 (if he had been one of the two first sons). And, we do not have a date for the second marriage of Theodorick to Sarah M. Hargrove.

However, let us try to put the family together as best we can, with the details available, --

# MILLY COLE LIPSCOMB, daughter of Benoni Lipscomb (p. 113)

MILLY COLE LIPSCOMB, third named grandchild — in the deed from her grandmother, Jane Hornett, would have been born between 1790 and 1800, daughter of Benoni Lipscomb and his wife, Mary Cole Lipscomb. She was probably named for her aunt, Mildred Lipscomb, daughter of George Major Lipscomb, and for, possibly the fact that her mother was named Cole for her middle name, because quite possibly, Mary's mother, Jane, had been born a Cole, as is thought by Dr. Harris, -gr. dau. of Capt. William Cole. (See p. 79)

The later life of Milly Cole Lipscomb is not known, but it might be well to check to see if she might have become the Milly Cole Alvey of later records.

# 87 THORNTON CLAIBORNE LIPSCOMB, son of Benoni Lipscomb (p.113)

THORTON CLAIBORNE LIPSCOMB, having the middle name, Claiborne, also points to the probability that the children's grandmother, Jane, had been a Claiborne before marrying, first, a possible Lipscomb, and having two daughters. Jane and Mary Cole. (See p. 79)

His 1850 Census, indicating age 60, would show his probable birth date as 1790, and the "Gentry Family in America"- Richard Gentry, Kansas City, 1909, p.107, gives his birth date as 5 Oct. 1790, in listing his marriage, ca. 1816, Henrico Co., VA, to Mary (Polly) Gentry (1796-1863), dau. of Wm. Gentry. This lists his death date as 7 Apr. 1871. Henrico Marriage Bonds, however, lists his marriage date as 7 Dec. 1814 (at least the Bond date).

They apparently continued to live in Richmond, VA, where the 1840 Census shows five sons and two daughters, and 9 slaves. Some of the children were married and away by 1850, when only three of the children appear, p. 287, Henrico Co. Census, -- 863/947,--

So, of their seven children, we can only list the 3 youngest ones, --

#### 88 AUSTIN T. LIPSCOMB, son of Benoni Lipscomb (p. 113)

AUSTIN T. LIPSCOMB, last named grandchild in Jane Hornett's deed of 1813, son of Benoni and Mary Lipscomb, was also born between 1790 and 1800, judged from Census record of 1830, K. Wm. Co.

Data came just recently from Stephen A. Lipscomb, Jr., P.O. Box 413, Frank-lin, VA, 23851, indicating his descent from Austin T. Lipscomb and wife, Elizabeth, whose son, Charles R. Lipscomb, married 29 Nov. 1855, Martha F. Whitehurst in Princess Anne Co., VA This information agrees with what had already been found (See p. 114) -- even to his statement that his father had jokingly told him that his third given name was "Budlong" (tho' not recorded as such in the Bible). So, had the Mary D. Budlong in the Richmond, VA record have been Mary Elizabeth Budlong?

Since the only other contemporary Austin Lipscomb of record, in Virginia annals, was the one in King William Co., (son of Daniel and Jane Lipscomb (p. 408) who married Mildred (Lipscomb) Ollone (p. 358), (widow), daughter of Capt. Bernard Lipscomb, - and is well documented, - it will be safe to assume that this Austin T. Lipscomb of the Richmond Marriage record, 1829 (p. 114) was the son of Benoni Lipscomb, and the ancestor of this branch. Further research should be done to confirm it.

The 1830 Census record, -- p.73, line 20, shows, --

Austin T. Lipscomb: males: 2 5-10; 1 30-40 2 slaves
females: 1 20-30; 1 30-40
(the 20-30 probably his wife, the 30-40 probably a mother)

It is impossible to explain an 1829 marriage, and yet two sons age 5-10. Could an earlier Henrico Co. Marriage Bond be his also? -- Augustine T. Lipscomb married Lucy P. Foster (dau. of Joseph), 9 Nov. 1820.

Austin T. Lipscomb paid land tax in King William Co., 1826 through 1829 (as far as checked!) on 63 3/4 acres, 8 miles S.E. of C.H., adj. J. Howard, Estate and the Lower Church (St. John's). His name is not found on the 1840 K. wm. Co. Census Index, and so far, no widow's census record would seem to correspond.

In any case, the report in "Lower Norfolk Anticuary", Vol.IV, p.94, listing the marriage "Charles B. Lipscomb, ae. 25, sgl. b. K. Wm. Co., son of Austin T. Lipscomb and Mary E. Lipscomb, Merchant, and Martha F. Whitehurst, ae. 22, sgl., b. Princess Anne Co., dau. of Nehemiah & Anne E. Whitehurst" Nov. 29, 1856, - Marriages performed Rev. H.J. Chandler, Bapt. Minister. P.A. Co.

would surely be acceptable proof, despite year and middle initial differences.

We can, now, start with the son Charles R.Lipscomb (were there other sons?) from the information from Mr. Stephen A. Lipscomb, Jr.'s Bible and personal knowledge records, -- unless otherwise stated, most were born Norfolk, VA.

(and, quite evidently not one of the two sons, ae. 5-10 in 1830 Census, and probably even born after the Census was taken); married 29 Nov.1855, (Pr. Was it this Ambrose Lipscomb who inserted the item in the Virginia Gazette of May 25, 1769 (Purdie's) dated 23 May, 1769, King William Co. "I intend to leave the Colony in a short time." Was this in order to go to Hanover Co. to assume his father's lands? Was it coincidental, too, with his marriage to Elizabeth Claiberne? (The term "Colony" is not understood) (Maybe County?)

On 25th of August, 1769, Ambrose Lipscombe, Holt Richeson and others were sponsors at the christening of Molly Gregory, daughter of Roger Gregory and his first wife, Mary Cole Claiborne, sister of Elizabeth Claiborne, ("Winstons of Virginia") in King William Co.

Ambrose Lipscombe was a Captain in the Hanover County Militia, during the Revolutionary War, and is mentioned in Robert Pollard's application for Pension (Nat'l Archives), saying that --

".. In the spring of 1782, he marched as drafted militia man from the County of Hanover under the command of Capt. Ambrose Lipscombe to guard and carry British priseners from Gold Hill near Hanover Town in Hanover Co., to Winchester in Frederick Co. .... duty 2 weeks."

Ambrose Lipscombe is also listed on Hanover Co. Public Service Claims (VSA) Court Booklet I 3,6; Certificate 1; List II 2; Commission Book III 182.

The Vestry Book of St. Paul's Parish, Hanover Co. shows that his land, which had been his father's was processioned in 1779 (p. 500). Here, Ambrose was a vestryman 1779 through 1786 (p538 and on).

He was listed on Hanover Co. tax records 1782 to 1794 when he died. A deed 15 Oct.1787 records that Thos. Pleasant Johnson and Susan, his wife, sold to Ambrose 219 acres, called "Ginger Bread", in St. Paul's Parish, on Mrs. Talley's Branch.... and Mr. Chapman's Mill Creek. (22W(1)122)

A number of additional items are included among the papers in the Brock Collection at the Huntington Library, Pasadena, California - on the Hanover Co. Lipscombes, and copies of the records have been carefully studied.

Ambrose Lipscombe was appointed sole Executor in the will of his brother, John, probated May 1784. He advertised the sale of his lands 4 July 1785, and encountered some difficulty in making necessary collections through 1787.

In Apr.1785, Ambrose Lipscombe was appointed and posted bond as Inspector at Page's Warehouse. In 1786, he was a Justice in Hanover Co. On 6 Oct. 1791, he and Nathan Talley were appointed Inspectors of Tobacco at Page's Warehouse.

Elizabeth (Claiborne)Lipscombe apparently predeceased her husband, who died at age around 49, at their family home "Merry Oaks" 21 Oct. 1794 after an illness. He died intestate, having given some verbal directions as to the division of his estate, which included 13 slaves.

Capt. Ambrose Lipscombe and his wife, Elizabeth (Claiborne) Lipscombe had the following children --

NATHANIEL CLAIBORNE LIPSCOMBE, eldest son of Capt. Ambrose and Elizabeth (Claiborne) Lipscombe was born ca. 1771, and named for his mother's father, Nathaniel Claiborne. He inherited his father's "Merry Oaks".

He was in the Hanover County Militia as evidenced by the certificate in the Brock Collection, saying --

"At a Court-Martial held for the 7th Battalion of the 93rd Regiment, at Mr. James H. Lynch's orders on the 26th day of May 1798, -- Nathaniel C. Lipscombe, a private in Captain John Bowers company of Militia, is fined Seventy five cents for having failed to attend a private muster in April last."

He must have married, by about 1790, Margaret Booth, daughter of George and Mary (Talliafero) Booth of Gloucester Co., Va. - as his first wife.

He was administrator of his father's (Capt. Ambrose) estate after his death in 1794.

His 1810 Census, Hanover Co. record is -- p.898, line 19

3 May, 1815 Nathaniel Claiborne Lipscombe was granted a license to sell wines and later, on 25 June 1839, Hanover Court granted him a "license to keep a house of Private entertainment at the Merry Oaks, he having paid to the Sheriff of this County five dollars, the tax on the said license." (Brock Coll.)

The date of his first wife's death is unknown, but in November, 1798, he married a second wife, Mary Bledsoe Sutton (who died in 1855), daughter of James and Fanny (Powell) Sutton. (G.H.S.King p.187)

The 1840 Hanover Co. Census. for Nathaniel C. Lipscombe, shows, p.98, --

Males 1 20-30; 1 60-70 (Many slaves, 8 in agriculture) Females 1 30-40; 1 40-50; 1 50-60

Nathaniel C. Lipscombe died in 1847. His last will and Testament was dated 18 Jan.1847, Hanover Co., witnessed by Sam'l R. Wingfield, William H. Timberlake and James A. Waddill. It was recorded 24 Feb.1847 at a "Court of Quarterly Session continued and held for Hanover County at the Court House". Somehow a copy had been preserved, and it is published, in full, in the Article by George Harrison Sanford King in Tyler's Quarterly Vol. 33, pp.179-182. His son, Nathaniel C. Lipscombe, Jr., Executor.

In his will, he "lent" to his wife, Mary B. Lipscombe, during her widowhood, the land where he lived, in Hanover Co., all farming equipment, twelve

slaves (named), and all residue not otherwise disposed of in will. Upon her death or remarriage, all which he had "lent" to her was to be divided among four of his daughters, Martha P. Wingfield, Marietta A. McGee, Rebecca A. Grubbs and Frances J. Franklin, - and his granddaughter, Jane L. Green (daughter of a dec'd daughter of his). Maria S. Youngs' children were not mentioned, but he had noted that he had already provided for her by deed.

His two daughters by his first wife are not mentioned. Margaret Booth Lips-combe had perished in the Theater Fire at Richmond, 1811, with her aunt. And, no further records of Eliza Lipscombe have been found.

To each of the four daughters, and to the granddaughter, Jane L. Green, he gave 2 or 3 slaves.

To his son, Nathaniel C. Lipscombe, Jr., he gave that part of land Tying to the north of the road leading from "Merry Oaks" to Langford's, - and from "Merry Oaks" to the Hanover Co. Court House. To his son, Roscow, nothing, since he had already given him his full portion.

From earlier records, from his will, and from Census records, we can name the children of Nathaniel Claiborne Lipscombe, Sr., and his first wife, Margaret Booth, --

SPOTSWOOD LIPSCOMBE, second son of Capt. Ambrose and Elizabeth 93 (Claiborne) Lipscombe was born 4 Dec. 1778, Hanover County. He married on 7 July 1799, Elizabeth Smith Pendleton (12 Aug.1782-9Aug.1861) daughter of John Pendleton of Richmond. They eloped from a picnic, going to Maryland where they were married in Charles Co., some little distance, by Rev. John C. Brockenbough, Rector of Wm. & Mary Parish ("Maryland Records"-Brumbaugh. p.488-Charles Co. Marriages)

He is listed on Henrico Co. Census, 1810 p 1007 #21 --Males 1 26-45 Females 3 -10; 1 26-45 10 slaves

His correspondence is preserved in the Brock Collection, beginning with a letter 15 Feb. 1811, from Lexington, Kentucky, to his wife back in Richmond, urging her to keep the lumber mill running there, but painting a plaintive picture of his attempts to find new locations in Kentucky which he could afford.

By a letter addressed to his brother 2 Feb. 1812 from Scott Co., Ky, his spirits were high, and urged Nathaniel C. to come to live there on adjacent land where crops would be profitable. His wife and children had evidently joined him. But subsequent correspondence with his brother continues in a pitiable vein, with many problems dealing with selling of crops and pork, and many debts, from Knox Co., Ky. Cumberland Falls, 1814, and later from Orroville, Tenn., 22 Feb. 1822 saying that "the burning of the station has well nigh ruined me, my loss being from eight to nine thousand dollars". He mentions "in all having had 15 children", but most of those must have died (see 1830 Census).

His letter 11 Feb. 1824 from Bean Station, Tenn. claimed that he was "almost bankrupt", but says "my family are all well and unite with me in best wishes for the health prosperity and happiness to yourself and family .. ". Spotswood died 10 May 1827, at Tate Springs, Tenn.

His family apparently stayed in Grainger County, Tenn. and the 1830 Census for that County shows -- p. 405 #6 -- his widow --

Elizabeth Lipscombe Males 1 20-30 (son, Nathaniel Edmund Pendleton) Females 1 5-10; 1 10-15; 1 15-20; 1 40-50

The son, Nathaniel Edmund Pendleton Lipscombe, wrote a letter 25 Apr., 1829 from Bean Station, Tenn. to his uncle Nathaniel Claiborne Lipscomb reporting on the little family, and saying that he would very much like to see his relatives in Virginia or to hear from them. Six of the children were still living. Mary, the eldest had married Dr. John Lide; Ann Virginia, the next, had married Dr. James W. Metherland - (?) and lived in Sullivan Co., Tenn.. Caroline was 15; Helen Maria 10; Margaret 8; and he was in his 22nd year.

Caroline (1815-1878) married, in July 1837, Dr. Miles Smith (1809-1868) at Chatanooga, Tenn.. And, Margaret seems to have married a \_\_\_\_ Moor, since we find, on the 1850 Tenn. Census Index, McMinn Co., Tenn. 498-514 --

"Elizabeth Lipscomb(e) ae. 71 b. Va.; Margaret Moor 25 b. Tenn."

Son, Nathaniel Edmund Pendleton Lipscomb does not show in the 1850 Tenn. Census Index. Did he leave Tennessee? Did he marry and have children?

Elizabeth Smith (Pendleton) Lipscomb is said to have died 9 Aug. 1861.

ROSCOW LIPSCOMBE, son of Capt. Ambrose and Elizabeth (Claiborne)
Lipscombe, was born 1780/1, Hanover Co., Va.. His name, Roscow, comes
from his mother's family. He did not marry.

He died, as. about 22 or 23, apparently at Charlottesville, Albemarle Co., Va., and his obituary appears in the 22 June 1803 "Richmond Examiner" (20 V286)

95 JANE COLE LIPSCOMBE, Dau. of Capt. Ambrose (p.123)

JANE COLE LIPSCOMBE, daughter of Capt. Ambrose and Elizabeth (Claiborne) Lipscomb, was named for her maternal grandmother. Her birth date is not known.

Her first husband, Clark, died by 1803 (10T68). She married (2), 8 Mar.1809, in Henrico Co., Aubin de la Forrest, who had been married first to her cousin, Elizabeth Lipscombe, daughter of her father's brother, John Lipscombe.

Jane Cole Lipscombe died in the tragic Richmond Theater fire, 22 Dec. 1811, along with her niece, Margaret, daughter of Nathaniel Claiborne Lipscombe. Whether or not she had children is not known, but her husband did return to France, taking with him, his two sons (by which wife?)

96 MARTHA (PATSEY) LIPSCOMBE, Dau. of Capt. Ambrose (p. 123)

MARTHA LIPSCOMBE, daughter of Capt. Ambrose and Elizabeth (Claiborne) Lipscombe married William Rawleigh.

Patsey died in 1797, after the death of her father, and William Raleigh evidently hoped to receive her portion of the inheritance. An interesting letter, in the Brock Collection, from John Warden (12 Feb.1798) advises the Administrator that since Patsey had had only a still born child, and that Mr. Raleigh never having had by his wife any living child, he is not entitled to any Estate by courtesy in Mr. Lipscomb's Lands."....(and, re: the slaves and personal estate)— "After the debts are paid Mr. Rawleigh is entitled to one-fifth part of the surplus."

He had apparently offered to release all his right and title ... for "the consideration of 120 pounds & a Mare of a sorrel coler".
