And, then, some of the "early researchers" add another son of

JOHN and DINAH (MACKGEHEE) LIPSCOMB (p.21)

20 WILLIAM LIPSCOMB (?) Son of John and Dinah Lipscomb (p.21)

20 <u>WILLIAM LIPSCOMB</u>, could well have been a son of John and Dinah (Mack-Gehee) Lipscomb, named for his brother, William.

But, no records have been found for him, ---- unless, by some unlikely chance, he could have been the William Mansfield Lipscomb found in Craven Co., N.C. records of 1758,-- (See p. 205).

Throughout the years, there were a number of unrelated records for various William Lipscombs in King William Co., but it has been impossible to piece them together to make a plausible pattern. None seem to have any special significance.

Here end the available records of the line of John and Dinah (MackGehee) Lipscomb (p. 21)

438 AMBROISE LIPSCOME (As yet, unidentified)

<u>AMBROISE LIPSCOMB</u>----! Now, here is a real puzzler. He had lived in Caroline Co., Va., where he died by 1767. (Caroline Co. was formed 1727-8 from Essex Co., King and Queen Co. and King William Co., and adjoins King William Co. to the northwest.) The Clerk of Caroline Co. must have been a Huguenot, - to have given the French spelling of his name in the few records that are still existent. Deeds and Wills were destroyed by fire, and the Order Books have been abstracted by John Frederick Dorman, so helpful for sifting out bits of information. Joel Hicks has published 'Caroline Co. Marriage Bonds', 1787-1852 (too late to help us), and T.E. Campbell has published "Colonial Caroline- History of Caroline Co., Va.". 1954, from which we can glean some important bits of information.

From this last source, we find (p.480), that the Executors of his estate, 1767, were Richard West, John Young and Melchizdeck Brame, - so he had died sometime shortly before that year. Also, we find, (p.490-1), that Ambroise Lipscomb had been appointed, in 1764 as guardian of Martin Crutchfield, and that the guardianship of George Crutchfield had been transferred to him from that of Richard West. They were apparently sons of Wm. Crutchfield who had died in 1757. After the death of Ambroise Lipscomb, the guardianship of George was transferred to Stapleton Crutchfield.

Then, keeping it all in the Crutchfield family, we find (p. 366). 1773, that his widow, Rachael Lipscombe, along with three others had been accused of Tax evasion (Rachael's for failing to list a chaise for taxation!) This was eventually excused by the Court. But, we find that Rachael was a Crutchfield, daughter of William, and also a sister of Martha who married a William Collins. ("Hist. of Collins Fam.- Caroline Co., Va."- H.R.Collins. p.13)

Then, very neatly, we pick up several references ("Spotsylvania Co. Records"-Crozier) for a Philip Lipscomb. involving more Crutchfield connections, - even his wife - Jane Crutchfield, in Fredericksburg. Spotsvlvania Co., beginning in 1779. So, working backward - can we surmise that Philip was born ca. 1745-46, (he was over 45 in 1810 Census), that Ambroise and Rachael had married ca. 1742-45, and that Ambroise could have been born ca. 1722-25?

Ambroise Lipscomb was surely born in King William Co., and would probably have been a son of one of the children of Ambrose Lipscomb II, Pichard, William. John - or even Ambrose or Benjamin (since Benjamin died after 1767. Ambroise would not have been named in his 1778 will, in Amelia Co., Va.- (D. 147), and Benjamin really should have had a son named Ambrose!)

Could he have been closely connected with the Philip Lipscomb I (p.55)? Or, any connection with the John Lipscomb and wife, Judith, who hought land, 1744 in Caroline Co. (0.8.1740-6 pt.2) from Sylivant, and sold it 9 Mar. 1749/50 to William Wills? (That is another puzzle!)

Had Ambroise"gone west", seeking new lands, -- and married there?

In any case, it would seem that Ambroise and Rachael (Crutchfield) Lipscomb had one son, --

439 <u>PHILIP LIPSCOMB</u>, born ca. 1745-46; married Jane Crutchfield by 1779; died ca. 1823-4, Fredericksburg, Spotsylvania Co. (Turn page for Philip)

PHILIP LIPSCOMB, Son of Ambroise and Rachael (p.445) 439

PHILIP LIPSCOMB, surely the son of Ambroise and Rachael (Crutch-439 field) Lipscomb, would have been born as early as 1742-46, -- if, that is. it was not necessary for him to have a guardian appointed, for being underage ca. 1767, when his father died. In some instances, even though the mother is still living, that was considered necessary. If such was not the case here, his birth could have been somewhat later -- even 1750-55. And, his father', marriage and birth dates could also be advanced. There is no evidence in the "Orphans Estates" portion of the extant records (Campbellp. 491. etc.) of a guardian being appointed for Philip.

By 1779, Philip had gone to the "city", -- Fredericksburg, Va., - in the far northeast border of Spotsylvania Co. - actually perhaps not very far from his home in the adjoining Caroline Co.. Other Crutchfields went to Spotsylvania Co., too. Perhaps they went together, before or after Philip and Jane Crutchfield were married.

From Crozier, we gather these events, --

- 2? Oct. 1779 (Spots.D.B. J p.350) recorded a deed of 27 May 1779, a 3way deed, involving the sale of lots #78 & 80 in Town of Fredericksburg, between Philip Lipscomb of Fredericksburg and Jane, his wife. Edw. Voss and Jane, his wife, and Chas. Washington.
- 18 June 1788, Jane's father, Stapleton Crutchfield, died, leaving, in his will, among others, a legacy to his daughter, Jane Lipscomb. (Spots.W.B. E p.947) Stapleton Crutchfield. Berkley Parish, Spots.
- 29 Jan. 1789. Philip Lipscomb deeded to John Crutchfield (Jane's oldest brother, for L200, slaves, goods, etc. (Crozier p. 427)

7 July 1791, Philip Lipscomb and Jane, his wife, of Fredericksburg deeded to John Crutchfield of Spotylvania Co., Lot #81 in Fredericksburg. Recorded 1 Nov.1791 (D.B. N) (for securing a bond)

During the Revolutionary War, Philip is credited with Public Service, --Spotsylvania Co. Court Book, p. 12; ; List 6.7.9 (DAR acceptance) His taxes began, of course, in Spotsylvania Co., 1782. and, in 1783, he is reported (4V294) to have 12 slaves.

His Census records. --

1810. Fredericksburg Corp. -- p. 47, Spotsylvania Co., - (or, 109?) Philip Lipscomb: males 1 over 45 10 slaves. females 1 16-26: 1 over 45

1820. same , p. 82 --Philip Lipscomb: males l over 45 ll slaves. females 1 26-45; 1 over 45. & 1 under 10 (granddau?)

An extra John Lipscomb shows up on 1820 Census, in Fredericksburg, under 45, so it seems safe to assume that he could have been an older son, not in 1810 Census. So, did Philip and Jane have a son, John, as well as the one daughter ? Philip's tax of 1824 is marked "Est", so he had died. The report is that Jane, his wife. was born 1759, and died 1827. Their children, --

440 JOHN LIPSCOMB, b. before 1794; m. ; a daughter b. before 1820. 441 A DAUGHTER, b. 1784-1794; married (?and had a daughter under 10,")

442 AMBROSE LIPSCOMB (Son of LOT) (As yet, unidentified)

442 <u>AMBROSE LIPSCOMB</u>, Lott was born possibly ca. 1745-50, and probably in King William County, Va.. The use of the identification "Lot" in 1780, and of "Lott" in so many other records, poses a problem of identification. Was he a son of a Lot Lipscomb? Was his mother named "Lott"? Was he called "Lott" because he owned lotts?

There were a few families named Lott in Virginia, but none have been found in the near vicinity. For instance, Marriage bonds, Norfolk Co., Va. show the Manuel lott married Mary Wright, 20 Mar.1753 (SW(2)100). So, that seems an unlikely solution. No Lott family research has, so far, produced results.

In 1783, through 1799 Land Tax lists, there are a number of designations such as "Meredith Lambeth, Lotts", with no acreage given. then, beginning 1785 they show, eg. "Gilbert Leigh, Lotts at W.Point", no acreage. The term "Lotts" evidently indicated that they owned lotts. but usually at West Point. Ambrose Lipscomb's 1782 Land Tax listing showed that he had 862 acres, -- was this considered a "lott"? And, did the name stay with him? Sounds far-fetched, - but, name another clue!

His first reference is on the 1780 King dilliam Co. Specific Tax list, --

"Mar. 23 Lipscomb, Ambrose (son of Lot) 6 bushels of Corn.

His Land Tax, begins, 1782 and 1783 -- 862 acres, 9/2. The 1785 Altera-... tions lists--

"Heir^d Ambrose Lipscomb Lott. of James Hughes 150 (acres)" This brought his total to 236 acres on 1785 and 1787 List. (no 1786 available, and none for 1788-92). There are no more Land taxes for Ambrose Lott, but his last record is the 1787 Personal Property Tax, which shows himself plus one son between 16 and 21 years. Then, the 1792 Alterations. show --

Going back to the "heird land, - 150 acres from James Hughes, we wonder at the meaning. Had James Hughes been in his mother's family? Some research has been made and few references have been found. James Hughes had been taxed for only the one year for the 150 acres, 5/6, in 1783, and this land had been taxed to Joseph Reynolds in 1782, the previous year.

Researching Joseph Reynolds produced no clues, -- only reference found, so far, has been that a Joseph Reynolds married, 26 Nov.1787, Elizabeth Turner in Halifax Co., Va..- perhaps even the same one after "leaving"K. Wm. Co., but no clue.

But, James Hughes presents an unusual story, -- related in the "Calendar of State Papers" (Va.) Vol.2,pp634 & 638, 1781 Litigation re: prisoners and petition, including James Hughes. Vol. 3 p.56, & Feb.1782 James Hughes confined to jail, - cold and ill, and p. 120, 5 Apr.1782 James Hughes on list of prisoners to be hanged for treason, Henrico Parish, Henrico Co. (Richmond?).

The reason is not given for the charge of treason, but could it have been a matter of Loyalty to the Colonist cause during the Revolution? At any rate, he was pardoned as shown in Vol. 11 Hening Statutes p.21-22, in May 1782. Had he, then, bought the 150 acres from Joseph Reynolds, 1783, (or, had Joseph Reynolds held it for him?) -- and, then, by 1785, given it to Ambrose Lipscomb, Lott, -- as an heir? Heir of whom? The entry in Alterations does not say. James Hughes, "dec'd".

No further references for James Hughes have been found-- except a possible irrelevant one-- Vol. 10"Calendar of State Papers" p.324, 1814, shows a James Hughes as master of "Antelope". (a ship, surely)

Further in-depth study might prove interesting, - and help to identify this Ambrose Lipscomb, Lott.

Now, another very thin, but fairly firm clue should be considered. Was the next-generation Reuben B. Lipscomb a son of Ambrose Lipscomb, Lott? This cuestion is raised because in 1798 Land Tax, Reuben B. Lipscomb begins to pay tax on that 863 acres. Could he have been named "Reuben B. "for the Reuben L. Burras to whom Ambrose Lipscomb, Lott, had sold (or, given?) the 863 acres in 1792 Alterations? And, could that have been a means for the father to have left that acreage to his son, in a sort of trust, for the 11 years intervening?

Could Reuben B. Lipscomb have been the son age 16-21 on the 1787 Personal Property tax list? If so, he'd have been at least 27 years old in 1798, a little old to have to wait. However, Reuben B. Lipscomb could have been a vounger son, born ca. 1772-1780,-? (His wife, Hannah A. , was born ca. 1775-1780 as calculated by Census records, later).

And, now, can you take another knotty question? Could Ambrose Lipscomb, Lott,

have been the father of Elizabeth Lipscomb who married 24 Dec. 1783, Cpl. John Lipscomb .- p. 430? He seems to be the one most likley, - of a proper age.

So, let us conjure up a list of possible children of Ambrose Lipscomb, Lott and a wife whose name is nebulous, -- married ca. 1764 (?). --

ELIZABETH LIPSCOMB, born ca. 1766 (?); married 24 Dec. 1783. K. (?) 143 Wm. Co., Cpl. John Lipscomb;

, born ca. 1766-1771, on 1787 Personal Tax A son 444 list of his father, as being between age 16 and 21.

REUBEN B. LIPSCOMB, born ca. 1772-1780; married Hannah A. ; (?) 445 died ca. 1810 late in the year.

243 ? ELIZABETH LIPSCOMB, "daughter of Ambrose Lipscomb" in the Pension files of Cpl. John Lipscomb, could have been daughter of this Ambrose, - timewise, the most likely. She was born possibly ca. 1766, and married 24 Dec. 1783 (age 17). See p. 430 for further details.

444 The son, age 16-21 on the 1787 Personal Property tax list of Ambrose Lipscomb, Lott, would have been born between 1766 and 1771.

Is there a possibility that the Ambrose P. Lipscomb. estimated birth ca. 1770, could have been this son? And, if so, could the "P." have been for Philip, - a possible father of this Ambrose Lipscomb, Lott? (See pp 56, 451 and 510)

445 REUBEN B. LIPSCOMB (was he son of Ambrose Lot? p.447)

445 <u>REUBEN B. LIPSCOMB</u>, possible son of Ambrose Lipscomb, Lott, was born possibly ca. 1772.

Records of at least five contemporary Reuben Lipscombs have made it diffi-

cult to untangle them, -- Capt. Reuben, brother of Capt. Bernard; Reuben, son of Capt. Bernard; Reuben, son of John who d. ca. 1777; and Reuben, son of that Reuben and his wife, Ann; along with Reuben B. Lipscomb.

The "B" helps to differentiate. And, as pointed out in the previous pages, he could have been named for Reuben L. Burras.

His first Land Tax began in 1798, 865 acres, surely the same tract that his father had turned over to Reuben L. Burras. Later records show that this tract was 8 miles South of the Court House, on Mastico Swamp. No other Lipscombs had land in this vicinity.

On 31 Oct. 1802, Reuben B. Lipscomb and his wife, Hannah, sold to Mourning Foster a tract, 54 acres, for £165, -(K.Wm.B. 4 p.185) - a tract which he had purchased from James Johnson, for £411 earlier in the year (K.Wm.B.4 p. 177 (ouite a loss!).

Then, on 8 May 1804. Reuben B. Lipscomb bought additional land (K. Wm.B.4 p.245) from Alex. Smith, for H153. This is no doubt the 133 acres which was added to his tax, that year, totalling 219¹ acres, then, on through 1820, 10/6, 8 miles So., adj. Betsy, and later James Slaughter, on Mastico Swamp. However, beginning 1811, it is marked "Est.", so he had died.

On 28 Nov. 1808, (K.Wm.B.5 p.262) Reuben B. Lipscomb, along with James Smith and James P. Powell signed a \$500. Bond, to Wm. Cabell, Gov. of Virginia, for the candidacy of James Smith for Constable of the County.

The 1810 Personal Tax listing for Reuben B. Lipscomb showed 1 over 21, six slaves and 4 horses. (The 1800 and 1810 Census records are missing, for all of Virginia, 1800, and several counties, including King William, 1810)

The widow, Hannah A. Lipscomb is listed on the King William 1820 Census, with one son, 10-16 and one daughter 10-16 (born 1804-1810). Her 1830 Census listing shows -- p. 77, line 26, --

Hannah Lipscomb: males 1 20-30 (b. 1800-1810) 8 slaves females 2 20-30; 1 50-60 (self, b. 1770-80) It is difficult to know who the extra female, 20-30, in 1830, was, - but, possibly a relative. But, the one son and the one daughter were, surely, the Ambrose and Elizabeth who appear in Land Tax, 1822, when Reuben B.'s land was divided (as they became of age). They, together, paid tax on the 133 acre tract, and Hannah A. Lipscomb, widow was taxed through at least 1829 for 30 acres "life tenancy". (Last tax year checked)

In 1826, however, the 133 acres was divided -- 572 acres going to Elizabeth. and 814 acres to "Armistead" Lipscomb. The question, then, arises, -- Was the name of the son actually "Armistead", but the Clerk had made the mistake of listing him as Ambrose for those four years, until the division? Guite probably so, because, Armistead does appear in the 1840 Census.

The name, Armistead, surely must come from Hannah A Lipscomb's family. There was a large Armistead family in Virginia, and among them, many Hannah Armisteads, though it has not been possible to locate one to fill this particular spot.

The children of Reuben B. Lipscomb and his wife Hannah A., (who probably lived until after 1840, were --

445-A ELIZABETH LIPSCOMB, born 1804-1810); owned 572 acres through at least 1829; no records further.

ARMISTEAD LIPSCOMB, born 1804-1810; married ca. 1830, name of wife B unknown; was on 1840 Census. King William Co., p.73, line 27. ---

> males 1 30-40 (self, b. 1800-1810) 17 slaves females 1 under 5; 2 5-10; 2 30-40; 1 60-70

The female, 60-70 could well be his mother. Hannah A.

No further record of Armistead has been found. None from this family seem to show on the 1850 Census.

446 AMBROSE LIPSCOMB, U.H. (Under-the-Hill) (Unidentified) 451

Three LIPSCOMBs with the given name of AMBHOSE, in King William County, in the same generation complicate research. The 1780 Specific Tax list shows them as --

(In addition, another contemporary, but less eminent Ambrose Lipscomb, born a little later, son of George Major Lipscomb, (see p. 81).)

These Ambrose Lipscombs have been impossible to place, -- even the Ambrose, son of Jessee, is difficult, since Jessee is also difficult (see p. 75) Ambrose. "son of Lot", would seem to indicate that there had been a Lot Lipscomb (p.447), but such a one has been impossible to locate.

Having dealt with Ambrose, Jessee in another segment, let us now consider the other two, -- (See p. 447 for Ambrose LOT)

446 <u>AMBROSE LIPSCOMB, U.H.</u> was born possibly ca. 1755-60, in King William County, Va.. He was no doubt from the lineage of Ambrose III, John, or William, sons of Ambrose II.

The designation "U.H." was quite a puzzle on tax records and deeds, until finding the document 29 July 1808 (K. Wm.B3 p 40),- "Ambrose Lipscomb of St. John's Parish, commonly called "Ambrose, Under the Hill"...". Some of his lands and dealings might indicate his activities in the area near to the Court House,--- and it would be interesting to know which HILL?

(By some descendants of Philip Lipscomb I (p.56)it has been thought that he had had a son, Ambrose, -- if so, might this be the one?)

His Court records deal primarily with deeds to his children, before his death, apparently ca. 1808-9, and from these we can reconstruct, fairly well, his family.

His wife (in deeds) was Mary (____), married possibly ca. 1775-7 (7W(2) 44). His deeds, --

23 Apr.1799 (rec. 28 Oct.) (K.Wm.B4 p.509) Ambrose to his son, Foster, 25 acres, for 5 shillings, land where he now lives. Wit: George Lipscomb (Foster's father-in-law), Nath'l Gregory. & Rob't Hill.

24 June 1805(K.Wm.B.4 p.336) Ambrose deed to his daughter, Susanna Watkins,-a negro woman.

29 Dec. 1806 (K. Wm.B.5p.110) Ambrose, deed of gift to grandchildren,-Synthia, Robert Moore, Sterling, and John Gresham, children of Stephen Gresham and Mary, his wife.

23 Feb.1806 (K. Wm.B.5 p.146) Ambrose and Mary, his wife, deed to Lumkin Gresham,-50 acres.

- 10 Sept.1807 (K.Wm.B.5 p.157) Ambrose "Sr." (to distinguish him from Ambrose, son of G. M.L., now, since Ambrose "Lott" had died). deed to his daughter, Keziah, "1/3 of land, and particularly the tract whereon I now live".
- 25 Oct. 1808 (K. Wm. B.5 p.256) Ambrose deed to his daughter, Elizabeth Burke, _"1/3 if land", with slaves. (what happened to the other third?)
- 29 July 1808 (K.Wm.B.5 p.267) "Ambrose Lipscomb of St. John's Parish, commonly called 'Ambrose Under-the-Hill'" for \$1.00,-to Harden Littlepage, in trust for his daughter, Mary Gresham, wife of Lumkin Gresham, then to her children, Synthia, Rob't Moore, Sterling, and John, - 7 slaves, and some furniture.

And, possibly another deed, (B.5 p.251) to his daughter, Susanna Watkins.

Tax (land) listings for Ambrose U.H. showed 221 acres, 9/2, 1782- 7, increased to 265 (44 acres added, gained by survey) in 1789, on through 1801. Then, 240 acres (25 off for Foster, 1799) through 1806, then 190 (50 acres off for Lumkin Gresham) through 1810, when it stopped. So, he had disposed of his estate fairly well before his death, (or, perhaps he lived with one of his children, a while?).

The list of his children, derived from the above deeds, then, are --

KEZIAH LIPSCOMB, b. ca. 1789 (?); did she not marry? (on 1820 450 (See p. 454) Census last.)

ELIZABETH LIPSCOMB, b. ca. 1790 (?); m. before 1808, _____ Burke; she died sometime after 1817.(See p. 454) 451

DESCENDANTS OF AMBROSE LIPSCOMB, U.H. (p. 451)

447 <u>FOSTER LIPSCOMB</u>, born, probably ca. 1780, married ca. 1799, Mary Lipscomb, daughter of George Lipscomb (p 369). He died ca. 1809-10,- his Land Tax shows as "Est". in 1810, 25 acres which his father had given to him probably at the time of his marriage to Mary.

His wife, Mary died, Intestate, 1815 (as evidenced in the litigation of the settlement of her brother, Lt. Daniel Lipscomb's military estate(p. 367)

Their children were ---

447-A ANN LIPSCOMB, b. ca. 1800; m. Wm. Watkins (no further research)

B <u>OVERTON LIPSCOMB</u>, b. ca. 1801 (?); was possibly the Overton Lipscomb, of Richmond, who m. 18 Feb.1817, Mary Ann Dillon of Richmond, Rev. Mr. Matthews. (Nat. Gen. Soc. Vol.28 p. 115)

> Overton Lipscomb is shown on 1830 Va. Census, K. Wm. Co. p.79, line 6 --

males 1 5-10; 1 30-40 females 2 under 5; 1 5-10; 1 15-20; 1 30-40.

however, by 1835, in the Lt. Daniel Lipscomb settlement, Overton is said to have died 1831, intestate, and survived by "Sally and Hannah, his only heirs". So, the other children must have died. (as well as his wife?)

448 SUSANNA LIPSCOME, Daughter of Ambrose U.H. (p. 451)

L48 <u>SUSANNA LIPSCOMB</u>, daughter of Ambrose (U.H.) and Mary Lipscomb, was born ca. 1782 (?), and had married by 1802, Wm. Watkins. "Winston of Va. and Allied Families" p 435, indicates that 28 Apr. 1802, Wm. Watkins and Susanna, his wife, of King William Co. deeded to Isaac Quarles of King Wm. Co., for ±103-10-0, 69 acres in K. Wm. Co. on Mattaponi R., adj. the lands of Roger Madison, Ambrose Lipscomb, Isaac Quarles, MillPond & bed of Mill Creek. (recorded B.9 p 16 ?)

In 1817, there was litigation regarding the division of the land that had been conveyed for use of Susanna Watkins-"unto her lawful heirs", and from this, we find the names of her children, -- as listed after her death, --

448-A ELIZA WATKINS, had married John White

B MARY WATKINS, b. before 1796 (?); married Beverly B. Lipscomb, son of Pemberton and Lucy Lipscomb (p.426) Possibly both Beverly B. and his wife, Mary had died by 1817, and the 1817 document gives the name of their only child,--

449 MARY LIPSCOMB (POLLY), Daughter of Ambrose Lipscomb U.H. (p. 451)

<u>MARY LIPSCOMB</u>, daughter of Ambrose, U.H. and Mary Lipscomb, was born possibly ca. 1785-88; she married, before 1806, Lumpkin (Stephen) Gresham. Her father haddeeded them 50 acres of land, 1806, which they sold, 8 Oct. 1808, for \$300., to Isaac Quarles (who was accumulating all this land about) adj. Benj. Waller, Swamp, Isaac Quarles MillPond, & Tobacco House Spring. (K. Wm. B.5 p.259-60). Their children's names from Ambrose's deeds, --

- 449-A SYNTHIA GRESHAM
 - B ROBERT MOORE GRESHAM
 - C STERLING GRESHAM
 - D JOHN GRESHAM

All born before 1806

450 KEZIAH LIPSCOMB, Daughter of Ambrose, U.H. (p. 451)

450 <u>KEZIAH LIPSCOMB</u>, daughter of Ambrose, U.H., and Nary Lipscomb, was born possibly ca. 1789 (?), and the question arises, -- was she perhaps named for Keziah (Yancey) Lipscomb, wife of Daniel (p. 371)She apparently did not marry.

There seems to be no evidence of her being taxed for the "1/3 of her father's land, particularly the tract whereon I now live", deeded to her by her father in 1807. However, after her brother, Foster's death, a suit was brought in Chancery Court by heirs of Foster Lipscomb, dec'd., and Bernard Lipscomb, Nathaniel Fox and Christopher Johnson were appointed to sell Foster's land which adjoined the Court House, supposedly 31 acres, but surely the 25 acres given to him by his father, 1799.

Keziah bought this tract, for \$286.75 (K.Wm.B.6 p.289) 22 July 1811 (?),

454

and the 25 acre tract remained on the Land Tax list, in her name, 9/2, 1814 through 1826, when the listing stopped. Had she died, or had she married? The date of the transaction could have been 9 May, 1813. instead of 1811.

Her 1820 King William Co. Census record was unusual, - several young people. -

Keziah Lipscomb: males 1 under 10; 2 10-16; 1 16-18; 1 16-26 females 1 10-16; 3 26-45

451 ELIZABETH LIPSCOMB, Daughter of Ambrose, U.H. (p. 451)

451 ELIZABETH LIPSCOME, daughter of Ambrose, U.H., and Mary Lipscomb, was born possibly ca. 1790. She married Burke before 25 Oct. 1808. when her father deeded to her 1/3 of his land and, in addition some slaves.

This land. - 64 acres, from her father "Ambrose, the elder", - Elizabeth Burke, in turn, sold to Isaac Quarles for 1765. It would seem that Isaac Quarles was intent upon accuiring all the land of Ambrose Lipscomb, U.H., dec'd. Did this become part of "Woodbury" on the Mattaponi River, between the Waller Plantation and the Chamberlayne's (p.762 "Old New Kent"- Dr. Malcolm H. Harris). (Quarles deed, "Winston of Va." p. 436)

No record of any children for Elizabeth Burke has been found.

End of the story of Ambrose Lipscomb, U.H.

JOHN LIPSCOMB (Who left a widow, Elizabeth, before 1780) 453

JOHN LIPSCOMB, who left a widow, Elizabeth, before 1780 is anoth-453 er problem. He just could have been the same John who had the Caroline Co. deed 1744 and 1749, - with a second wife, after a first wife, Judith, may have died.

And/ or he could be the father of Charles Lipscomb, B.L., and John Lipscomb, B.L. (See following segments)

The only way we actually know of him is the listing on the 1780 King William County Specific Tax on which is listed -- the first name, --

Mar. 17, 1780 LIPSCOMB, Elizabeth (wid? Jn?) 4 bushels Corn

Then, in the 1782 Personal Property Tax, King William Co., in only this one report, there is a second Elizabeth Lipscomb, no titheables, 6 slaves, 1 horse, 4 cattle. (The other Elizabeth was the widow of Roger Lipscomb, was on the 1780 Specific Tax list for 280 lbs. Tobacco, and was listed on 1782 and 1783 for 600 acres. 7/4. and personal property tax 1782, no titheable. 18 slaves, 5 horses, and 20 cattle. see p. 134).

There are three Public Service records, Aug. 10,1781, beef; Aug.13,1781, Corn; and Aug. 22, 1781, Lamb. and one in 1782-3 for beef, listed for Elizabeth Lipscomb, but it would seem that this must be "the other Elizabeth" who had the larger acreage, especially since "the widow of John" does not appear on any later records -- she may have died.

But, one John Lipscomb, "Est." Public Service, King William Co., Court Booklet p. 3 was for a claim dated 20 June, 1780, so, if this could have been the same John Lipscomb, here, it would be hard to prove, and only adds to the big problem, and should be checked into further.

CHARLES LIPSCOMB (Another problem - apparently a Bricklayer 454

454 CHARLES LIPSCOMB, (Bricklayer), becomes evident first on the 1780 King William County Specific Tax, Mar.23, for 2 bushels of corn. Is there a possibility that he could have been a son of John Lipscomb above?

The name "Bricklayer" does not seem to have been applied to any of his other records, - but since there were no other contemporary Charles Linscombs, they are surely the same. His Land tax begins on the 1782 List, as 227 acres, value in 1783- 9/2, changing by 1787 to 217 acres having deeded 91 acres to Josiah Lioscomb. After the few years of missing tax records, this "217" acres, 9/2, shows up in the name of Mourning" (the "w" designation to distinguish him from the older Mourning Lipscomb, for whom he was possibly named). So, this Charles had no doubt died between 1788 and 1793.

There is no way to determine where Charles' 227 acres came from, but may be land owned by his father (and, if his father had been John, above, this may account for the fact that Elizabeth showed no Land tax.)

There is no way, also, to determine what became of that 217 acres which apparently went to his son, Mourning^W, because he apparently died after his last tax listing in 1797, with no explanation as to the disposal of the land. And, the location of lands would not be indicated on Tax rolls until in 1814. That is, unless the 217 acres did go ultimately, in 1814, to Martin Lipscomb. (See "Martin"Lipscomb, later, for further details)

No indication can be found to name a wife for Charles Linscomb, Bricklayer, and names of children must be deduced from round-about sources, such as the new assignment of the 217 acres, to Mourning. There is also an indirect clue that he had a son, John Lipscomb, in the document (K.Wm.B.3 p.61?) in which John"Son of Charles, is mentioned in the document in which Mourning Lipscomb (the elder) was furnishing security as Administrator of Mrs. Frances Quarles' estate.

So, by deduction. we can say that Charles Lipscomb, Bricklayer, must have had two sons, --

- 455 MOURNING LIPSCOMB., born, you guess it!; married, --?; Died ca. 1797-8
- 456 JOHN LIPSCOMB, Guess some more! There seems to be no John Lipscomb of record who could identify with him, unless it could have been the John Lipscomb, and wife, Sally K.,who deeded 3 1/8 acres, 25 Oct.1796 to Mourning Lipscomb (the elder) (K.Vm.B.3 p. 232-or.438?).

Continuing in this guessing game, let us now consider --

457 MARTIN LIPSCOMB I (More problems)

457 <u>MARTIN LIPSCOMB</u>, b. ca. 1783 (a big guess) began paying tax on 217 acres of land, 7/4, in 1804, - seven years after Mourning^W had last been taxed for his 217 acres, 9/2. The entire King William tax list was studied to try to find any other disposition of Mourning^W's 217 acres, and no other like acreage unaccounted-for was found. So, is there a possibility that Martin could have been a son of Mourning Lipscomb^W? The value of the land was quite different, and no other "adjustment" in tax rate has been found to correlate, but it just could be that his was a special case.

Whoever Martin Lipscomb was, then, he remained in King William Co. through 1811. married, 10 Sept.1812, Essex Co., Ann Jones (Essex Co. Mar. B.1 p228) stayed in Essex Co. a few years. still paying tax from Essex Co. through 1815, then sold, 29 June 1816, to Henry Slaughter (his neighbor) for 3800., "193 acres by recent survey", on road leading to Cohoke Mill, land "inherited from his father". The 1815 Tax list had shown it as 9 miles East, adj. Jn⁰ Roane, near Cohoke, (which could have been on the road to Cohoke Mill). So, the big question is -- was this the land that had belonged to Mourning Lipscomb^W, - some distance away from the area where Mourning Lipscomb(the elder) lived, and John Lipscomb B.L., whom you will meet later.

458 Martin Lipscomb shows, however, on the King William County 1820 Census -- p.299 Martin Lipscomb: males 1 under 10; 1 16-26; 1 26-45 females 2 " 10; 1 16-26; 1 26-45; 1 over 45 (a mother?) (no accounting for those 16-26!) Then, surely the same Martin Lipscomb, on Henrico Co. 1830 Census, p.290 ---Martin Lipscomb: males 1 5-10; 1 40-50 several slaves females 1 under 5; 2 10-15; 1 30-40; 1 50-60 (still the mother?) None in 1840 Census Index of Virginia. But, Henrico Co., Va. Census 1850 -- an odd entry, -- p. 564 (west portion of Co.) 28 (no occupation) \$6,000. all b. Va. Martin Lipscomb: 26 gardener Tallyrand BRICKLAYER (!) (Full circle?) John B. " 25

So, untangle all that, if you can. That is, if you might be trying to tie your line into this branch.

Now, going back to p. 456 . - Charles Lipscomb, bricklayer, let us consider-

JOHN LIPSCOME, (Bricklayer) (More tangles) 458

458 JOHN LIPSCOMB B.L., with the caption "B.L." posed a problem, until finding the Tax Alterations for 1785, King William Co., --

Deed: John Lipscomb Bilayer, of Thos Littlepage 612 (acres).

So, was he a brother of Charles Lipscomb, Bricklayer? Were they both sons of the John Lipscomb (who left a widow, Elizabeth, before 1780)?

He bought this 613 acres, and was taxed for it through 1801. On the 1802 list, it is marked "Est.", so that probably sets his death date. And, it continued on through at least 1829 (as far as checked) as simply "Est.", shown, in addition, in 1813, as " no description, Orphans" and beginning in 1815 as "near Court House". However, the Recorder must have not bothered to find out. The original Deed from Thos. Littlepage, (K.Wm.B.2 Pt.3, p.74), 19 Apr.1786 to John Lipscomb, was for 613 acres on Bull Swamp and Long Branch, which area is four to five miles East of the Court House, N. side of the Main Road. The deed was witnessed by James Lipscomb, - James (C)? Complications confound the problem! But, they possibly give clues as to the possible children of John Lipscomb, B.L.. In 1813, two deeds are recorded 24 May, 1813 from 1. Ambrose Madison and Jane King Madison, his wife, and 2. from Alsey and Frances Lipscomb, selling to Wm. F. Ollone their interest in the land belonging to the estate of John Lipscomb, dec'd, and "all interest that may accrue to us by the death of Charles Lipscomb, son to said John Lipscomb", indicating Charles Lipscomb as their brother.

So, could this mean, probably, that John Lipscomb, B.L. had a son, Charles and three daughters, Alsey, Frances and Jane King Madison? if so .--CHARLES LIPSCOMB, Jr., b. ? ; m. ? ; died ca.1817. 459 (See below) ALSEY LIPSCOMB, no details further, except the 181? deed. 460 (See p. 460) FRANCES LIPSCOMB, no details further, except the 1813 deed 461 (See p. 460) 462 JANE KING LIPSCOMB, b. ? ; m. Ambrose Madison; d. (See p.460)

459 CHARLES LIPSCOMB, Jr., Son of John (p. 458)

459 <u>CHARLES LIPSCOMB, Jr.</u> was so-called apparently to distinguish him from "his uncle Charles", probable brother of his father, John Lipscomb B.L.

He, too, left few records. His first Personal Property Tax. 1809, and, in 1814, he accumulated 152¹/₂ acres of land, 6/11, 5 miles East of the Court House, adjoining Conway O. Lipscomb, and Alex. Frazer, -- in the area near the Bull Swamp, on the north side of the Main Road.

This land was purchased in smaller parcels by deeds,

- 3 Nov.1913, (K.Wm.B.6 p.284) A portion from the lands of Wm. Boswell, Dec'd
- 24 Nov.1813 (K.W., B.6 p.295) 46 acres on Bull Swamp, adj. Mourning Lipscomb & Alex Frazer, \$320., from Herman Otter of New Kent Co.
- 29 Mar.1810, recorded 29 Mar.1814 (K. Wm.B.6 p. 312) 48 acres from James

Sargeant and wife, Susanna. (seemingly land allotted to Susanna Boswell).

He had also joined Jas. Smith and Thos Ware in furnishing bond for the appointment ofthe Constable (K.Wm.B.6 p.148) (\$500.)

He must have married, because after his death, his "relict" did deed 3 3/4 acres to Mourning Linscomb (the elder), in 1817. But, we have found no further record of name of wife, disposition of his lands, or names of any children.

He died so soon after accumulating his lands, that it may be that he was not in good health, -- the reason that his sisters worded their deeds to the effect that they would include any "interest that would accrue to us"by the death of their brother, Charles. His listing marked "Est.",1817.

The tax listing as "Est." stopped after 1819. It may probably be that he had no children, hence his sisters were anticipating a portion of his inheritance.

Che problem in connectior with sorting out this family, is the listing on the 1780 Specific Tax for King William Co., which shows, as well as the Mar. 23 listing of Charles Lipscomb (Bricklayer for 2 bushels of Corn. -- a March 30 listing for a Charles Lipscomb Jun., for 6 bushels of Corn. with the notation "Short 1 tythe". This could surely not be for the Charles Lipscomb, Jr. we have been here considering who may not have been born until around 1788-90. No clue as to the identity of the 1780 Specific Tax Charles, Jun^r.

460 ALSEY LIPSCOMB, and 461 FRANCES LIPSCOMB

ALSEY LIPSCOMB, and 461 FRANCES LIPSCOMB, apparently daughters 460 of John Lipscomb, B.L., may have been born in the 1790s. The only thing we know of them is the deed 10 Mar. 1813, recorded 24 May 1813 (K.Wm. B.6 p. 242) conveying to Wm. F. Ollone, - "all interest in lands that belonged to our father. John Lipscomb, dec'd, -- and all interest that may accrue to us by the death of .. (our brother) .. Charles Lipscomb in said land ... ". It was witnessed by Peter Deffarges, Paul Lipscomb and John White.

This very probably referred to the 61 acres which had been the land of John Lipscomb B.L., and was still listed to him through as late as 1829, as "Est." after his death ca. 1802.

However, Wm. Ollone's taxes were marked "Est." in 1814, without apparently any increase in acreage, except for a 63 acre increase (from 3763, 9/0, in 1812 to 383 acres in 1813. 9/0) So, was that deed for only 63 acres? It did not decrease the 61 acres credited to John Lipscomb. So, it may be that the conveyance was not finalized.

No further clues on the two daughters, but further checks of later deeds and records might help. Census records seem to show no clues.

JANE K. LIPSCOMB (Wife of Ambrose Madison) 462

JANE K. (KING) LIPSCOMB, apparently daughter of John Lipscomb, 462 B.L., -and her husband, Ambrose Madison, also made out a deed (K. Wm. B.6 p.241) dated probably the same date as the above (obliterated) to Wm. F. Ollone, for \$100., "all out interest.. etc. etc" as above.

Their conveyance was witnessed by Nath'l Cobb, Reuben Madison and John Huckstep. Jane's release of dower follows.

Much effort has been made to identify Ambrose Madison, but to no avail. The only documents found were -- referred to in "Winstons and Allied Families" p.226 indicating that Ambrose was the son of John Madison, dec'd by 1802, King William Co.

"Jane King" was probably the given name of Jane King (Lipscomb) Madison. This might possibly be a clue to see if her mother might have been a King.

Whether or not Ambrose Madison and his wife, Jane King had children has not been ascertained.

This is the end of the tangled history surrounding and following the John Lipscomb(#453, beginning on p. 456), who left a widow, Elizabeth.

463 JOSIAH LIPSCOMB (Not yet identified)

463 JOSIAH LIPSCOME needs a birthdate as well as parents. He could have been born ca. 1750, in King William County. Whether or not he married cannot be determined. And, even a death date cannot be accurately be estimated. except probably ca. 1793.

His few records are unrevealing, --

1780, 30 Mar. King William Co. Specific Tax -- Lipscomb, Josiah- 6 bu. Corn

- 1781. 20 Sept. King William Co. Court Booklet, pp 6,25, show that he furnished Beef, 225 lbs. -- £2-16-3.
- 1783, 2 Oct. King William Co. Commission Book III shows that he furnished Tar ±0-16-0 p. 251. Also, see List II,1. (DAR acceptance-- if he had any descendants).
- 1782, His Land tax began with 180 acres, increased in 1785 by 9gacres from Charles Lipscomb, totalling 189g acres, 11/0, through 1793 when his listing is marked "Est." So he must have died that year. And, that year, the Tax Alterations show that Holt Richeson "added" 189g acres, from Josiah Lipscomb.

(No family connection can be established, so far, with Holt Richeson or the Richeson family. He was, no doubt, the Lt. Col. Holt Richeson. who"resigned his commission on May 10, 1779" (Dr. Malcolm Harris - "Old New Kent" p.626). He m. (1) Susanna West, and (2) 1790, Catherine Hogg, of West Point. So, this transfer of land must have been simply a deed, rather than an inheritance.) This land was apparently east of the Court House.

1783, His Personal Property Tax showed, in his list of titheables-- two slaves, - "Sampson and Oney", totalling 3 tithes- so apparently no sons.

If he had heirs, they have not been found, as yet.

464 NICHOLAS LIPSCOMB (Impossible to identify)

464 <u>NICHOLAS LIPSCOMB</u> is an illusive member of the early Lipscomb family. There are only two records for such a person.

In March 1779, he turned in 3107. in bank notes to the Continental Loan office. during the Revolutionary War. (Nat'l Gen. Soc. Guarterly, Vol. 46-1958. No.4 p. 190). (See Appendix)

He is also credited with having furnished a gun, during the Revolutionary War, -- Public Service claim, -- King William Co.. Court Booklet 0.24; Commissioners Book III, 0.249 (See Appendix)

No other records have been found, - Rev. War, Specific Tax, Land or Personal Property Tax, in King William Co., -- so, perhaps he died ca. 1781? It would be a wide guess to approximate his birth date, or whether or not he had married.

465 NUNN LIPSCOMB (Identity unknown)

<u>NUNN LIPSCOME</u>, born possibly ca. 1725-35, could have been a son of any one of the children of Ambrose Lipscomb II (except Benjamin). His name, Nunn could have come from the Nunn family (a Thom.Nunn (1690-1744) and wife, Elizabeth of Chesterfield Co., for instance). The name of his wife is unknown.

His land, 234 acres, 6/5, was taxed, 1782, and by 1787, it had gone to his son, John, who was designated John ^N (for Nunn). In 1814, when the location of land - distance from the Court House, - was first listed, it showed it to be 2½ miles East, which places it at the extreme west portion of the original Land Patent of Ambrose Lipscomb II. Could have even been the original 1681 purchase.

In March,1779, Nunn patriotically turned in his bank notes (\$50.) into the Continental Loan Office (Nat'l Gen. Soc. Quaterly Vol.46 p 163, 1958) (DAR acceptance.) The 1780 Specific Tax, King Willaim Co. shows him for 280 lbs. of tobacco. (See Appendix)

He had a Public Service record, during the Revolutionary War, King William Co. Court Booklet p.25; Certificate 1; List II 1; Commissioners Book III, p.251, for Beef, L2-18-9. (also DAR acceptance) (See Appendix)

He probably died 1786, because, as mentioned above, his son, John took over the taxes on the 234 acres in 1787, and this is the only heir of record,--

466 JOHN LIPSCOMB., son of Nunn Lipscomb, was born ca. 1753 - calculated from the fact that he was listed as a Volunteer, in case of need, in 1812 as aged 59.

Recorded 28 Feb.1805 (K.Wm.B.4 p 350) is a deed dated 17 Oct. 1804(?) from John Lipscomb (Nunn) and Charity, his wife, to Philip Lipscomb, for \$50., for 7 acres on the road from Piping Tree to Blakesville, adjoining each other. Witnesses were Foster Lipscomb, Daniel Lipscomb and Thos. Hill. This decreased his holdings to 227 acres which continued on through 1822 when the listing was marked "Est.", probably the year of his death.

His name seems to be absent from the 1820 Census, but in 1810 (taken from Personal Tax lists) he had 2 titheables (self and son, John, Jr.) and Thomas S., older son is listed in his own right. So, the two sons of John . and Charity Lipscomb were, --

467 THOMAS S. LIPSCOMB, Son of John Lipscomb.

467 <u>THOMAS S. LIPSCOMB</u>, elder son of John ^N and Charity Lipscomb was born possibly ca. 1785-90. He was married, but the name of his wife is unknown. He died before 1848, at which time, his 61 acre tract was sold by his heirs, to Charles S. Rogers.

In 1823, their father's land was divided between the two boys, Thos. S., and his brother, John N., Jr.-- 60 3/4 acres to Thomas S., and 1662 to John, Jr... The land of Thomas S. adjoined that of his brother and Philip Lipscomb, and was designated, again, as $2\frac{1}{2}$ miles East of the Court House.

His 1820 Census record is -- p.298,--Thos. S. Lipscomb: males 2 under 10; 1 26-45 2 slaves females 2 " 10; 1 10-15; 1 26-45
In 1830, p. 71, line 2 --Thos. S. Lipscomb: males 2 15-20; 1 40-50 2 slaves females 1 under 5; 2 5-10; 1 10-15; 1 20-30; 1 40-50
In 1840, p.76,line 24: males 1 50-60 1 slave 2 in Agriculture. females 2 15-20; 1 20-30; 1 50-60
He died before 1848, and the list of heirs who sold his land (K.Wm.D.B. 13 p. 264) in 1848, give a clue as to their names, -- four daughters, two sons, 467-A <u>SALLY LIPSCOMB</u>, married Montague Cobb, before 1848.

468 JOHN LIPSCOMB N, Jr., Son of John Lipscomb N

468 JOHN LIPSCOMB N, Jr., who, in time, became known as John N. Lipscomb, was born probably in 1795. (He was aged 55 in the 1850 Census). No records show for him except his Census, --(later Court records have not been checked). His 166‡ (167½) acres adjoined Mary D. Slaughter and Cohoke.

His 1830 Census record, p. 74, line 23, shows 1 male 30-40 and 3 slaves.

In 1840, p. 76, line 23, shows 1 male 40-50, and 1 female 10-15 & 3 slaves. This 1 female was surely not a daughter, - nor a wife?

In 1850, 98-8 - John Lipscomb N age 55 Farmer \$1400. b. Va. -- with no family, so, apparently he had no heirs. He seems to not show in 1860 Census, so must have died before then.

469 FRANCIS LIPSCOMB (So far, unidentified)

469 <u>FRANCIS LIPSCOMB</u>, whose identity cannot, as yet, be determined, was born, possibly ca. 1745-50, and probably in King William County, Va., and, just possibly could have been a brother of Ambrose Lipscomb, son of Jesse (see p. 76).

This assertion is made because of one record in Louisa Co., which shows that Francis already owned land there in 1773, adjacent to the 300 acres which Ambrose Lipscomb (son of Jesse) bought, on Long Branch, Trinity Parish, from John Stewart. and Ann, his wife. (Louisa D.B.D. p.539). (Ambrose held this land for only five years, still living in King William Co.,-deeding it, 1778 to Sam'l Shelton. (D.B. E p 266).

Francis Lipscomb had bought 140 acres, bound by Benj.Cook, East side by John Stewart. and John Waddy, Louisa Co., 12 Jan.1769, from James Harris, of Albemarle Co., for 177. He was designated as "Francis Lipscomb of Louisa Co." so must have been there for a while previously. (Louis Co. D.B. D p.158-160 ?). Had he married ca. 1769? His children's ages would indicate this possibility.

A gap in estimated ages of the children might indicate that his first wife (name unknown) might have died ca. 1786-90, and that he may have married a second time, by around 1794. The name of his wife, in his will of 1802, was Mary Ann

Francis Lipscomb was on the 1777 Tithe List, Louisa Co., Trinity Parish.

He must have been a trusted friend and neighbor, judging from the list of responsibilities he performed, as of record, --

1779 - He helped settle the estate of Richmond Terrell (rec.1] Oct.1779.

1780 He and Wm. Lipscomb were involved in settling the estate of John Marshall, dec'd..

1789 - He witnessed the will of Rob't Goodwin.

1792 - He appraised the estate of James Terry, rec. 13 Aug. 1792.

Francis Lipscomb is credited with Public Service, during the Revolutionary War, -- (DAR acceptance) (See Appendix)

Louisa Co. Court Booklet p.2,5,6; Certificates 2; Lists I 1,51; II 2; Commission Book III, p. 357, 358.

Francis Lipscomb's Land Tax record is short, beginning, of course, 1782 --

1782 - his 140 acres bought 1769 1787 - he had added 113 acres from Nelson Anderson, making 253 acres 1796 - he added 149 acres, totalling 402 acres, which berhaps increased in size, by survey (?), since, after his death, 1802, his lands were divided into equal portions, 137¹/₂ acres to each of the sons-John, Thomas and Henry.

Tracing the marriages, taxes, etc. for Lipscombs in Louisa Co. must be done with great care, in order to distinguish between the members of the different family groups, apparently not closely related. There were, beside Francis Lipscomb (ca. 1750-1802), Thomas Lipscomb I (1700-1770) with his three sons, Thomas, William and John, and 8 daughters, - and, Joseph Lipscomb (ca. 1735-1807), son of Benjamin, with his sons, Barnabas and William Tandy Lipscomb, and his six daughters. (see pp.208 and 148).

Francis Lipscomb's will, dated 18 Mar.1802, was probated 12 July 1802 (Louisa Co. W.B. 5 p.77-78). He lent his "whole estate" to his wife. Mary Ann, during her natural life, and after "their mother's death", his land was to be divided equally between the three sons, Henry, John and Thomas. The two youngest children, Thomas and Judith were to be schooled. The six daughters were to receive portions that would equal that of the sons (in personal estate?), etc.. George Pottie, David Bullock and Benjamin Sims, Exec.; Wm. Stansfield, James Baughan and Micajah Sims, witnesses.

(Since the three sons immediately began paying tax on their portions, were they doing this in order to pay for "their mother's" tax, or, had she, too, died? And, did this mean that she was mother of all of the children?)

470 DESCENDANTS OF FRANCIS LIPSCOMB (p. 465)

470 JOHN LIPSCOME, born possibly ca. 1770, Louisa Co., Va., son of Francis Lipscomb (and maybe Mary Ann ____, his wife), was unmarried at the time of his father's will, in 1802. And, no record of a marriage has been found. It was probably this John Lipscomb who witnessed the marriage bonds for his two sisters, Lucy and Elizabeth, in 1788 and 1795.

He was taxed for land, Louisa Co., 1372 acres (from his father) 1803 through 1815. Part of the time his listing was "S.F." indicating son of Francis, and part of the time, as "Jr.", apparently to distinguish him from John, the son of Thomas Lipscomb (1700-1770).

Further research has not been done to determine his later activity, after 1815; the name "JOHN" is difficult to trace. But see p. 515 for a possibility. And, could the Thomas Lipscomb, ac. 60, 1850 census, with family, be his brother, also in Robertson Co., TN.? (p. 468)

471 <u>LUCY LIPSCOMB</u>, born Ca. 1771 (?) Louisa Co.; nothing further, except that her husband Benjamin Sims was one of the Executors of her father's will, and was guardian of her youngest sister, Judith.

472 <u>SARAH LIPSCOMB</u>, born ca. 1772-3 (?); probably married Charles Rice, 22 Dec. 1808. Nothing further.

473 <u>ELIZABETH LIPSCOMB</u>, born ca. 1775-8 (?); married 1 Oct.1795. John Sims. Her brother, John, was a witness. Nothing further.

474 <u>HENRY LIPSCOMB</u>, born ca. 1778 (?) Louisa Co., Va.. Two marriages are listed in Louisa Co. for a Henry Lipscomb, and since he was apparently the only Henry Lipscomb of that time, there, it would seem that perhaps the Morton Jeter, whose marriage to Henry is listed as 4 June 1798, may have died very shortly. That marriage had been performed by Martin Walton, Minister. Evidently she died very shortly, because another marriage is listed 10 Dec.1798 for Henry Lipscomb, marrying Frances Walton, daughter of Mary Walton. Surety John Walton, Witness Joel Walton, and the marriage performed by the same Minister, Martin Walton.

Henry Lipscomb died in 1803, very early, leaving a will, dated 29 May1803, which was probated 16 Oct. 1803, leaving his wife, Frances, and two children, Nelson and Polley. Wife, Frances, and friend, Joel Walton, Exec..; Benjamin Sims, Garland Walton & Anis Lipscomb, Witnesses.

It is thought by some that Henry's widow, Frances, married (2) 13 July 1813, David Smith.

This last listing, Frances Lipscomb 23, is puzzling. Was she on older daughter? Or, could this have been a mistake, supposed to be "73" instead of "23", in which case, this could have been Nelson's mother, Frances (b. ca. 1777),that is, if she had not married, in the meantime, David Smith.

476 ANNESS LIPSCOME, , daughter of Francis Lipscomb, b. ca. 1790-01; married 30 Sept. 1815, Newel Baker, Witness John Sims.

477 <u>THOMAS LIPSCOMB</u>, born ca. 1794 (?); "to be schooled" in his father's will of 1802. His listing of land, 137¹/₂ acres, 1803-1807, Nothing further. No indication of disposition of the land. He could well be brother of John (p. 467 & (?)p. 515), both in Robertson Co., TN. 1850 census.

478 JUDITH LIPSCOMB, daughter of Francis Lipscomb, his youngest. b. ca. 1796 (?); was also "to be schooled" according to her father's will of 1802; married, 15 Dec. 1814, Samuel Waldrope; Surety Benjamin Sims, her guardian, who attested that she had "received her legacy twelve months ago".

This is the end of what we have found in the line of Francis Lipscomb (p. 465)

481 PEMBERTON LIPSCOMB (The Elder) (Impossible to identify)

469

481 <u>PEMBERTON LIPSCOMB</u>, another one of the enigmas among the early Lipscombs, could have been born ca. 1750, King William County, of course, but no clues have been found to identify him.

His name surely must come from some connection with the prominent Pemberton family in the area. In fact, there were three Pemberton Lipscombs in overlapping generations, -- this one; and another, born ca. 1792 (?) who may have been son of "the elder"; and, then, Pemberton Lipscomb, son of John and Ann(Madison) Lipscomb (p. 425), whose name must have come from Ann's father, Thomas Pemberton Madison, (if indeed his middle name was Pemberton).

Pamberton Lipscomb, the elder, paid 84 lbs. of Tobacco on the King William Co. Specific Tax of 1780 (so, he was probably at least 30 years old-?). His King William Co. Land tax through 1787 was for 196 acres, 7/4, adding 25 acres, 7/4, from Henry Cobbett on the 1788 Alterations, totalling 221 acres, changed for some reason to 9/2 value, stopping abruptly, without comment, 1795.

His Revolutionary War Public Service Claim is recorded in King William Co. Court Booklet p. 2, 14. 26; Certificates 2; King William Co. Commissioners Book III pp 249, and p. 251, for beef, Ell-8-10. Another entry, in Commissioner Book III. p. 250 for a small amount was listed as Piperman Lipscomb, surely meant for Pemberton. King William Co. List I, p.7 also lists 25 July, 1783 To Pemberton Lipscomb- for carriage, and apparently 128 lbs. bacon, --E³19-14-0. (See Appendix)

His last tax, 1795, would surely indicate his possible death date. Then, along comes a vaguely possible clue, -- was his wife's name Mary?

Of the two or three mysterious Mary Lipscombs in King William Co. records, one began paying Land Tax on 701 acres, $8/6\frac{1}{2}$, in 1796 (the year after Pemberton Lipscomb's listing stopped), and on through 1805 when it stopped, with no apparent disclosure as to its disposition. Could she have been the widow of Pemberton Lipscomb, and perhaps adding 480 acres from some other source, to his 221 acres, remained his widow during those years?

Had they, before his death, had a son, Pemberton, b. ca. 1792, -- and perhaps other Lipscombs whom we are not able to identify? And, could she have been the Mary Lipscomb (K. Wm.B.4 p.333-334) who, in two separate deeds of gift, left to her grandchildren, James Fisher, - two black mares, and to Eliza Fisher, - three head of cattle? This would indicate a possible daughter who had married a ______ Fisher, before 1805, 17 June, the date of the deeds. See pp 55 and 65)

So far, however, even if Pemberton Lipscomb, the younger, might have been their son, there are, as of now, no male Lipscomb lines of continuation, since Pemberton, the younger seemingly had only daughters.

Let us assume that Pemberton, the younger, was their son --

482 <u>PEMBERTON LIPSCOMB</u>, (the younger), b. ca. 1792-; married ca. 1815 Ann Coleman Pemberton, lived in Richmond, Va.; died 4 Dec. 1832. see next page.

482 <u>PEMBERTON LIPSCOMB</u> (The Younger) Son of Pemberton the Elder ??? 482 <u>PEMBERTON LIPSCOMB</u>, (the Younger) may have been a son of Pemberton Lipscomb, the elder. He may have been born ca. 1792, probably in King William Co., Va.

He left very few records, but from King William Co. deeds, we may conclude that he married Ann Coleman Pemberton, (daughter of Wilson Coleman and Wealthea (Edwards) Pemberton) ca. 1815.

They lived in Richmond, Va., and Henrico deeds and tax lists have not been studied, -- they would surely reveal more information. But, King William Co. deeds show --

- 9 Feb. 1818. (K.Wm.B.7 pt.1 p. 179) Pemberton Lipscomb and wife, Ann, deeded to Parkes B. Davis 92 acres, for \$644., up Cohoke Swamp, adjoining Roger Slaughter, etc. to Thos. Hill line.
- 1 Feb. 1820. (K.Wm.B.8 p.65) Roger Slaughter and Lucy, his wife, James Christian and Mary, his wife, and Pemberton Lipscomb deeded to Henry Davis, for \$1658, 206 acres, adjoining land of Parkes B. Davis - land that sd. Slaughter purchased from Jas. Christian and his wife, and part of land inherited from brother Henry T. Slaughter. (Had Pemberton's mother been a Slaughter?)
- 5 Mar.1821. (K.Wm.B.8 p.282) Wilson C. Pemberton sold two negro slaves to Rob't Pollard, -(slaves which had been left to his wife, Wealthea by her father, Ambrose Edwards "during her life"),-This deed with the consent of all his children, which included Ann and her husband, Pemberton Lipscomb.

By 1820 Pemberton and his family were in Richmond City, Henrico Co., Va. -

483 COLONEL LIPSCOMB (So far unidentified)

483 <u>COLONEL LIPSCOMB</u> is one who is difficult to identify. He could have been born ca. 1750-55, and very probably in King William County, Va.. He named a son - "Anderson", which may or may not indicate some connection with the John Lipscomb of King William Co. who married Dinah Mack Genee and had sons in that branch, named "Anderson".

He married, probably ca. 1780, Susanna Mosby, daughter of Hezekiah Mosby (b. 1695, Henrico Co.- d. 1787 Powhatan Co., Va.) and his wife, Elizabeth Cox. Had he already gone farther west to seek new lands? - to Buckingham County.

He had died by 1804, when his Personal Property Tax listing was marked "Est.". His Buckingham Co. Land Tax began in 1782 (when Va. taxes were initiated) with 400 acres, 3/6, and on through 1802. Then 1803, 294 acres, 3/6. Deed records for Buckingham Co. were destroyed by fire, so cannot be checked.

The question must arise as to whether or not his name, "Colonel" might be a military title, -- but apparently not. The Buckingham Co. Land Tax records list him at first as "Col.", then beginning 1790 it is fully spelled Colonel, so, this name is difficult to explain. All efforts to locate any Revolutionary War connection, or any army appointment have produced no results. And, the name has not been found anyplace else in the family.

"Col! Lipscomb of Buckingham Co. was, however, credited with Public Service during the Revolutionary War, - in their Court Booklet, p.3 and 10. (DAR Acceptance). (See Appendix)

Nothing further has been found for him, and the names of his children must be surmised (quite logically) from the continuing Buckingham Co.Tax lists since there were no other Lipscombs in that area.

No death date has been established for his wife, Susanna, but their children were, very probably, --

HEZEKIAH LIPSCOMB, probably the eldest of the children of Colonel and Susanna (Mosby) Lipscomb, could have been born ca. 1781. The only records found for him are Tax and Census. He married and had a large family, beginning around 1796-7, but the name of his wife has not been found, nor, for certain, the names of his children. And, a date for his death cannot be stated, except that it would be after the 1830 census.

His Personal Property tax began as early as 1804, and perhaps earlier. He began paying Land Tax in 1806, in Buckingham Co. for 280 acres, 4/-,-- could this have been his father's land, after he died ca. 1804, (which had been valued at 3/6), adding, in 1811, 35‡ acres "per Sally Johnson" (any connection with his wife?). In 1815, he acquired 273 acres, 9/4,"conveyed by John Glover", - on Buckingham Rd., 13 miles S.W. of Buckingham. Then, in 1819, his tax was for only 112 acres on Bryants Creek, , 2 miles S.E.,"conveyed by Peter White". Taxes after 1821 have not been checked.

His Census records, all in Buckingham Co. are as follows, --

This could very well be the same Hezekiah Lipscomb from Buckingham Co. - a short distance away, -- his age, 71, - b. 1779, - a proper age. And, the young members of the family probably granchildren. And, even the name "Mosby" figures in very nicely. North further pursuit, for any descendants in that branch. Try Land and personal property taxes, deeds, wills, and later Census data.

485 ANDERSON LIPSCOMB, Son of Colonel Lipscomb (p. 471)

ANDERSON LIPSCOMB, son of Colonel and Susanna (Mosby) Lipscomb, would have been born ca. 1783 in Buckingham Co., Va.. Since there are no County records, except Tax, we have to rely entirely on the Tax listings and Census records, and he has not been easy to trace. But, we can trail him across, through Census records, to Pulaski Co., Missouri where he died 1846-1850. He married by ca. 1800-1803, since the 1810 Census shows him with a son and 3 daughters, so he must have married a girl from Buckingham Co. or nearby, but we do not have her name. He had had 11 slaves in 1910.

He baid Personal Property tax as early as 1805, perhaps earlier. His Land tax began 1810 with 100 acres, 6/-, and in 1815, his 100 acres (a different 100?), 3/-, were 7 miles East of Buckingham on the New Canton Road.

By 1817-18, he left Virginia, however, and we find him, 1821 on a list of taxables in Grainger Co., Tenn (N.E. part). ("Early Tennesse Tax Lists")

By 1830, he had gone on farther Southwest, where we find him on the Jackson County, Alabama Census, p. 99, line 13 --

Anderson Lipscomb: males 1 under 5; 1 40-50 females 1 10-15; 2 15-20 and 1 60-70 (a mother?) (had his wife died?)

No record has been found, as yet, for 1840, but family records. indicate that he must have gone to Pulaski Co., Mo. along with his son, Made by 1840, where he died.

From various sources, we have pieced together the names of at least four of his children, one son, and three daughters. Now, one of the daughters, Nancy, had married in 1827, which would leave, still, three daughters in addition. Mrs. E. L. Cuiring, Rt. 1, Box A-9, Dixon, MO,65459 is hoping to find that the fourth daughter could have been a MARY Lipscomb, b. ca, 1812, who married her ancestor, Martin Mitchell (b. Ky., and who travelled with his brother, Nicholas and their families, in 1838, with the Cherokees on the Trail of Tears. Can anyone help? The Mitchells stopped off at Waynesville, Pulaski Co., MO, and the Indians went on to the Indian Territory. Several inter-relating facts point to the fact that there must have been that fourth daughter, Mary Lipscomb.

The name of Anderson Lipscomb's wife is unknown, but since the name of his only son was "Wade", it is strongly suspected that his wife's name might have been Wade, from the large Wade family in the area. Piecing the names of their children together from the various sources, we find--

Now, the big question asked on p. 473. Did Anderson Lipscomb have a fourth daughter, MARY Lipscomb who married Martin Mitchell? Louise Quiring (Mrs. E.L.) Rt. 1, Box A-9, Dixon MO, has been working for a long time on this possibility, but has not been able to find proof. They lived in Pulaski Co. MO, where the Court records have burned. Mitchell records are hard to find, but many relationships are indicated.

Martin and Mary Mitchell had a son, Henry, b. 17 July 1828, Jackson Co. AL, according to family records. He married 1853, Nancy Turner Claiborne. Their son, Martin Ousley Mitchell, b. 1855, was Mrs. Quiring's grandfather.

<u>JOHN LIPSCOMB</u>, son of Colonel and Susanna (Mosby) Lipscomb, would have been born ca. 1784, in Buckingham County, Va.. His records there are brief, -- paid Personal Property Tax as early as 1806, and on up through 1819 when he must have left the county. He paid Land tax on 100 acres, there, value 6/-, 1810 through 1813.

John Lipscomb seems to have married long enough before 1810 to have had a small family, as is shown on the 1810 Buckingham Co. Census --p.794 line 12-

John Lipscomb: males 1 26-45 (1765-1784) 11 slaves females 2 under 10; 1 26-45

Could it be that he was the John Lipscomb who married in Campbell Co., Va. which, at that time, adjoined Buckingham Co., -- Nancy Caldwell, - date of bond 26 Feb. 1807; bondsmen John Lipscomb and Alex Rutledge, witnesses, Oleander Rutledge and Neil Jones? (Cuaker records, Va.- Hinshaw)

A man named "John" is not easy to trace, but there is a John Lipscomb who is listed on 1820 through 1850 Census records in Smith Co., Tenn., who has, so far, not been identified. His age agrees with the Puckingham Co. John Lipscomb, so let us consider this, ----

In 1803 Thomas Lipscomb was dismissed from the Colossee Baptist Church, King William County, Virginia. On October 15, 1804, Thomas Lipscomb and Dorothea, his wife, sold their land in King William Co., Va. It was around this time that Thomas and Dorothea arrived in Person County, North Carolina. Thomas Lipscomb died July 22, 1807. An Indenture dated November 17, 1807, and found in Book D, page 98 of the Person County Courthouse Records mentioned the heirs of Thomas Lipscomb.

The February Court Term for Person County, N.C., in 1808 showed the Inventory and List of Sales of the personal property of Thomas Lipscomb deceased. Included were these negroes: Billy, George, Lieu, Hannah, and Daphney. Buyers of the household articles were: Dorothy Lipscomb, Wm. Satterfield, John Dgroon, John Bateman, Moses Bearsher, Abner Bearsher, J. Dollarhide, James Garden, Aron Russel, E. Whitehead, Daniel Draby, Reuben Grinstead, William Frasier, Holsonback, Thomas Lipscomb, Will McDaniel, Samuel McMurray, Lea, Arch Lipscomb, Samuel Pittard, Francis Wright, Edward Burk, Wilie Ingram, Wade Lipscomb, Alex Rair, Micajah Gainey, and Samuel Lendon. Outstanding notes were listed to John Rains, John Pemberton, and Arch Lipscomb.

The note to John Rains was for rent of plantation and negroes in Richmond County, North Carolina, for the year 1807 and for the year 1808 ending 25th day of February of that year. The Court Record goes on to say "The following negroes and articles are on a plantation on Pee Dee to which the intestate claimed a Title and were with the said plantation rented by him to John Rains for Three years, one of which has not yet expired. (Viz) Peter, Billy, Dafney, Dinah, Sarah & Three children, Fanny, Delphy, and Essie." Also another statement in this same Court Record "it is supposed that there is a Considerable amount of Debts due the said Thomas Lipscomb Estate in the State of Virginia which Some of Them is supposed to be desperate." In the 1809 Court Records it was shown that the negroes were moved from Richmond County to Person County.

The only record on the 1790 Census list for Richmond County, North Carolina, that shows the Lipscomb name, is one for Anderson Lipscomb of Virginia who owned 6 slaves in the Fayette District. (See p. 419)

The 1810 February Court of Person Co., N.C., gave the Division and Allotment of the several negroes belonging to the estate of Thomas Lipscomb deceased. Among the several heirs were to wit: "To Binion Lipscomb ..", "To Reuben Waldron ..", "To Emma Lipscomb ..", "To Matilda Lipscomb ..", "To Geoffrey Lipscomb ..," Arch Lipscomb was also alloted two negroes. The Nov. Term Court of 1815 divided the land belonging to Thomas Lipscomb deceased, this land situated in Person Co., N.C. Lot No. 1 drawn by Geoffrey Lipscomb, Lot No. 2 drawn by Binion Lipscomb, Lot No. 3 drawn by Matilda Lipscomb McMurray, Lot No. 4 drawn by Emma Lipscomb, & Lot No. 5 drawn by Elouisa Walrond. The Dower Lot was also laid out for Dorothy Lipscomb.

The land in Person Co., N.C. that belonged to Thomas Lipscomb deceased was a tract of land lying on the waters of South Hico adjoining the lands of Widow Nancy Lea, Kindal Van Hook, and others. This land was divided into five 30 acres for each of the five children of the deceased plus the widow's dower. It was in 1837 that Dorothy Lipscomb & children deeded 130 acres on the Hyco to John Harris.

When Dorothy Lipscomb applied for Revolutionary Pension as a widow of Thomas Lipscomb deceased, she was living in Smyth County, Tennessee. The date of her application was June 24, 1844. After the death of her second husband in 1837, she had moved to Tennessee to live with her children living there. Her pension application says that she was a widow of Thomas Lipscomb deceased. Thomas Lipscomb, a private in the Revolutionary War, served in Captain Pemberton's Company, Virginia Continental Line. One record in the Archives at Washington D.C. shows that he was at Valley Forge - March & April 1778 in Major Stephenson's Company, 5th & 11th Va., Regt. of Foot, Commanded by Col. Russel. His balance of pay L455-11-1 was collected by Captain D. Ragsdale. Thomas Lipscomb was granted a Military Warrant for 100 acres for his 3 years service -Warrant # 1466, 8-1-1783. After serving for 3 years on the Continental Line, Thomas Lipscomb was discharged Jan. 1, 1781. This Thomas Lipscomb was known as "old continental" Thomas Lipscomb to distinguish him from another Thomas Lipscomb who also lived in King William County, Virginia. Two affidavits for the pension included - July 21, 1845, Caswell Co., N.C., declaration of Nicholas Thompson, cousin of "old continental Thomas Lipscomb", knew Thomas Lipscomb and his brother, Archibald Lipscomb and moved with them to Person Co., N.C. The other was from Ottoman Slaughter who said he lived on the adjoining farm in King William Co., and he knew Thomas Lipscomb. Dorothy Lipscomb did not receive a pension for Thomas's Revolutionary service, but she did receive it for Archibald Lipscomb's Revolutionary War service. Archibald Lipscomb had been receiving a pension for his war service before he died.

On December 20th, 1787 Thomas Lipscomb received a marriage bond to marry Dolly Palmer, daughter of Nicholas Palmer deceased. Signing the Bond was Thomas Lipscomb and James Palmer. They were married December 25th, King William County, Va. Their first child was born in May, 1789. It is not known for sure in what chronological order the children were born, but these were the children of Thomas Lipscomb and his wife, Dorothy Falmer:

491 <u>ELOUISA LIPSCOMB</u> - believed to be born May, 1789. She was sometimes called Louisa Lipscomb. She married Reuben Walrond on August 9, 1808, in Person County, North Carolina. On March 15, 1815, Reuben Walrond and Louisa, his wife, deed to Archibald Lipscomb a tract of land on South Hico. Aletter from Rosey Walrond addressed to Mr. Archibald Lipscomb, Person Co., N.C., and dated October 14, 1833 and from Pittsylvania County, Virginia, mentions that she had recently visited her parents, and that her mother had had "another fine daughter". Rosey said she was living with her sister, Martha Hall, who had 4 children - 3 sons and 1 daughter.

- 492 <u>MATILDA LIPSCOMB</u> married Samuel McMurray April 18, 1814, in Person Co., N.C. Samuel McMurray and Matilda, his wife also deed their tract of land that Matilda inherited from her father, to Archibald Lipscomb on March 15, 1815. The McMurrays joined the Agees and others to live in Smith Co., Tennessee.
- 493 <u>BINION P. LIPSCOMB</u> was married to Elizabeth (last name unknown). 1850 Census for Smith County, Tennessee gave his age as 51 and that he was born in Virginia. Elizabeth's age is also 51. She was born in Tennessee. The only other name mentioned in the 1850 census was William C. Wakefield who lived with them. Binion and Elizabeth were listed in the 1820 Census for Smith Co., Tn. - no children. The Person Co., N.C. land record book listed that Binion P. Lipscomb of the County of Smith & State of Tennessee deeded property in Person Co. to George Lea, on September 11, 1820.
- 494 <u>EMMA LIPSCOMB</u> married Hiram B. Dolehide. In a letter to Archibald Lipscomb from Hiram Dolehide, he said that Emma had had a fine daughter since she had last visited at Archibald's home. The letter was dated August 18, 1836, and was

from Prattsburg, Orange County, North Carolina. Hiram Dollehide was also an attorney in settling the estate of Richard G. Lipscomb in Halifax County, Virginia.

495 <u>GEOFFRY LIPSCOMB</u> - was young when he died in 1817. His guardian had been Duncan Rose of Person Co., North Carolina.

After Dorothy Palmer Lipscomb's first husband, Thomas Lipscomb, died July 22, 1807, Dorothy married his brother, Archibald Lipscomb, January 11, 1808, in Person County, North Carolina.

Before continuing on with the Lipscombs, just a few notes on the Palmers. The Palmers of the Eastern Shore, Maryland and North Carolina, and the Halifax Virginia Palmers can all be traced back to Edward Palmer, who on July 3, 1622, received a patent of land from the Virginia Company.

Dorothy Palmer was the daughter of Nicholas Palmer who was deceased at the time of the marriage of his daughter to Thomas Lipscomb in King William County, Virginia. James Palmer was one of the Bondsmen for this marriage. In 1797 Edward Palmer, of Halifax county, Va., sold to James Palmer 385 acres of land on the southside of Hico River and in the same area that the Lipscombs held their land holdings. 496 ARCHIBALD LIPSCOMB OF PERSON COUNTY, NORTH CAROLINA by Ruth Phillip, 605 Benton, Missoula, Mt., 59801

Archibald Lipscomb rendered service during the Revolutionary War. His Application for Pension reads as follows:

"Declaration of Archibald Lipscomb in order to obtain the benefit of the Act of Congress State of North Carolina, Person County, to wit: On this 17th day of September 1832, appeared in open court before the Court of Pleas & Quarter Sessions in and for the County aforesaid, the same being a court of record, Archibald Lipscomb, a resident of the said County of Person & state of North Carolina, aged about 74 years, who being first duly sworn according to Laws, doth on his oath make the following declaration, in order to obtain the benefit of the aforesaid Act of Congress - that he enlisted in the Continental line of the army of the United States as a common soldier, he thinks in the winter of 1779-80 at the King William Court House in the State of Virginia for a term of 18 months that he served in the company commanded by Capt. Martin Heely, Lieut. Vaughan, & the names of the other company officers not recollected, in the regiment commanded by Col. Porterfield - that he marched from King William Court House to Williamsburg where the company joined the regiment, thence to the southward through the county of Caswell, the towns of Hillsborough, Salisbury, & Charlotte in North Carolina to the pine tree in South Carolina, was at the battle of Gates defeat on the 16th of August, 1780. Being ordered to rendevous at Hillsborough, North Carolina, after the rout & dispersion of the defeat, this declarant came on there as well as he could. This declarant was ordered from Hillsborough under a Lieut. with 15 men to carry some British prisoners to Richmond, Virginia, after arriving at Richmond the Governor ordered the prisoners to be carried into the interial at Winchester, Virginia. Having left the prisoners at Winchester, this declarant returned to Richmond & was placed under the command of Col. Dabney, the names of the other officers not recollected, and although his term of enlistment (18 months) was now expired, this declarant remained in Richmond as that city & vicinity were greatly alarmed at the savages of the countey below committed by General Arnold with part of the British forces. This declarant continued in service near two months after his term was out and received a discharge from Col. Dabney which he has long since lost. He hereby relinguishes every claim to a pension except the present & declares that his name is not on the pension roll of the agency of any state - that he was born in King William County, Virginia, & lived there until the years 1800 or 1801 when he removed to Person County, North Carolina & hath resided here ever since." Signed Arch Lipscomb. Sworn & subscribed in open court. And the said court do hereby certify their opinion that the said Archibald Lipscomb was a revolutionary soldier & served as he states. Signed Thomas Halliburton and Isaac Satterfield.

Records in Washington D.C. for the Daughters of the American Revolution show Archibald Lipscomb's birthyear as 1763 while this Pension Declaration shows he was 74 in 1832, making his birthyear as 1758 - a 5 year difference. This makes him of legal age when he enlisted.

Archibald Lipscomb was married by 1782 as his first child was born around then. His first marriage must have been soon after his discharge. It is not known for certain the name of Archibald's first wife, nor do we know how many times that he was married. We do know that he had a wife whose first name was Mary. In the land records of King William County, Virginia, the papers show "Archibald Lipscomb and Mary, his wife," sold land in 1798. Sometime between 1798 and January of 1808 Mary must have died. Archibald married Dorothy (Palmer) Lipscomb, the widow of his deceased brother, Thomas Lipscomb. Archibald and Dorothy were married in Person Co., North Carolina on January 11, 1808.

No Lipscombs were listed as living in either Person or Caswell Counties, N.C. in the 1790 or 1800 Censuses.

The 1810 Census for Person Co., N.C., has these Lipscomb households:

- Thomas Lipscomb age 16-26, 1 female under 10, and 1 female 16-26.
- Arch Lipscomb age over 45, 2 males under 10, 1 male 16-26, 2 females under 10, and 1 female 26-45.
- William Lipscomb age 16-26, 1 female under 10, and 2 females 16-26.

In Caswell County there is only one Lipscomb household list-

ed, that of Pheby Lipscomb. Caswell marriage records show that John Lipscomb married Phebe Richmond December 14, 1808. Something must have happened to John since Phebe is the Household head by 1810. (See p. 101)

The 1820 Census has these Lipscomb households in Person Co.: Henry Lipscomb age 26-45, 2 males under 10, 2 females under 10, 1 female 16-26, and 1 female 26-45.

William Lipscomb age 26-45, 2 males under 10, 2 females under 10, 1 female 10-16, and 1 female 26-45.

Mrs. Ann Lipscomb 26-45, 1 male under 10, and 2 females under 10.

Archibald Lipscomb age over 45, 1 male under 10, 1 male 16-18, 1 male 18-26, 1 female under 10, 1 female 10-16, and 1 female 26-45.

The 1820 Census for Caswell County lists only one Lipscomb: Thomas Lipscomb age 26-45, 2 males under 10, 2 females under 10, 1 female 10-16, and 1 female 26-45. Also 2 slaves.

The 1830 Census has both Archibald Lipscomb Sr. and Archibald Lipscomb Jr. as living in Person Co., while Thomas Lipscomb & Henry Lipscomb are living in Caswell. No other Lipscombs.

The first notation in the General Index to Real Estate Conveyances in Person County is where Archibald Lipscomb received a Deed (Bk.C p.436) for 149 Acres from William Sargent. In 1806 Archibald Lipscomb received a Deed (Bk.D p.34) from Thomas Carver. It is thought that Archibald Lipscomb borrowed money from his brother, Thomas Lipscomb, to be paid back on demand. Thomas Lipscomb died July 22, 1807. The 230 Acres that Archibald Lipscomb received from Thomas Carver were deeded to the heirs of Thomas Lipscomb, namely Benion, Elouisa, Emma, Matilda, and Geoffry. This same 230 acres on the South Hico is deeded back to Archibald Lipscomb in 1815 (Bk.D p.423).

Deed Book D page 151. "Know all men by these presents that I, Archibald Lipscomb of the County of Person & State of North Carolina do give & Bequeath unto Thomas Lipscomb of the County & State aforesaid one negro girl by the name of Betty & her increase to the s. Thomas Lipscomb & his Heirs. In Witness whereof I have hereunto set my Hand & Seal this 8th September 1808." signed Arch Lipscomb. State of North Carolina Person County May Term 1809 - The Execution of this gift was duly proved in open Court by the Oath of Henry Sergent Esqr. Witness & ordered to be registered. Then on the following page of 152: "Know all men by these presents that I Daniel Sergent of the County of Person & State of North Carolina do Give & Bequeath unto my Daughter Polly Lipscomb of the County & State aforesaid one negro girl by the name of Phillis & her Increase to the s. Polly Lipscomb & her Heirs forever In Witness whereof I have hereunto set my Hand & Seal this 8th September 1808." signed Daniel and also witnessed by Henry Sergent. Archibald Lipscomb also gave his daughter, Elizabeth Frazer, a negro woman. This was the 20th day of September 1808 shortly after he had given his son the negro gift. (Bk. D p.139).

In 1809 William Lipscomb is deeded 101 Acres of Land from Lloyd VanHook (Bk.D p.176) Also in 1809 William Lipscomb is deeded 44 Acres of Land from James McMurray (Bk.D p.186)

There are later Real Estate Conveyances as children move around which will be noted later.

We have in possession of descendants of Archibald Lipscomb these two early receipts:

Feb. 13, 1815 - Received of Archer Lipscomb, guardian for Emmy Lipscomb, the sum of twenty five cents for the crying(unreadable) two negroes.

Nov. 18, 1815 - Received of W. Arch Lipscomb his proportion of my fee in the petitions himself & others for the division of the lands of Thomas Lipscomb. signed E. D. Janey

In all the signatures that Archibald used on his early documents, he only signed "Arch". Other people refered to him as "Archibald". This has led to considerable confusion. With the above receipts and other records, the true name for Archibald is William Arch (-er or -ibald) Lipscomb. His son, William Arch (er or ibald) Lipscomb Jr., being in the same area, also lends to the confusion for the early records. The son's name was William Archer, but he is also called Archibald Jr. A letter written by Yancey Lipscomb to his uncle George Lipscomb inquires about his uncles, Thomas and Archer. This George Lipscomb was the son of Archibald Lipscomb and Yancey would be the grandson of Archibald Sr.

The Will of Archibald Lipscomb names his children. It reads:

193 (page number in Person Co., N.C. Will Book)

June Term 1837

In the name of God Amen. I Archibald Lipscomb of the County of Person and State of North Carolina being of sound and perfect mind (blessed by God) do this 4 day of Feb. in the year of our Lord 1837 make and publish this my last will and testament, in manner following viz,

Item 1st - My will and desire is that after my death that all my perishable property not disposed of in this my last Will and Testament be sold.... just debts be paid.

Item 2nd - I loan unto my beloved wife Dorothy Lipscomb one negro man named James and one negro Girl named Matty during her natural life. I also will....one feather bed....

Item 3rd - Having advanced to my daughter Elizabeth Frazer what I conceive to be her equal portion of my estate, I will her no more.

Item 4th - Having advanced to my son Thomas Lipscomb what I conceive to be an equal portion of my estate I will him no more.

Item 5th - Having advanced to my son Henry Lipscomb in his lifetime what I conceive to be an equal portion of my estate I will nothing to his Heirs.

Item 6th - Having advanced to my son Archibald Lipscomb what I conceive to be an equal portion of my estate, I will no more.

Item 7th - Having advanced to my daughter Mary Faquir what I conceive to be an equal portion of my estate, I will her no more.

Item <u>7th</u> - To my son George Lipscomb and my daughter Eveline Lipscomb the following slaves with their increase to wit, Delpha, Franky, Carter Dick, Will, Little Jim, Sally and Esther, to be equally divided between them, also one feather bed, bedstead and furniture each.

Item 8th - I further will that if either of my last named children George or Eveline should die leaving no bodily heirs then and in that case the survivor shall inherit the others part - And in case both should die without bodily issue, the said negroes to descend to their lawful Heirs.

Item 9th - I further will to my beloved wife Dorothy Lipscomb my land and Plantation whereon I now live during her natural life with the previlege of selling the same if she should wish to move, two thirds of the sale money to go to my son George and my daughter Eveline

Item 10th - I further will that after the death of my wife Dorothy, the slaves James & Matty and increase with the land and Plantation be equally divided between my son George and my daughter Eveline

Item 11th - I further will that the residue of the

monies from the sale of my Perishable property after all just debts are paid be equally divided between my wife Dorothy Lipscomb George and Eveline

And I hereby make and ordain my Friend John Bradsher and my son George Executors of this my last will and testament - In witness whereof my hand and seal

signed Archibald Lipscomb

witnessed by Kindle Vanhook and John Tally (Jurate).





HARDEN LIPSCOMB (Not identified) 504

HARDEN LIPSCOMB, a Lipscomb, as yet unidentified, was born surely 504 ca. 1760 in King William County, Va., but very few records have been found for him. The name "Harden" may have come from connection with the fairly large Harden-Harding family of Virginia, - but not exactly close to King William Co.

He was a soldier in the Revolutionary War, but there are only a few records on his service. John H. Gwathmey's "Historical Register of Virginians in the Revolution, 1938 (pp.477-8) shows that he had been in the Infantry, and that he had not applied or received Bounty Land. Vol 1, VA, Brumbaugh's"Revolutionary War Record" does list him as Harding Lipscomb, and indicates that he did not receive Bounty Lands.

Eckenrode's 1912 "List of Revolutionary Soldiers of Virginia" (pp271-2) lists Harding Lipscomb "ar 4,251" which is an Auditors account of payroll; and Harden Lipscomb as having enlisted at Chesterfield "C.S.11". This has been copied from the Chesterfield Rolls(at VSA) (where young men from different parts of Virginia seem to have enlisted, for some reason), so, at least we might be able to recognize him! -- Chesterfield Enlistments, "since 1780"

"Harden Lipscomb, ac. 20, 5'10", Joiner, born Va., King William County. resides, King Milliam County; Hair black; eyes blue: Complexion - fair. Enlisted 8 Sept. for term of 1 year and six months."

A Henry Lipscomb, also aged 20, and from King William Co., planter, is also listed on that same page, six lines down, in an alphabetized list. Had they gone together, 3 counties to the Southwest, to enlist, 40-orso miles?

Aside from these military records, nothing else has been found to record his activity, except his faithful annual payment of Personal Property tax, beginning]79] through at least 1811 (the last year checked for this tax).

He apparently did not own] and, at least as late as 1829 (last year checked) and he has not appeared on any census record, 1820 through 1850. So, he may have lived with other members of the family, - or, on rented land. We do not know whether or not be married. His death would be sometime after 1811. He may have died before making any application for Pension or Bounty Land.

505 AMBROSE P. LIPSCOMB (As yet unidentified)

505 <u>AMBROSE P. LIPSCOMB</u>, for some reason is difficult to identify. He apparently married Catherine Lipscomb, daughter of James Lipscomb (C), ca. 1800. See her story, p. 39, for greater details.

The fact that the 1813 deed of the mill site shows his wife's name as Christian is impossible to explain- except that perhaps the names Catherine and Christian (and Kitty") were maybe interchangeable. Surely he had not married a second time. Catherine Lipscomb was born, by estimation, ca. 1780, and Ambrose P. Lipscomb possibly ca. 1775.

He started paying Personal Property tax in 1798, then, his land tax began in 1807, for the 67¹/₂ acres he received (in right of his wife, from her father, James Lipscomb (C)). He increased these lands to 188 acres. 9/0. in 1811, then to 371. 9/0, in 1812, 1¹/₂ miles S.E., and, by 1817, he had died and the land was listed in Catherine's name, "this from A.P. Lipscomb, dec'd by will". And, after her death, apparently ca. 1819, the land had been divided among their three children.

Their children's names, given, p. 41 - Jobe, Ambrose P. Jr., and James T.

505-A JOBE LIPSCOME, b. 1794-1804 (was 16-26, 1820 Census); married ca. 1821, Eliza who inherited his land acreage in 1825 from his estate which amounted to the 95 1/4 acres in 1822 from his brother's (Ambrose P. Jr.) estate after his death. This was taxed in her name through 1829 (last date checked) - no further record of Eliza (_____) Lipscomb has been found on Census records, and it is not known whether or not they had children. The 1820 Census showed Jobe, 16-26, with no family.

B AMBROSE P. LIPSCOMB, Jr. b. ca. 1805-6 (?) left such a brief record, -- He inherited 1524 acres from Catherine and Ambrose P. Lipscomb's estates, taxed in 1820 to him, then the next year, 1821, part of it had been taken over by Thos. and Wm. Hill (adjoining neighbors), and the balance - 954 acres went to Jobe (above). Nothing else! He had died?

C JAMES T. LIPSCOMB, named for Catherine's father, b. ca. 1805-10 (?) Inherited 1524 acres from his father's and mother's estates on which he paid taxes through at least 1829. No further records- not even Census, as far as has been researched.

It would be interesting if further records can be found relating to the parentage of Ambrose P. Lipscomb (Sr.). Is there a chance that he could be the son of Philip Lipscomb (P. 56), or perhaps son of Ambrose (Lott)(p. 447)

506 JAMES P. LIPSCOMB (Pot Pye) (unidentified)

506 JAMES P. LIPSCOMB, so far unidentified, was born-by guess, ca. 1779. The few records about him reveal nothing as to his parentage, the surname of his wife, or any descendants.

The only clue as to the identity of his wife is that in 1803, his land tax started with 16¹/₂ acres, 9/2, on which he paid tax through 1814. Then, in 1815, his widow, paid the tax on the 16¹/₂ acres, "Near Court House, 2 miles N.E." in her name, Mary Lipscomb, and on through 1829, "adjoining Doct" Smith", fee, and marked, in 1815, "this taken from Jas. Lipscomb P. dec'd it being land he got by her by marriage." So, they had probably married ca. 1803.

Oddly enough, in 1800 Land Tax, James Lipscomb (C)'s tax was reduced by $16\frac{1}{2}$ acres (from 418 to 401⁴) but it was valued at 8/7 per acre. and later records show that James' land was all on the South side of the main road, so, unless this happened to have been a separate parcel, this would probably have had nothing to do with the transfer of land, which might have indicated that Mary was another daughter of his. (See p. 34)

The 1807, both Land and Personal Property Tax lists, include, in parentheses, spelled-out "Pot Pye" after his name. Was this a nick-name, - or perhaps an amusing real name for which the "P." stood? There had been an Edward Pye Chamberlayne in that family, but, so far, there is no clue for connection.

James P. Lipscomb and his wife, Mary had been married only a few years, probably, before his death, and it is not known whether or not they had children. Her tax listings continued on, but changed, in 1820, to "Mara" instead of Mary.

Census records do not help particularly, unless the 1850 entry, King William Co., p 239. might be the one -- for Mary Lipscomb, ac. 60 (b.1790) no family, but land value \$300, adjoining (?) families, Tompkins and King.

507 JAMES W. LIPSCOMB (Yes, another James, and unidentified!)

507 JAMES W. LIPSCOMB, another James, and another problem to find him some parents! He paid Personal property tax, first, in 1805. as "1 over 16 yrs.", so, perhaps he was born ca. 1789. His 1830 Census record bears out this possibility when it gives his age as 40-50.

In 1811, he started paying Land Tax on 290 acres, 9/0, and "puzzlingly" is listed directly after Thos. A. Lipscomb who, that same year, acquired 290 acres (added to the 56 acres he had already - from his first wife). Later records, showing locations, place these acreages 5 miles S.E., and varying times, adjoining each other, and Roger Slaughter, Henry Davis, etc. This area must have been south of the Cohoke, and in the vicinity of the present road to Lanesville (Road 633) north of Rd.626, where Cobbett's Mill was.

It seems difficult to find out how these two men acquired an equal amount of land, at the same time, 580 acres in all, but further research might account for it. Find a 580 acre parcel on 1810 list, - not listed in 1811!

Had they both been married at that time? By 27 Mar.1813, a perplexing deed was executed, (K.Wm. B.6 p.272) in which Ambrose P. Lipscomb, and Christiana his wife, Thomas A. Lipscomb and Levina, his wife, James W. Lipscomb and Elizabeth, his wife, and Henry Lipscomb all of King William Co. sold, for 3800., to George Slaughter, the Mill (formerly called Cobbetts Mill, now called Fox's mill), 25 acres on Cohoke Swamp, and adjoining Henry Cobbett's land, witnessed by J. Lord, Nathan Fox, Binion Slaughter and Christopher Johnson. (See p 40).

Was that 25 acre tract owned jointly? Had it been inherited from a common parent? What was the relationship between all these Lipscombs? It has been studied from many angles, and no solution has been found. At least, it was in the vicinity of these two 290-acre tracts owned by James W. Lipscomb and Thos. A. Lipscomb, -- tho' the sale seemingly made no difference in the amount of acreage for any of them. (In fact, Henry Lipscomb - whoever he washad no Land Tax listing.)

Whatever the answer, though, we have found that James W. Lipscomb had married Elizabeth . Had the 290 acres been land from her father?

His 1820 Census shows as just James Lipscomb, p. 299 --

James Linscomb: males 1 10-16; 1 26-45 (a son b. before 1810) females 2 under 10; 1 26-45 4 slaves.

1830 Census. King William Co., p. 72, line 20, seems to show that his wife had died, --

James W. Lipscomb: males 1 20-30; 1 40-50 11 slaves females 1 under 5; 2 5-10

No later Census records have been found, and no identification for the names of their children. Tracing land tax records after 1829 would, no doubt, be very helpful, - on the 290 acres, and its disposition.

Back, on 17 June, 1805. (K.Wm.B.4 p. 333-4), when James W. Lipscomb was cuite a young man. he was a witness, along with Thos. A. Lipscomb, and Wm. B. Lipscomb, to the deed from Mary Lipscomb, widow of Philip Lipscomb (I) to her grandchildren, James and Elizabeth Fisher. Could there be a clue there?

508 PAUL LIPSCOMB (not identified, as yet)

508 PAUL LIPSCOME, also, needs names for his parents. He first paid Personal Property tax in 1805, for"l over 16"- which would indicate his birth by 1789, or earlier.

His Land Tax began in 1811, on 13 3/5 acres, 9/0, indicated, in 1813, as 13 2/3 acres, Ridgeland, and 1814 as life tenancy (not fee) 5 miles S.W, and 1817, as "'Est.' (Relict)," and a bit later adjacent to Mm. Langbourn and John Huckstrep. Then, by 1824, it was listed in the name of Kitty Lipscomb, and "this from Paul Lipscomb est.", - on through at least 1829.

Thus we have the name of his wife, probably, - Kitty ____. And, she may have been the Catherine Lipscomb on the 1830 Census, King William Co., p.70--#5-

Catherine Lipscomb: males none l slave females 1 30-40; 1 40-50 (she, born 1780-90)

And, perhaps the "Catha" Lipscomb on 1840 Census, p. 77, line 24, --

Catha Lipscomb: males none l slave females 2 5-10; 1 40-50; 1 50-60

Had the daughter "30-40" in 1830 (b. 1790-1800) been born ca. 1809, and, between 1830 and 1840, been married and widowed, with 2 little girls?

And, had Catherine (Kitty) been born ca. 1788 or so?

Apparently there were no male children to carry on the name, unless he, (or, they) had married before 1830, having been born ca. 1805, --?

 509 JOHN B. LIPSCOMB (Unidentified)

509 JOHN B. LIPSCOMB, also unidentified, was born ca. 1790-- if our calculations are correct, from Census records.

Census records are all that we have to work with, since he apparently had no land for Land taxes, up to 1829, and only a very few Personal Property tax records for an unidentified John Lipscomb, "Jr." up to 1811, which do not fit, of course.

Could this John B. Lipscomb possibly be the son, John. born. (according to family records) 27 Sept.1793, child of Reuben and Ann Lipscomb (p. 70) whom we haven't traced further down? He could have been designated with the "B" because his mother married (2), by 1804, John Brett in whose home John was, no doubt, raised. 1860 Census does not seem to help with identification.

The neighbors, in 1850 could easily indicate the area of the]and Reuben Lipscomb had inherited from his father, John Lipscomb, who died 1776.

510 Another JOHN LIPSCOMB (Unidentified) (Wife, Judith)

JOHN LIPSCOMB who died in Marshall Co., Tenn. - his will 31 Dec. 510 1839, prob. 3 Feb. 1840, has been hard to identify. He could very possibly be the John, son of Francis Lipscomb, of Louisa Co. (p. 465), also unidentified, since that John Lipscomb disappeared from records in the early 1800s (See his portion (p. 467), but was born at around the proper time, ca. 1770-1780. And, he had not married by 1802, time of his father's will.

The 1830 Maury Co., TN (from which Marshall Co. was taken, 1836) Census, - p. 346, line 17, shows, --

John Lipscomb: males 1 5-10; 1 10-15; 1 50-60 (b. 1770-1780) females 1 10-15; 1 15-20; 3 20-30; 1 40-50

John died before the 1840 Census, Marshall Co., TN, p. 209, showing his widdow, Judith Lipscomb: males: 1 15-20 females: 1 15-20; 1 30-40; 1 50-60
